Wynona was the unintended whippet. I had recently lost my greyhound and Jack McManus had a litter of whippets at a Labor Day trial. Little did I know how my life would change when my husband and daughter encouraged me to bring this puppy home. After an unbelievable first coursing practice run at 9 months, I was instructed by Camille Mendicino to "put her away". Wynonna was a small bitch, but very agile and fast. At the DASH trial on July 4, 1997 the little firecracker exploded on the scene, going BoB in her first trial. While small in stature, she was large in enthusiasm and voice, never voluntarily leaving a lure. Wynona ran competitively until she was twelve years old. Along the way she completed her ASFA LCM 4, ASFA Veteran-LCM, AKC Field Champion, and AKC Master Courser. Wynonna continues to contribute to lure coursing through her progeny. Her 5 running children and 10 grandchildren have compiled a combined total of 100 coursing titles (15 ASFA FChs, 46 LCMs, 3 V-FCh and 6 V-LCMs, 12 AKC FCs, 13 AKC SCs, 4 AKC MCs and 1 AKC LCX). For the years 2006 through 2014, with a total of 7,079 competing, her offspring garnered 24 of the 180 possible Top 20 placements (13.3%). This includes two #1 placements (2008 and 2014), six #2 placements and four #3 placements. To the chagrin of many huntmasters and lure operators, Wynona's crocodile passion for plastic has also been passed along to her offspring.

Come watch sighthounds race in the Trapp Family Meadow Memorial Day weekend, May

23-25. Hounds run in groups of two or three, instinctively chasing lures made of white plastic strips

tied to strings run on pulleys in a 600 to 1000 yard zig-zag course. Judges score them on speed, en-

thusiasm, follow, agility, and en-durance. Lure coursing is a fami-ly sport and the hounds are pets.

Some of the breeds you're likely to see are Afghan Hounds, Borzois, Irish Wolfhounds, Salukis, Scottish Deerhounds, Greyhounds, and Whippets. Hounds will be running mid-morning through mid-afternoon.
