They lived in New Jersey and traveled quite a bit to attend trials. "Shariff" Their Afghan Hound finished his ASFA Field Champion Title on 11/4/76 becoming the first in a long line of ASFA titles for "Campe Sighthounds".

If you have been around for a while you will remember Mera and Seeker Pharaoh Hounds bred by Marilyn Smith.

Their next two sighthounds were Whippets "Pippa" or "P A" standing for "Piss Ant" because of her small size. Followed by "Putt Putt".

Pete and Camille help start several clubs: Tortoise and Hare Lure Coursers which they are Honorary Lifetime members of. Coastal Coursers which they started in New Jersey while still living there. Once they moved to Westminster MD. Coastal Coursers moved along with them. They worked with all of these clubs as Field Trial Chair and Secretary. They are also Honorary Lifetime members of Mason Dixon Ibizan Hound Club and Upper Chesapeake Bay Saluki Club..

Pete is an excellent lure operator and Camille has judged all over our country.

Camille was the ASFA scheduling chair from 1982 thru 1983. She became the ASFA records Co-coordinator in 1990 and held that position until being replaced by Lori Coulson in 1999.

Pete was the Region 8 Regional Director from 1989 thru 1993.

The two of them together have served ASFA and Sighthounds for over half of their adult life. It is impossible to think of one without remembering the other of this pair.
