She even caught a real rabbit in Open Field coursing the month prior to her death. Bayreen was on maternity leave from January 30, 1991 till her next trial on June 22, 1991. She was the first Irish Wolfhound on the West Coast to achieve her LCM II. During her coursing career, she was consistently in the ASFA Top Ten. Everyone on the coursing field knew Bayreen – she barked the entire time, waiting her turn to course, as well as coursing on the field. In her short coursing career or 3.5 years, she accomplished everything Terry and I dreamed of. Not only did Bayreen make many coursing friends, so did we.
