Judge's Sheets

With the addition of the Silken Windhounds in the Provisional Stake changes have been made to the top of the judge's sheets. If your club is using up old judges sheets, please add "SW" at the top where the breeds are listed for the stakes in which the Silkens are running. Also the words Provisional will be

added in the "Stake/Class" section to indicate when a breed is running in the Provisional Stake. This will necessitate the FTS to circle both Provisional and "open", "FCh" or "Veteran" when the sheet is for a provisional breed. The judge's sheet on the web site will be updated shortly.

Policies Approved

The following are policies that the Board has recently approved:

- To make policies on the Web Site official and fall in line with the official version of the rule book being on the ASFA web site, Operational Policy RUL03 will now read:
 - "The 'official' version of the ASFA Policies shall be the version on the ASFA website. That 'official' version shall be 'watermarked' with the ASFA logo and the word 'official'."
- ♦ To clarify which stakes a Provisional Judge can judge Operational Policy JUDG20 was modified to include the word "only".
 - "Provisional Judges are considered regularly licensed **only** to judge Limited Stake and Single Stake. This includes at Regional Invitationals."
- Changes to the entry form. With the addition of the registry for the Silken Windhounds, the Registration Number section on the entry form is becoming

crowded. Therefore the existing text in the Registration Number section on the Official ASFA Entry Form will be replaced with "Registration Number (Write in name of Registering body and Number". This change will allow us to collect the necessary information while providing the flexibility to allow new registries and breeds in the future without requiring a change in the entry form. For example when entering a dog that is registered with the AKC, you would write: AKC HP 123456-01.

As a follow up to the TRIALS48 policy passed at the ACoD in March the Board approved the following policy (TRIALS49) regarding Provisional Breeds and the Singles Stake:

"For those breeds afforded Provisional Recognition under Article X of the Constitution, the provisional classes referred to in Section 5 in which the provisional breed may compete at an ASFA Trial include the Singles Stake."

Customized Entry Form Offer

Here's a time saver! For a limited time, you can request a handy customized entry form with your hound's information already entered. That way when you want to enter an event, all you have to do is bring up the form and supply the event information and stakes you want to enter and then save it to a different file name. Then print it, sign it, and send it (with your check of course).

To request your customized versions of the new forms, send an email to Marilyn Standerford (forms@asfa.org) with the following information about your hound:

- Breed
- Call Name

- Registered Name and Titles
- Registration Number and Registering Body
- Date of Birth
- Sex
- Name of the Actual Owners
- Street Address, City, State, ZIP, and Phone
- Email Address
- (Optional) Region of Residence

Submit your request in early, as the offer is good only through August 15, 2012!
