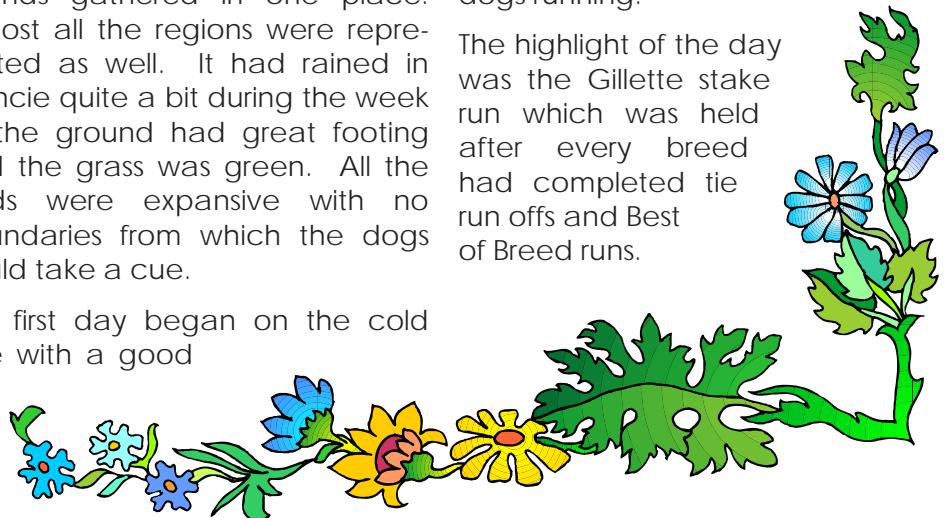
## 2013 II – April 13th & 14th, Muncie, Indiana

The 2013 ASFA II is now history. By all accounts it was an amazing II. Fourteen breeds which included the Provisional breed, Silken Windhounds, competed. It was beautiful to see so many great running hounds gathered in one place. Almost all the regions were represented as well. It had rained in Muncie quite a bit during the week so the ground had great footing and the grass was green. All the fields were expansive with no boundaries from which the dogs could take a cue.

The first day began on the cold side with a good

breeze. Many had on long under-wear and winter jackets. It was cloudy for most of the day but by afternoon the sun was peeking through and the air was getting warmer. There were about 250 dogs running.

The highlight of the day was the Gillette stake run which was held after every breed had completed tie run offs and Best of Breed runs.





## 2013 II – April 13th & 14th, Muncie, Indiana

To be eligible to run in the Gillette stake a hound must be both a bench champion and a field champion as well as having earned at least 20 ASFA points in the previous 12 months. The hound also has to be entered and run in the II on Saturday.

If more than one hound within a breed is entered in the Gillette Stake the hound with the highest cumulative score for the day represents its breed in the Gillette Stake run. This year nine breeds ran for the Gillette stake – the Basenji “Searsha”, the Borzoi “Lotus”, the Greyhound “Hero”, the Ibizan Hound “Jerri”, the Pharaoh Hound “Kinneson”, the Rhodesian Ridgeback “Venus”, the Saluki “Mercury”, the Scottish Deerhound “Ellie”, and the Whippet “Torrey”. The winner was the Rhodesian Ridgeback “Venus” owned by Kasey and Dale Parks.

Following the Gillette stake we had a delicious dinner under the tent. Everyone was ravenous at that point. As dinner began, Dean Wright held a bidding auction for many choice items. There was also a silent auction going on both days. Thank you to so many for generously donating items for both auctions. As dinner was winding down, awards for Saturday were presented.

Sunday dawned still on the cool side, but that didn't last long. It warmed up quite a bit during the day and those who had brought shorts were able to finally don them. The judges, the course plans, and lure operators remained on the same fields but the hounds shifted. It was another day of beautiful runs.

The culmination of the weekend is the running of the Best in II in which the Best of Breed winners from each day are eligible to compete provided they have been entered and received qualifying scores, running in prelims and finals, both Saturday and Sunday. This year there were six courses – 16 hounds competing. They were: the Afghan

“Dalton”, the Basenji “Echo”, the Greyhound “Blueberry”, the Greyhound “Jane”, the Ibizan “Dory”, the Ibizan “Jerri”, the Italian Greyhound “Luca”, the Italian Greyhound “Matt”, the Pharaoh “Sabah”, the Rhodesian Ridgeback “Calli”, the Rhodesian Ridgeback “PJ”, the Saluki “Haifa”, the Saluki “Lola”, the Scottish Deerhound “TB”, the Whippet “Lucy” and the Whippet “Fuzzy”. Following the six courses the Pharaoh “Sabah” and the Whippet “Lucy” were brought back to run off a tie. The ultimate winner was the Whippet “Lucy”. She was from the last litter that Les Pekarski and Shirri Peak had bred and is now owned by Mary Frances Miller.

“Flying First Class”, was the slogan Les Pekarski had given the II for this year. It seemed fitting that a dog he had bred was Best in II. As the trophy was presented to Lucy and Mary Frances there were not many dry eyes under the tent.

A huge thank you to all of the field committee especially the co-chairs Dawn Ferris and Joe Shoemaker for keeping everything running smoothly. The success of the II would not have been possible without help from so many people from all parts of the country as well as the cooperation of every exhibitor making sure their hounds were at the line in plenty of time.

## ASFA Officers, 2014

Article VI, Section 2 of the ASFA Constitution provides for the appointment in odd-numbered years of a Nominating Committee to draw up a slate of nominees for the officer elections to be held at the Annual Convention of Delegates (ACoD) the following year. The list of nominees will be posted on the ASFA web site at least 150 days prior to the electoral ACoD. During the 45 days following posting of the Nominating Committee slate, each member club can submit additional nominees for officers. Those Nominations must be agreed to in writing by the nominee, carry the written endorsement of the nominating member club, and be submitted in writing to the Corresponding Secretary. The nominee names will then be circulated to all member clubs. Candidates for office can also be nominated from the floor of the ACoD at the time of election. The

nominee must be a convention delegate in attendance at that electoral ACoD. Please note that no one may be nominated for an office who has been elected to that office in each of the preceding two terms; nor may any person be nominated or accept a nomination who has, within the preceding year, accepted a fee, over and above expenses, for handling a hound at a sanctioned lure field trial, or for performing or assisting in the performance of duties of the officials of a sanctioned lure field.

The Nominating Committee consisting of Dean Wright (Chair), Dawn Ferris, and Beth Levine, is now accepting suggestions for nominees for officer positions. Send your suggestions to Dean Wright ([vp1@asfa.org](mailto:vp1@asfa.org)) for consideration and possible inclusion on our slate. Please review the ASFA Constitution, or contact the ASFA Corresponding Secretary or your Regional Director for more information.
