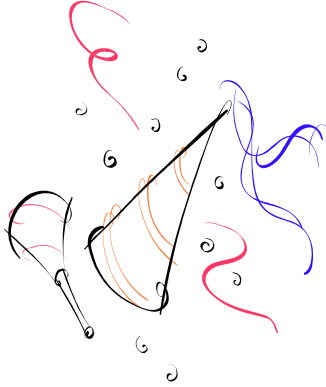
## Scheduling Chair Search

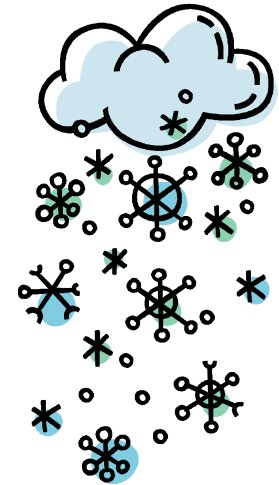


## New Policies

The Board recently approved a new policy to clarify the word "club" in the section of the Constitution that deals with which clubs will vote in special elections to fill vacancies for Regional Directors. New Admin-

istrative Policy A-ELEC04 reads:

*"The word "club" as used in Article V, Section 5, of the Constitution and Bylaws is interpreted to mean a Member Club with voting privileges."*
