

# MESSAGE FROM THE PRESIDENT

Much effort is being put forward for upcoming in-person Annual Convention of Delegates (ACoD). This will be exciting, as we have not had an in-person ACoD in several years. There will be old acquaintances to greet and new friends to make. Please plan on attending as there will be many items on the agenda. We need to continue the constructive discussions on ASFA's future.

The financial results are in from the 2022 II, and it was an incredible success. We generated a profit of over \$5,000 and had a lot of fun. Again, thanks to the Field Committee.

Work is progressing on this year's International Invitational, and we hope to see a detailed proposal and budget shortly.

As everyone is aware, we have an open project for a new Records Program. The initial project plan was well developed and exciting, with a rapid implementation. The reality has now set in, requiring a very large effort to standardize the data set from the past. This is still a high priority, and we will continue to work toward the new program.

We continue to research the decline in entries for ASFA events. A report from the AKC indicates that while their overall entries increased slightly from 2019, AKC Lure Coursing dropped by almost 11%. The single largest increase that the AKC saw was in Fast CAT entries, which doubled. Nothing in these numbers is surprising. We have all seen the popularity of Fast CATs grow, both as money

making events for clubs and as events where participants can be out with their dogs.

As the old saying goes, a duck may look tranquil on the surface, but is paddling like mad below. The ASFA board is working hard on the routine parts of our responsibilities, such as policy and rules development, developing improved processing, meeting schedules, and searching for ways to move ASFA forward responsibly, honoring our traditions and heritage.

My name is Paul Sanders. My wife, Karen, and I are Allagante Silkens. We have been showing, racing, and lure coursing Silkens for going on 21 years. We ran our first straight race in fall of 2002. We live on 21 acres in Damascus, Oregon and host straight racing and lure coursing events for all breeds here at our home many times a year.

Each year, we - as our club SWEPT - also host a three day Regional ISWS (International Silken Windhound Society) Specialty consisting of two conformation shows, straight racing, and lure coursing. Our personal goal is to produce the Silken that can do it all. We have done this many times with dogs that are quad champions ISWS, LGRA, NOTRA, and ASFA. Our Silken, Chyna, won Best in II in 2021.

I have been a lure operator for about 18 years. ISWS had its own racing organizations for straight, oval and lure coursing years before Silkens were accepted by LGRA, NOTRA, and ASFA. During those many years I ran the lure under many lure mentors and many judges and learned the best way to run dogs. Several of them encouraged me to become an ASFA judge. I love the sport, so I recently decided to work towards becoming a judge. I am currently a provisional judge working my way up the ladder, as there are only two ASFA judges besides myself in Oregon.

Going forward we need to get more young people involved in lure coursing; encourage and train more lure operators and judges; and also include and train people in doing all jobs of putting on and holding an event. Some of the hardships that clubs are facing are loss of fields; not enough people to help work; and cost of bringing in judges from other areas due to not enough judges in our region, which can make clubs run fewer events or just give up. A lot of us are getting older, kennels are getting smaller, and so on. Instead of running a team of a half-dozen before, now maybe running one or two. These are some of the challenges I see going forward. I am here to try to make it better for our dogs to enjoy what they love to do.



## Walking Starts & A Lively Lure That Pops Up From A Hole In The Ground –

an exciting change of pace by the Gazehound Association of the Smokey Mountains (GASM)

ASFA allows for clubs to be creative in their trials. As an illustration, on November 12 & 13, 2022 GASM went all in, and ran drag lure, did walking starts, and jumped the lure out of a hole - to the delight of everyone.

On Saturday 48 dogs were entered. Despite the cold damp and snowy weather everyone had a great time with the different format. Of course, the day was capped off with the amazing Southern hospitality at the Kominek residence. On Sunday the entry dropped to 41, but the weather was better.



Images 1-3 (right) show the walking start. In #1 the hounds walk and are looking around. In #2 they see the plastic bag as it emerges from underground. In #3 the lure (tennis ball and fur strips) pops up in front of them.



A walking start is not what we are used to in lure coursing, and it originates from open field coursing where the jackrabbits are hiding and invisible beneath low bushes until the line of dogs and people get too close for comfort and they suddenly start running. For a walking start, the huntmaster commands the owners and dogs to start walking and once everyone is moving the huntmaster signals the lure operator to start the lure. The lure is hidden from the dogs under a sheet of plywood until it starts to move. Once the lure has a bit of a head start the tally ho is given, and the dogs are released. *Note: This could be done using continuous loop, especially if there was a trench under the sheet of plywood and the bunnies stopped under the plywood.*

Walking starts created some trepidation and concern for handlers with larger breeds, but they soon found out that it was easy to do. Having the lure hidden at the start mostly eliminated dogs spinning and bouncing while the owner was trying to hang on and stop them from moving. The dogs were too busy scanning the area looking for the bunnies. I've got to say that the expressions on some of the dogs' faces when the bunnies popped out of the hiding place was very entertaining.

The lures were made of 2 or 3 fur strips about 10 inches long and 2 inches wide fastened to a tennis ball sized toy to create bounce. Eddie Kominek got the fur strips from a mixed box of fur trimmings from Amazon. There are lots of sources of fur strips or whole pelts on the internet.

Using fur as lures was very appealing for some dogs, but others preferred the familiar white plastic bag. They could choose what they wanted to attack at the finish. At the GASM trial the grass was wet (snow covered that melted during the day), so the fur part of the lure got wet, muddy and flat, so it was not as appealing. Based on my past experience, if the fur had not been so wet and muddy, more dogs would have focused on the fur at the end.

I believe that the appeal of running drag for the dogs is the bounce factor. In a continuous loop system, the lures do not bounce much but when using drag, that ball or toy bounces on every bump in the ground or grass clump and the motion of the lure is very different.


Running drag lure has its own set of problems which is a reason why clubs don't use it very often, and I have addressed some of those issues below. But the dogs do enjoy the action of a drag lure.

## Hints for Running a Drag Lure

The difference is that in a drag setup you add a tennis ball or other object that bounces and really winds up the dogs. Obviously, a tennis ball will not fit through a pulley, so the ball and lure are offset from the line on a foot long “leader” that is free to swing away from the pulley as the line zigs through the pulley.

Most field trials are run using continuous loop equipment, a however drag lure system operates by winding the string and lure on the take-up reel during each course. This means that the string must be manually repositioned (re-strung) along the course before the next course can be run. So, you are going to need a method for efficiently re-stringing the course between runs.

ATVs, and bikes are commonly used to make the re-stringing go quickly. But the key is for the person driving the vehicle to travel at a steady and uniform speed. If the vehicle slows down the reel of string continues to spin, which results in piles of string flying off the reel with nowhere to go and this creates a mess of loops. The solution is to have a brake and/or brake person to slow the take-up reel down when the vehicle slows down. GASM used the sole of an old shoe attached to a stick that pivoted to rub on the take-up reel when pressure was applied. The more smoothly and efficiently the equipment team can re-string the course the more entries you can handle in a trial. Note, I said team here, it helps to have extra people available to help with braking and re-stringing the course.



You don't need special pulleys for running drag, but they are available and expensive. I have included a photo.

Conversely, during the course when the string is being wound up, the tension changes because there is less weight of string out on the field as the lure gets closer to the finish line. This can be solved by creating a zig zag of 5 to 10 pulleys just before the machine to create tension. – Cathy Sanderson

# To Excuse, Dismiss, or Disqualify – Trouble and Training

ASFA recognizes three levels of interference between hounds running a course. These are: Innocently following another hound; actively interfering in another hound's pursuit of the lure; and attacking a hound during a course. The following are my personal comments and conclusions about these situations.

## *Part 1 – Trouble*

**To Excuse** – An excusal is the mildest of ASFA consequences for hounds that interact with each other during a course. The hound at fault follows the other hound into every turn, rather than following the lure.

This kind of tag-along following happens often if a new hound is not slipped quickly on the “Tally Ho” and is behind a leading hound. This novice hound never sees the lure and relies on the other hound to lead the chase.

Sometimes, when approaching a corner, the leading hound cuts the corner and overruns the string. When that happens, the lure operator may well be able to let the inexperienced hound see the lure. Hopefully this will get the new hound back on the lure. The judge may or may not stop the course.

An Excused hound may not return to the trial that day.

**To Dismiss** – A Dismissal is the middle-level of consequences for interaction between dogs in a course. In this case, the hound at fault is not only following the other hound but catches the other hound and intentionally interferes with the hound that is following the lure's course. It may be playful or aggressive, but in any case it spoils the other hound's run.

A Dismissed hound will run under the shadow of Dismissal for five additional trials. He or she must run five trials without interfering. A second dismissal within five trials results in an automatic Disqualification. When a hound is working off a Dismissal, this must be indicated on the entry form.

**To Disqualify** – A Disqualification is the most serious of the consequences ASFA assigns to dogs interacting during a course. “A hound shall be Disqualified...for the following reason: fighting – the aggressor in fighting in the field.” The hound at fault aggressively

chases after the hound following the lure and starts fighting. If the hound that was attacked retaliates in self-defense that is not their fault and he or she is not penalized.

A Disqualified hound has lost the privilege to compete. See the ASFA Rule Book, Chapter VIII, Section 7 for reinstatement procedures.

## *Part 2 – Training*

After writing about consequences, I realize I need to write something on training your hound to prepare for their First Field Trial.

One of the worst things that can happen to a sighthound is to be entered in a trial with no previous practice. Every hound needs to run alone when practicing for the first several times. Once a new hound is keenly focused on the lure, we should also practice with a seasoned hound to run with this hound for the first time. When the new hound has passed these markers, he or she can earn the ASFA Certification of Eligibility.

The Hanover clubs, and many other ASFA clubs, hold practice sessions after the completion of the first day of a trial series. Many club members enjoy practice and are ready to help novice hounds and handlers get started.

One useful tip is to practice the start. Arrange with your friends and the practice crew to have a double “Tally Ho.” At the first “Tally Ho” you slip your newbie immediately, the huntmaster cries “Tally Ho” again and the second hound is released. This exercise allows the inexperienced dog to have a clear sight of the lure even when he or she is not alone at the start.

If there is any question about whether the new hound chased the lure or the other hound, keep practicing. The best practices for this issue are not by themselves. Too much running alone sometimes makes the hound possessive of the lure.

The Singles stake is also a useful way to let new dogs become familiar with field trials.

## *Random Thoughts on Training a Puppy to Their First Trial and What Happens at Practices*

1. 6 weeks – Play with lure toy. A fishing pole with garbage bag attached. Let puppies chase as you pull it along the ground. Both in groups and as single puppies one at a time.
2. 3 months – Take your pup to a trial or trials. Let him or her listen to noises and other people as well as the lure machine. Let puppies watch the lure especially as it goes through the machine and back out to start again. It’s pretty exciting!
3. 6 months – Take them to a trial and let him or her run a straightaway, with the crew reversing the wheel and so the pup can chase back to the start.
4. 9 months – Take them to a trial and do a couple of turns, reverse and bring them back to the starting spot.

5. 11 months – Take them to a trial and let run the entire course alone so it does not add the stress of trying to beat another dog.
6. 12 months – Try a run with another hound, preferably an older hound that the pup knows. This experienced hound must be 110% on the lure.

## Bracket Challenge Coursing (BCC) Overview

The Bracket Challenge Coursing (BCC) event is designed to have sighthounds compete against one another in a head-to-head competition.

Each event will assign the entrants to each bracket based on prior BCC points accumulated or random draw when entrants are similarly pointed.

Courses are preferred to be run in braces within a double-elimination format, with winners advancing to run against winners and losers running in a loser's bracket.

Judges need only to pick a winner of each course within a round, so results are instant, and handlers know the outcome before they leave the field.

This format is designed to go quickly, so that Clubs could choose to run a BCC event on the same day after a regular ASFA trial.

All brackets within an event are determined in 3 rounds with no ties and no runoffs.

### Overview:

- There is no separation by breed for this event.
- Prior to the start of competition, hounds are placed in brackets based on the number of points each has accumulated within the prior 12 months. Thus, over time, the hounds with the best records should be competing against one another.
- Hounds then compete within their bracket. The preferred bracket size is 8 hounds, but as few as 4 or as many as 11 hounds may be placed in a bracket depending on the number of hounds entered in the event.
- Each bracket is run in three rounds. All hounds run at least twice (rounds 1 and 2), with some hounds advancing to a third round.
- In most cases, hounds run in braces. When there is an odd number of dogs in a bracket, there will be one trio in each of the first two rounds. For trios, the running rules instruct the judge to pick a single winner or a single loser, depending on the round and the size of the bracket.
- For the first round of each bracket, hounds are seeded within a bracket according to their BCC points accumulated over the preceding 12 months. In round 2, winners from the first round compete against other winners and losers against other losers. All hounds with fewer than 2 losses move on to round 3.
- After three rounds of competition, there is an overall winner (3 wins); and one, two, or three runners up (2 wins and 1 loss) from each bracket who receive points toward a Bracket Challenge Coursing Champion title. The number of runners-up depends on the number of hounds in the bracket.
- The hound with the most wins in each bracket (3 wins) will receive 3 points towards their title and the hounds with two wins will receive 1 point towards their title.
- It will take 10 points for a hound to receive the first level title. It will take an additional 15 points to achieve the next title level.

Example: Assume that we have an 8-hound bracket, comprised of the following:

<b>Call Name</b>	<b>12-month running BCC points</b>	<b>Call Name</b>	<b>12-month running BCC points</b>
<b>Andy</b>	21	Betty	15
<b>Charlie</b>	12	Dolly	12
<b>Eddie</b>	10	Frankie	10
<b>George</b>	10	Hattie	9

For Round 1 (R1), in Course 1 (C1) the highest-seeded hound (Andy) runs against the lowest-seeded (Hattie). In the second course, Betty runs against one of Eddie, Frankie and George (drawn randomly). Charlie is randomly drawn into course 3 and runs against randomly drawn Frankie. In course 4, Dolly runs against Eddie.

#### Round 1:

Course 1: Andy vs Hattie – Andy wins  
Course 2: Betty vs George – George wins (an upset!)  
Course 3: Charlie vs Frankie – Charlie wins  
Course 4: Dolly vs Eddie – Dolly wins

For Round 2 (R2), the 4 winners from R1 will run in the first two courses, and the 4 R1 losers will run in courses 3 and 4. The winner of R1 C1 will run against the winner of R1C4 and the winner of R1C2 will run against the winner of R1C3. The losers follow the same pattern.

#### Round 2:

Course 1: Andy vs Dolly – Andy wins  
Course 2: George vs Charlie – Charlie wins  
Course 3: Hattie vs Eddie – Eddie wins  
Course 4: Betty vs Frankie – Betty wins

After R2, Hattie and Frankie have two losses and are done for the day. R3 will have three courses: The two hounds with no losses (Andy and Charlie) will run against each other and the loser of R2C1 will run against the loser of R2C2 with the remaining two running against each other.

#### Round 3:

Course 1: Andy vs Charlie – Andy wins  
Course 2: Dolly vs Eddie – Dolly wins  
Course 3: George vs Betty – Betty wins

After R3, Andy wins the bracket with 3 wins and gets 3 BCC points.  
Charlie, Dolly and Betty have 2 wins and 1 loss and get 1 BCC point each.  
Eddie, Frankie, George and Hattie don't get any points, and will probably find themselves in a lower bracket (with a better chance at winning) in the next event.



## **EXPERIMENTAL Bracket Challenge Coursing EVENT**

FOR EVALUATING AND AWARDING TITLES TO ALL Purebred  
SIGHTHOUNDS

**Statement of Purpose:** The American Sighthound Field Association (ASFA) Bracket Challenge Coursing (BCC) program will evaluate each purebred sighthound dog's ability and desire to chase or catch the artificial lure. Each hound will be individually competing against another hound in a winner takes all format.

This program is optional for ASFA approved clubs using ASFA approved judges only. The club hosting this event will run this as a separate event after the regular trial and may set entry limits for this event. Clubs may also run this as a separate trial.

**Objective:** A format that pits the best against the best in head-to-head competition regardless of breed. Courses are run primarily in braces in a double-elimination format, with winners advancing to run against winners and losers dropping to a loser's bracket. Judges need only to pick a winner of each course within a round, so results are instant, and handlers know the outcome before they leave the field. This format is designed to go quickly, so that Clubs could choose to run a Bracket Challenge event on the same day as a regular ASFA trial. All events are determined in 3 rounds with no ties and no runoffs.

The standard ASFA running rules will guide these events with the following modifications.

### **Chapter I General Rules**

**Section 1.** *Refer to ASFA running rules Chapter 1 Section 1 for eligible breeds. Breeds with ASFA provisional status and hounds with breed disqualifications may also compete in this event.*

**Section 2.** The owner or agent entering a dog in a BCC event does so at their own risk. The owner or agent and licensed club agree to abide by the rules of the ASFA.

**Section 3.** Entry fees shall be fixed by the host club and shall be forfeited in such cases where dogs are scratched from the event except for one of the following causes.

- A. Dogs determined to be lame at the time of roll call shall be barred from competition and their entry fees shall be refunded.
- B. Bitches in season, or bitches showing a discharge characteristic of being in season, or which come in season after the close of entries, shall be excepted from this rule and their entry fees shall be refunded. Notification to the Field Trial Secretary of bitches in season must be made before or during the roll call. Bitches known to be in season should not be brought onto the trial grounds.
- C. Dogs that have been disqualified *for aggression* by ASFA or another organization. Fees will be refunded only if the owner or agent notifies the Field Trial Secretary of such ineligibility prior to or during roll call.

**Section 4.** To compete dogs must:

- A. Be a minimum of 12 months old
- B. Be physically fit for competition. Blindness, Lameness and Amputation are considered as being unfit.
- C. May be spayed, neutered or intact.
- D. Females must not be in heat/season.

- E. Be free of bandaging or any other attachments for medical purposes.
- F. Not be disqualified *for aggression* in any organization.
- G. *Entrants must be eligible to enter an ASFA or AKC open or Field Champion/Specials stake. First time entrants who have not run in an ASFA trial must provide an ASFA Hound Certification Form or AKC QC form.*

## Chapter II

### OFFICIALS

Officials will be the same as defined in Chapter II of the ASFA Running Rules and Field Procedures for Lure Field Trials.

### JUDGES

Refer to the Glossary for definitions of the program.

In addition to those rules and procedures set forth in ASFA Running Rules, Chapter II, as they relate to judges, the following shall apply:

A club can have more than one judge for an event.

- A. A single judge is used for each course of a round within a bracket. A club can use multiple judges for the event. For this experimental program, the judge may be in provisional status and judge alone.
- B. If there are multiple brackets and more than one judge, the judges should switch brackets for each round unless a judge has a hound in one of the brackets. Judge 1 officiates round 1 of bracket 1, Judge 2 officiates round 1 of bracket 2. Judge 1 then officiates round 2 of bracket 2 and Judge 2 officiates round 2 of bracket 1. Judges are then switched between brackets for round 3.
- C. The judge declares a winner for each course immediately following the course.
- D. For the experimental event the judge may be in provisional status.

A Judge can officiate an event where their hound is entered but cannot officiate the bracket in which their hound is entered. If the judge has multiple entries and would be in different brackets, they can move a dog up a bracket so it will not be in the bracket they are judging but cannot move a dog down a bracket. In this event, the judges will not switch brackets between rounds so that no judge is officiating a bracket with hounds they own.

## Chapter III

### JUDGING

In addition to those rules and procedures set forth in Chapter II, as they relate to judges, the following shall apply:

**Section 1.** A single judge is used for each course of a round within a bracket. If there are multiple brackets and more than one judge, the judges *should* change for each round. The judge declares a winner for each course immediately following the course. for the experimental event the judge may be in provisional status.

**Section 2.** A person shall not single judge an event on two consecutive days within a 150-mile radius, unless given special dispensation by the trial-giving club's Regional Director to prevent a hardship on the host club. In each case where a person is to judge on two consecutive days, the respective Regional Director must write a letter of approval to the Scheduling Committee Chair in advance of, or together with, the sample premium list. There will be no exception without such written dispensation.

**Section 3.** No judge shall handle a dog where they are officiating. No dog may be entered in a bracket where a judge is officiating if the dog is owned or co-owned by that judge, or if the dog is owned or co-owned by a member of that judge's immediate family or residence.

**Section 4.** No judge shall perform any other field trial duties during their judging assignment that are reasonably likely to interfere with their judging performance. In particular, no one may judge and operate the lure at the same time, or judge and serve as huntmaster at the same time.

**Section 5.** Each and every judge, before beginning their assignment, shall walk the course and verify with the Field Trial Chairman that the approved course plan is properly staked.

**Section 6.** While on the field during their judging assignment, no judge shall discuss anything relative to their judging assignment with any handler or agent instigated by such handler or agent.

**Section 7.** A judge shall be able to call a no-course at any time:

- A. The dog is interfered with, disrupted or the judge cannot fairly determine the course.
- B. When a segment of the lure falls off and the dog reacts to said segment, but only if the judge cannot fairly determine the course.
- C. If a dog touches or catches the lure and, in the judge's opinion, by so doing that action causes interference with the running of the course, it shall be declared a no-course. Any time a dog becomes entangled in the string, the judge shall order the lure stopped and may declare a no-course.
- D. If the lure operator fails to maintain the reasonable lead, and the dog becomes unsighted, the judge shall have the prerogative to call a no-course and re-run.
- E. The judge has the option of restarting the course from the beginning or at the point of interruption.

**Section 9.** Judges are responsible for determining the winner for each course. There will be no ties. The first tie breaker is speed, followed by agility. In the case of a trio (see below), the judge will be asked to select either one winner or loser, depending on where in the bracket the trio appears.

**Section 10.** The dogs will be evaluated in the following categories: Enthusiasm, Follow, Speed, Agility and Endurance.

**Section 11.** The judge may consider a course delay or pre-slip in their decision. Their decision is final. Course delay includes a dog being slipped before the tally-ho has been sounded and the handler makes little attempt to quickly retrieve the dog.

## **Section 12. Judging Criteria**

Judges will use the following to guide their evaluation of each category:

**Enthusiasm:** Single-minded interest, showing great eagerness and determination in pursuing the lure after the "tally-ho" and until the lure passes the marked finish for the course. Reward dogs in ability that are showing great focus, drive, and determination to get the lure.

**Follow:** Chasing with the intent of taking the lure while maintaining a path in reasonably close proximity to the lure's course should be rewarded.

Dogs that anticipate which way the lure will go as the lure approaches a sightline, sometimes cutting off much of the course trying to catch the lure, at some point should force a significant scoring penalty.

A dog that becomes unsighted for some good reason, and yet attempts to find the lure again, should not be severely penalized. It may be appropriate to rerun the course. In this context, the height of the terrain with respect to the dog's eye level will be considered. A dog that becomes unsighted in a situation where it should have no trouble following the lure is not demonstrating follow.

**Speed:** Speed is defined as rapidity in moving, the rate of motion or progress; the dog's overall speed and acceleration in chasing the lure. Credit the dog that levels out low, stretches and really drives. A dog that takes more strides per second than its competitor is not necessarily demonstrating speed.

**Agility.** Agility is the ability to move quickly and easily: nimbleness in negotiating terrain (i.e., recovery from difficult terrain that may cause a dog to slip or slide); turning without going wide, cutting or breaking stride.

**Endurance:** Endurance is the lasting quality, stamina of physical and mental concentration. Credit the dog that does not fade, pull up, or slacken. A dog that lacks endurance will usually show degradation in running style as the course progresses. A dog lacking in enthusiasm will most often just quit or go off to explore the field. Lure-wise dogs frequently will slow down on the very last portion of the course knowing that the lure will stop before it reaches the machine and should not be heavily penalized.

**Section 12.** Dogs may be excused from the field by a judge for the following reasons:

- A. Dogs who fail to run after the tally-ho in any course.
- B. Dogs who may be considered unfit to compete.
- C. Dogs whose handlers or owners interfere with the judges or officials.
- D. Dogs who delay the course.
- E. Handlers who willfully interfere with another competitor, their dog, or any official.

**Section 13** In the event that a dog running loose joins a course in progress and interferes with or instigates a fight with the dog properly entered in that course, the judge or judges currently judging the course in progress may excuse or dismiss the offending dog from the field for the day or disqualify the offending dog.

**Section 14.** Dogs shall be disqualified by the judge, for the following reason: fighting - the aggressor in fighting in the field.

**Section 15.** Judges shall immediately inform the huntmaster when a course is called a no-course or when a dog is dismissed or disqualified. The huntmaster will then inform the handler.

**Section 16.** Judges must state on the Field Trial Secretary's document the specific reason for excusal, dismissal, or disqualification.

**Section 17.** After a course has been judged, and the decision rendered, only the judge can change their decision.

**Section 18.** The judge's decisions upon all matters relating to a round are final and binding upon the start of the next round.

## Chapter IV

### RUNNING THE MEET

**Section 1.** Entry limits may be applied. Table 1 will be the guide for setting any limits based on number of brackets for equal size of brackets.

**Section 2.** No dog may be entered more than once at an event.

**Section 3.** The judge must be the same for all courses in a round unless the judge is unable to complete their assignment.

**Section 4.** There will be no separation according to breed. ~~All breeds will be seeded and placed within brackets.~~

**Section 5.** Brackets

The minimum bracket size is 4, and the maximum size is 10. See Table 1 for the number and size of the brackets depending on the number of hounds entered in the event.

*A preferred bracket is comprised of 8 hounds.*

### 8-hounds:

**Round 1:** 4 courses of 2, Course 1 (C1), Course 2 (C2), Course 3 (C3), and Course 4 (C4) (W1 = winner of course 1, L1 = loser of course 1, etc.).

**Round 2:** The course direction is reversed. Hounds are assigned to courses based on Round 1 results as follows:

C1: W1 vs W4,

C2: W2 vs W3,

C3: L1 vs L4,

C4: L2 vs L3

**Round 3:** The judge selects the course direction for round 3. Hounds are assigned to courses based on Round 2 results:

C1: W1 vs W2:

C2: W3 vs L1,

C3: W4 vs L2

Hounds with two losses do not compete in round 3.

### Table 1: How many brackets?

The goal is to have the highest-seeded hounds run in a bracket of 8. Hounds are run in a single bracket until there are at least 11 entries, then the brackets are split into 7 and 4, then 8 and 4 for 12 entries. After that, hounds are added to the lowest-seeded bracket until it reaches 10, then it splits into 7 and 4, then 8 and 4, and so on:

**Section 6.** Seeding within each bracket shall be determined by a rolling 12-month accumulation of BCC points.

- A. The top 8 hounds compete in bracket #1, the next 8 in bracket #2, etc. Dogs with the same number of points are randomly ordered. Seeding means that top hounds will compete against one another, but it also makes it harder for top hounds to accumulate points because they will have to consistently beat other great running hounds.
- B. Within a bracket, if the hounds are ranked Hound 1 (H1) through Hound 8 (H8), for round 1 C1 is H1 vs H8, C2 is H2 vs H7, C2 is H3 vs H6, C4 is H4 vs H5.

**Section 7.** The following description applies to Bracket Challenge Coursing:

- A. Dogs shall run in braces except for times where trio is required due to number of entries as outlined in Section 5.
- B. One hound wins the course. Exception: See Appendix 1 for six and seven dog brackets where two winners are chosen in trios in rounds 1 and 2.

## Chapter V

### PLACEMENTS, AWARDS, and TITLES

**Section 1.** No ASFA points or placements toward the Field Championship or Lure Courser of Merit titles will be earned.

**Section 2. Bracket Challenge points: For 8 hound bracket (see appendix for other numbers)**

- A. After Round 3, one hound has 3 wins, and 3 hounds have two wins and a loss.
- B. The hound with 3 wins is the overall winner and is awarded 3 Bracket Challenge points.
- C. The 3 hounds who are 2-1 are awarded 1 Bracket Challenge point each.

**Section 3. Titles for Bracket Challenge Coursing:**

A permanent title of Bracket Challenge Coursing (BCC) shall be awarded as a suffix to the registered name of any hound which has attained ten (10) challenge points.

A permanent title of Bracket Challenge Coursing 2 (BCC2) shall be awarded as a suffix to the registered name of any hound which has attained twenty-five (25) total challenge points.

A permanent title of Bracket Challenge Coursing X (BCCX) shall be awarded as a suffix to the registered name of any hound which has attained each additional fifteen (15) challenge points.

- A. Individuals wishing to know their hound's point standing should fill out the Request for Current Information form under Hound Records on the ASFA web site, and this information will be sent to them.

- B. Title certificates will be mailed to the owner upon validation that the dog has completed all requirements.

## Chapter VI

### RECORDS & FEES FORWARDED TO ASFA

**Section 1.** All records must be received by the ASFA Records Coordinator within fourteen (14) days or be postmarked within ten (10) days of the approved Bracket Challenge event.

These records must include:

- A. Names of all judges and their city and state of residence and the complete mailing address of the Field Trial Secretary.
- B. First time entries must include a copy of registration certificate and certification form.
- C. Per Capita Fee as set by the ASFA Board.

## Chapter VII

The standard ASFA Running and Field Procedures for Lure Field Trials will govern any item not specifically covered in this set of rules.

### Glossary

**Brace:** Two dogs running in a course

**Bracket:** Group of hounds based on performance in past events

**Course:** Running of two or three dogs in competition

**Round:** Up to three courses to determine top winner in bracket

**Seeding:** Placement of hounds based on performance in past events.

**Trio:** Three dogs running in a course when needed

### Appendix 1 Brackets and Blanket Colors

H# = Seeding order for Round 1 within a bracket. H1 has the most BCC points prior to the trial, H2 the next most points, etc. Hounds with the same number of points are assigned randomly. For example, if three hounds are tied for third in points, they are assigned H3, H4 and H5 randomly.

C# = course number within a round. For example, C1 is the first course, C2 is the second course.

W# = winner of course # in the previous round. For example, in the second round W1 is the hound that won the first course in the first round.

W#a, W#b = winners of a trio in the previous round if scoring requires more than one winner (6 and 7 dog brackets). Hounds declared winners are assigned a or b in order of blanket color, y/p/b. For example, in a 7-dog bracket Round 1 Course 3 is a trio with two winners. If yellow and blue are the winners, the yellow dog becomes W3a for Round 2 and the blue dog becomes W3b for Round 2. (The pink dog is L3)

L# = loser of course # in the previous round. For example, in the second round L3 is the hound that lost the third course in the first round.

L#a, L#b = losers from a trio in the previous round if scoring requires a single winner. Losing hounds are assigned a or b in order of blanket color, y/p/b. For example, in a 9-dog bracket, course 4 in the first round is a trio. If the yellow dog wins the course, pink become L4a for the second round and blue become L4b for the second round.
