







LETTER FROM ASFA PRESIDENT PHIL FULLAM

We are well into The ASFA's 50th year. Leading up to 2022, many of us had hoped that this would be a year of celebrations and reflections on where we have come from and where we are going, but planning took a back seat to COVID.

The planning for this year's International Invitational is well under way. It promises us the opportunity to get together and enjoy our sport with the best of the best, and to renew acquaintances and friendships, and to exchange stories and savor 50 years of lure coursing.

I think back over my 45 years in the sport, of the people, dogs and places that have filled so much of my life. When I started The ASFA was only 5 years old, still coalescing around the basic concepts, but fully recognizable as the organization we have today. The very first trial I went to does not seem that much different that our present-day events, except that I just walked up to the line with a totally green dog, no precertification required, and somehow slipped her (who was then excused for coursing the other hound).

One major change has been the number of different events that are available for the enthusiast. Back then we had only conformation and obedience pulling us away from coursing. Conflicts over dates were much less of a problem, and there seemed to be more options for fields.

Times have changed. With the diversity of events today, it takes a serious spreadsheet to keep track of events and dates. It seems like there is no such thing as an open weekend anymore. Now it is a choice of picking which events we will be in conflict with.

The ASFA's second 50 years is going to be marked by a need to rapidly adapt to new environments, new challenges, and new opportunities. This is an exciting time as we explore new events, improve our operations, seek ways

to make life better and more enjoyable both for those putting on events and for participants. Our long history of putting on quality events, with strong competition and camaraderie will provide the foundation for our future.

NOTICE Corresponding Secretary Vacancy

Mary Frances Miller has resigned as Corresponding Secretary (CS). I want to thank Mary Frances for all the effort she put into the position over the past months. This is a demanding position, and she did a great job during her tenure.

The resignation has created a vacancy. Ping Pirrung has agreed to fill in until the board can elect a replacement. Per the constitution the BOD can elect a replacement for vacant position among the officers, other than the President.

At this time, we are asking anyone who might be interested in the position to contact the Search Committee, Cathy Sanderson, Jennifer Gysler, or Ping Pirrung. Ping has agreed to stay in the CS position for up to six months to train and support the new CS.

Recognizing the need for continuity in the CS position, the BOD is looking to amend the term of the CS to provide a positive overlap. By having the new CS shadow the current CS, there will be time to learn and understand the tasks needed as well as the mechanics of the Board of Directors communications, dealing with requests from the fancy, board motions, and how to report the results. A 3 to 6 month training period should provide a seamless transition for the new office holder.

NOTICE to ASFA JUDGES

and to those wishing to obtain a judges license

from the Chair of Judges Licensing

A new testing requirement was added to the General Requirements for judges at the 2022 Annual Convention of Delegates (ACoD). The new testing requirement is set out below. The effective date is August 1, 2022. Also, the entire Chapter XI LICENSING OF JUDGES has been changed. Anyone interested in obtaining a judges license should review it.

new Chapter XI 2(a) [2022] LICENSING OF JUDGES

Every judge (all-breed, provisional, apprentice) will be required to take a 25-question open book test provided by the Chair of Judges Licensing every four (4) years. This test will cover all running rules and policies in effect on January 1 of that year related to judging. Passing grade will be 85%. If a judge has not passed the test within four years, their license will be suspended. The Scheduling Chair will not approve suspended judges for new assignments until they have passed the test. Currently approved assignments will be completed. Judges will be allowed three attempts to pass.

During the month of August, the first group of judges to be assigned the testing will be notified to look for their tests in their email. Prior to this, each judge should verify that their email address is correct in the judges list published on the website.



There will be a food truck Saturday and Sunday. Saturday night dinner will be catered by "Birds Smokehouse BBQ", which comes highly recommended by the local folks.







Currently the ASFA is in decent shape financially. This is due in part to having a virtual ACOD instead of in person. We have a couple of expenses coming up in the next year all relating to a new records program and web application.

We continue to see fewer entries in a 10-year comparison. I attribute that to a number of factors, including the ongoing opportunities for hound lovers to participate in a variety of events outside of lure coursing, the return to open activities after recent concerns for gatherings, and the loss of event space for holding lure coursing trials.

I would challenge clubs to look at hosting 2 more trials this year. I know time is difficult to find (based upon above observations) but this is one way to promote our sport and allow it to grow.

This is ASFA's 50th anniversary and I would encourage people to plan on participating in the upcoming International Invitational being held in Muncie, Indiana. The premium is being tweaked and should be out soon.

Ribbons for Regional Invitationals

Attention- Regional Directors

When you schedule your Regional Invitational, you must submit a request for ribbons and medallions to me. This includes your best guesstimate of how many ribbons will be needed. I know this is daunting, so contact me and we can work together on that. Please give me as much lead time as you can. Once we have the numbers, it will take me at least two weeks to pack up the ribbons and ship them to you from the post office without incurring extra charges.

Limited Stake Has Been Eliminated

The Limited Stake has been eliminated. Breeds that were previously included in the Limited Stake are now included in the Provisional Stake. The Provisional Stake now consists of the following breeds: Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), and Portuguese Podengo (Medio & Grande).

Ibizan Hound Veteran Age Has Change

The age at which Ibizan Hounds may enter the Veteran Stake has been raised from 6 years to 7 years.

UKC is Now an Approved ASFA Registry

The UKC (United Kennel Club) has been added to the list of approved registries for ASFA eligibility.

Accordingly, hounds that are registered with the UKC are now eligible to enter regular ASFA stakes without having to also get the AKC registration number.

Premium Lists - New Requirement

There was a rule passed that the Field Trial Secretary's e-mail address must be included in the premium. This is so that the Records Coordinator Lori Zorbaugh (f/k/a Lori Coulson) can contact the FTS with questions.

Licensing of Judges – Rules Re-write

Message from the Records Coordinator to FTSs

Lori Zorbaugh

I would like to say a big Thank You to all the FTS who have responded quickly to my email for information.

We have been following the new protocol for trial submissions for over a year and the biggest problem is still missing FTE entries. For the most part it is because the owner did not mark the entry as such and the required copy of the registration and certification (if required) were not included. I will continue to rely on each FTS to question each unfamiliar entry.

Some suggestions:

- When making your roll call sheet if you have any unfamiliar entries, mark the name and have the person(s) doing roll call direct owner to contact the FTS to confirm that the hound is not an FTE.
- If you have an FTE that did not bring all required information, have them, email or fax it directly to me. This will expedite your ability to submit the results instead of waiting for them.
- It is helpful when you list the breed initials by the call names on the Single Record sheet. Then, If one of the entries is missing information, I will have a breed to search by.
- If you plan to submit the results via email, please minimize the number of files you send and try to keep things in the same order that you would always use to submit.
- Please submit results as soon as you can. The quicker I have them, the sooner I can process and post results.
- As always, please contact me should you have any question(s). Email is always the best way to reach me. You can call me if you need an answer quickly, but if you do call, I typically do not pick up if I do not recognize the number so leave a message. I may be listening and may pick up immediately.

Most Frequent Records Errors

- 1. FTE entries not submitted, typically because the owner has not marked as such.
- 2. Incomplete Records sheets. They must have call name & registration number.
- 3. Not marking forfeits, just marking the placement(s).
- 4. Giving hounds placements that have not received a total of 50% of the possible combined score.



During this past ACoD, one of the delegates from a new club inquired about how clubs hire judges and whether to pay or reimburse them. The initial response was a "NO" to paying judges based on the running rules. The Judges Committee would like to answer in more detail at this time.

Reimbursing Judges Expenses

ASFA Policy

First, we need to discuss the ASFA rule for judge reimbursement. Currently Chapter XI, Section 6 of the ASFA Running Rules states that "No person shall accept a fee for judging but may accept reimbursement from the host club to defray expenses." (The word currently is used because effective Aug 1, 2022, Chapter XI will be renumbered).

This rule is interpreted to mean that a club cannot offer a flat fee for a judge to officiate at their event nor should the judge request a flat fee. This means that if the club offered a judge \$100, but that judge traveled only a short distance by car and the cost of gas was \$75 for the event(s), then according to the rule, the club can only reimburse the judge \$75, and cannot pay them \$100. Also, the judge cannot ask for the \$100.

ASFA & AKC Rules Differ

The difference between the AKC and ASFA is that under the AKC rules, a judge may request expenses and then add a fee. For example, the AKC judge may have an expense to travel to an event of \$200 and the judge can request an additional \$2/dog judged if they wish. Or if they travel only a short distance, the judge may request a flat fee of \$150 for the event even though the judge's expense was only \$50.

ASFA judges have always put the interests of clubs and dogs above making a profit from the events. This rule has been stated and restated in all of the older copies of the Running Rules that I have seen.

First Set Your Budget

Prior to asking a judge to your event, clubs should have a budget to determine how much they can offer for expenses. To do this, the club should have an approximation of the number of entries they expect and the entry fees they charge. From that they deduct their standard expenses (ground rental, equipment needs, porta potties, etc.) From that any money they need to operate during the remainder of the year. The remainder would be what they can offer between the judges they want to hire

Set Everyone's Expectations

When it comes to setting expense expectations, it is always best to negotiate with the judge or provide a set limit and have a contract between the club and judge. ASFA Operational Policy O-JUDG17 states that "Electronic confirmation of judging assignments is as valid as hard copy confirmation of judging assignments."

Unlike prior situations where a phone call or formal letter was used, now initial contact from clubs may be through email. During this contact, words like "can you" and "will you" are used to determine if the judge is interested in coming to the event. When agreement is made, it is best to have the final version in the form of a contract as an attachment or within the message so that there is no dispute on what the judge expects for expenses and what the club is willing or capable of providing. The electronic confirmation is the judge returning the email or attachment stating that they agree to it and not having to physically sign a paper version.

It is not a good situation for either party when an individual comes to a trial to judge and travels first class and the club was expecting them to travel coach or drive.

You May Need to Negotiate

Any budget limitations of the club should be stated during the initial offer that the club can "reimburse up to \$XXX" for the event. A judge may accept that or they may feel that due to current situations it would be more expensive to come and ask for some additional funds if they feel they cannot afford it. If a club wants a certain individual, both parties should be willing to negotiate the expenses. For example: to save lodging expense, a club member could offer

to put up the judge for the weekend and provide transportation. Both sides should be considerate of the others' financial capability. It is always best to be safe and ask the judge for documented expenses. For example, when traveling by car, ask for receipts from gas stations, lodging, tolls and restaurants.

ASFA judges volunteer their time and apply professional standards to every aspect of the sport.

Our dear friend Gary Roush, age 75, passed away in July, 2022. He had been sick and disabled for the last several years from a heart problem. It was sad, indeed, to see such an active man become unable to enjoy his favorite sport of Lure Coursing. My wife, Daphane, and I first got to know Gary in 1970 when we both belonged to the Afghan Hound Club of Greater Denver (AHCGD). Gary had no dog and was researching the sighthound breeds.

Some weeks later at a Field Trial in Denver Gary met Frank Cassano with his Salukis, which made a favorable impression on Gary. Weeks later Gary had his founding group of Salukis from various sources - the main ones being the Jen Araby Kennel in California and that of Wayne and Marlys Jensen.

Fast forward a couple of months and Gary, Frank, Daphane, myself, and a couple of others are to be found free coursing on one of Colorado's beautiful high plains deserts, the Pawnee National Grasslands. We had our Afghans, which were no match for the Salukis, but we had fun. Gary actually took a co-owner ship of one of our Afghans, "Fruki" was his name.

About a year later, when Gary had established his own breeding program, he presented Daphane and I me with a pair of young Salukis, which we used to start our own line. Gary in his later days had only one Saluki. He called him "Talisman" or "T-man". Talisman was Gary's kennel name from way back. T-man was bred from descendants of the original pups that he had given us - and it was fitting that Gary named him from one of his favorites from the 70's.

A group of friends, including Gary, formed the Colorado Lure Coursing Association (CLCA), which is active to this day. At about the same time, ASFA was forming in California under the leadership of Lyle Gillette.

Gary Roush was nominated to the ASFA Hall of Fame by Region 8 in 2020. Below is the information that Region 8 presented in support of the nomination. Gary was inducted into the ASFA Hall of Fame in 2021.

Positions Held in ASFA: President, First Vice President, Chief Financial Officer, and all breed judge

Positions Held in Other Lure Coursing or Dog Clubs: Field Trial Chair, Lure Operator, Open Field Coursing Judge. He was also active in the Saluki Club of America.

Gary was a Charter Member of the Colorado Lure Coursing Association (CLCA), which was the first ASFA club outside of California. CLCA held the first lure trial outside of California in 1973. Gary was one of the prime movers in the creation of the Colorado Grand National. Gary served as Co-Field Trial Chairman for the Grand National in 1978, 1979, 1980, 1981, 1982, 1987, and 1988.

1975 was a very political period for allowing multi-sighthound breed clubs to become member clubs of ASFA. Gary was in the forefront of this expansion despite there being a strong movement to keep only AKC parent clubs as members of and control ASFA.

In the 1980's Gary moved to the Williamsburg, Virginia area where he stayed active in ASFA lure coursing, joining the Sight Hound Organization of Tidewater (SHOT). He often served as field trial chair, lure operator and judge for SHOT. Gary continued to accept judging assignments throughout the country. He came to live with Pat Abrams who had her own saluki kennel and was active in showing. I cannot tell you just how much work she had put in caring for Gary who needed it after his heart problem.

Gary has served on the ASFA Board in the following positions:

- 1978 1st VICE PRESIDENT (first time on Board)
- 1980 PRESIDENT
- *1982 PRESIDENT*
- 1986 FIRST VICE PRESIDENT

Gary also served four terms in the early 2000's as Chief Financial Officer (CFO). He alternated with Jeff Lipps as ASFA's CFO for 16 years.

During ACoDs Gary would often preface his thoughts or reports with detailed stories of his Mother. It felt as though his Mother was an active participant in ASFA.

At every ACoD we always looked forward to his (facetious) motion to eliminate the rule which does not allow drinking until after a trial is over. His subtle sense of humor always brought levity at the right moment during some arduous ACoDs.
