

For the second time in as many years, the

March ACoD was held electronically. Thank you, Cathy Sanderson, for putting it all together for us on ASFA's GoToMeeting app. This year over 50 people attended the electronic ACoD, representing 41 clubs.

LCI

The LCI program is growing. The LCI rules from 2020 remain in effect. The final approval on the LCI program will be determined at the 2022 ACoD. The first LCI National Specialty will be held in conjunction with the 2021 II in Cedar Falls, Iowa on Friday May 14th.

TEAM COURSING

The Team Coursing experimental program remains in development by the Experimental Programs Committee. But implementation of the program is on

pause, due to complexities of record keeping, which will be worked out in the coming year.

IT COMMITTEE

Status update on the new records program The IT Committee recently approved Eddie Kominek's LCSoft program, which allows for random draws for ASFA field trials. This is the first software program that the committee has approved. If you know of any other trial software that the IT Committee should take a look at, please contact Cathy Sanderson, Co-Chair.

Several years ago, ASFA contracted with Paragon to create an online database. It has become apparent that Paragon cannot complete that job for us. In the meantime, the IT Committee has approached Eddie Kominek to provide an online records database linked to a re-designed ASFA website. The IT Committee does not want to place responsibility for creation or maintenance of the entire new system in the hands of a single person, so if you have programing or database experience, please contact Eddie Kominek or Cathy Sanderson.

EXCELLENCE IN PERFORMANCE



Summary of 3 Reports Covering February - April 2021

Information supplied by Greg Breitbach, Chair of Judges Licensing

This summary has been reformatted to combine 3 monthly reports. The information is current as of 4/25/2021.

NOTES FROM JUDGES LICENSING

Important reminder

With the new year, the suspension of not judging in two years is no longer in effect. This means that all judges who were potentially losing their license last year and have not judged in the past three years are required this year to judge at least one trial to maintain their license. 2020 does not count for lack of assignments for any judge. (From 2-24 report).

Listing Judges as Lure Operator

Because listing as a lure operator on the judges list is considered personal information, anyone wanting to be listed as a lure operator has to contact me in person. I cannot accept third party information to place anyone on that list. (From 2-24 report).

Meeting Requirements

With more trials being scheduled this year, it should be easier for individuals who have not been active the past three years to obtain assignments and meet the requirement of judging at least once every two years. (From 3-24 report)

Contact Information

If you are not receiving communications, please check the judge list that your contact information is correct. You cannot be asked to judge if people cannot communicate with you. (From 3-24 report).

Provisional Judges

Reminder that provisional judges may do more than four breeds with permission of the Regional Director. The Field Trial Secretary can obtain permission to use a provisional judge for more than four breeds by requesting permission from the RD and providing the information to the scheduling chair. This can assist individuals in areas where some scheduled breeds may not show up but other breeds the provisional may need does. (From 4-24 report).

REC COMMITTEE REPORT

Rules Evaluation Committee—2021 ACoD

There was a lot of work by the REC Committee this past year in preparation for the 2021 ACoD. It is not only the specific rule proposals that are referred to the REC by the Board, but the research throughout the <u>ASFA Running Rules and Field Procedures for Lure Field Trials</u> to ensure that each rule does not contradict another rule or policy and does not cause other rule changes that have not been reviewed.

A huge THANK YOU goes out to the REC Committee members for their hard work and our "bantering" back and forth through e-mail to get our points across and to make the most understandable, well-written rule changes or offer a counterproposal with wording as we see appropriate. Not all our work is accepted by the ACoD. Sometimes it is sent back to REC for re-work because we missed the mark, or after reading how we proposed it, there is a new perspective shared.

This year, only one of our proposals was approved for implementation into the ASFA Running Rules and will go into effect on **August 1, 2021**.

Chapter IV, Section 5. Course Plans. #3

When using a continuous-loop system, mid-course reversals are not permissible.

Report of Records Coordinator

AKC has been notified that California Assembly Bill 702, which would have regulated all breeders in the state, will be pulled from today's committee hearing agenda and not be considered this year. As such, we no longer need clubs and hobbyists to make phone calls during today's meeting.

AKC extends a huge thanks to all the club members, federations, and breeders who took the time to contact the author's office and committee members over the past several weeks. Your efforts made a tremendous difference for dogs and responsible AKC breeders!

AKC Government Relations staff had numerous meetings and communications with the author's office, committee members, and key staff members. Your phone calls and letters supported these efforts and demonstrated that AB 702 was not a good solution for California.

We also thank the California Animal Welfare Association, NAIA, sportsmen groups, and many others who also worked to advocate for a better solution for California.

AKC looks forward to working with California lawmakers, shelters, clubs, and other stakeholders to develop reasonable, effective solutions that will truly benefit animals in the state.

Summer has 2 BOB wins from ASFA IIs, 4 BOB wins from Grand Nationals, 2 BIF wins from regular trials, and placed in the ASFA Top Twenty for 8 years. She has a LGRA title in straight racing and a NOTRA title in oval track racing.

She was born on July 16, 2002 and bred by Bonnie Schulz. Summer was nominated by CLCA (Colorado Lure Coursing Association).

In July of 2002 I called my friend, Bonnie Schulz, who had just had a litter of Afghan puppies and told her that if she had one that she thought she could part with that I would love to have her. Bonnie chose a cute little cream girl for me, and that is the story of how Summer came to live with me.


I feel blessed to have shared my life with Summer for 13 years and will be forever grateful to her breeder, Bonnie Schulz. - Connie Sullivan

Charlie (like his dam Chromium) broke and set new records on the lure coursing field for Borzoi. Charlie was known for his great enthusiasm on the coursing field, but he was best known for his sliding flips at the finish as he came in to grab the lure in his "death" lockjaw grip. It would take three people to get him off the lure; two people to catch and hold him while Leilani would try to get him to release the lure. Charlie died tragically of hemorrhagic enteritis, leaving Leilani heart-broken, as Charlie had been her life for ten years.

He was born on his famous dam's birthday, November 7th. When his dam Chromium died, Leilani volunteered to feed and take care of the five orphan puppies. She fell in love with "Charlie" and asked to be allowed to keep him. A better home could never have been found, for Leilani loved and pampered him and traveled and competed with Charlie everywhere. O'Dah was born June 1, 2004 by Ch. Bi-Na Mahanajim, SGRC out of Ch. Ibtsama Shi'Rayan, FCh, ORC, GRC. Bred by Dr M-D Crapon de Caprona, owned by Dr Bernd Fritzsch. O'Dah's grandfathers are both country of origin Sloughis, one from Libya, the other from Tunisia. On his sire's side he descends from a line of talented racing German Sloughis through his paternal grandmother. He is also a nephew of I'Saar, a grandson of Bouthayna, and great grandson of Aswad Shi'Rayan, all three previous Nubia Cup winners.

O'Dah is the second Sloughi (after his great grand-sire Aswad Shi'Rayan) to be awarded top awards in shows as well as titles in all 3 major sighthound sports, lure-coursing, oval and sprint racing. The Gary Forrester Award is meant to honor a person that carries forward the philosophy, dedication, and joy of ASFA Lure Coursing. I believe Katie Kaltenborn has done that for close to 40 years. Katie was one of the early adopters of lure coursing. She



competed early on with her Borzoi and most recently with her Greyhounds. Many of her dogs have been top-ranked hounds.

Katie is a longtime judge. She became an all-breed licensed judge in 1987. She is one of the premier judges in the ASFA and has mentored many that have become judges or just wanted to understand what judges are looking at on the field. Katie has also served as the ASFA Judges Licensing Chair.

Her involvement with the sport does not end there. Katie is a phenomenal Field Trial Secretary (FTS). She has been the FTS at numerous big events, including ASFA IIs. She has also mentored up-and-coming people who are now FTSs themselves. Katie has agreed to be the FTS for our next two ASFA IIs in 2021 and 2022. Many of us know what a huge and time-consuming job that is! She is also the voice behind moving the ASFA FTS job to computer-based scoring and draws to facilitate faster turn-around of results for the next two IIs.

Katie has played an important role in local coursing club events. She was a central person with the Bluegrass Coursing Club and GANG when Les and Shirri were with us. Katie travels with her dogs and has been a voice for promoting the sport of lure coursing across the country. She even judged in Alaska a few years ago.

Katie has friends far and wide in the lure coursing world. In addition to spending time with seasoned coursing folks at field trials, Katie seeks out the newcomers. She makes them feel welcome and mentors them. This is important because the newcomers and younger people will keep this sport alive. They are the future.

Katie's almost 40 years in ASFA Lure Coursing has had an impact on the sport to the extent that it would not have been the same without her. I do not know a person more deserving of this award both in longevity in the sport, and for her dedication, support, and unwavering love for lure coursing. If Katie doesn't emulate Gary Forrester and uphold his legacy in the sport of lure coursing, I don't know who does.

GARY ROUSH

Gary Roush is the Hall of Fame Individual Inductee for 2020. He was nominated by Region 8.

Positions Held in ASFA: President, First Vice President & Chief Financial Officer and all breed judge

Positions Held in Other Lure Coursing or Dog Clubs: Field Trial Chair, Lure Operator, Open Field Coursing Judge. He was also active in the Saluki Club of America.

Gary was a Charter Member of the Colorado Lure Coursing Association (CLCA), which was the first ASFA club outside of California. CLCA held the first lure trial outside of California in 1973. Gary was one of the prime movers in the creation of the Colorado

Grand National. Gary served as Co-Field Trial Chairman for the Grand National in 1978, 1979, 1980, 1981, 1982, 1987, and 1988.

1975 was a very political period for allowing multi-sighthound breed clubs to become member clubs of ASFA. Gary was in the forefront of this expansion despite there being a strong movement to keep only AKC parent clubs as members of and control ASFA.

In the 1980's Gary moved to the Williamsburg, VA area where he stayed active in ASFA lure coursing, joining the Sight Hound Organization of Tidewater (SHOT). He often served as field trial chair, lure operator and judge for SHOT. Gary continued to accept judging assignments throughout the country.

Gary has served on the ASFA Board in the following positions:

- 1978 1st VICE PRESIDENT (first time on Board)
- 1980 PRESIDENT
- 1982 PRESIDENT
- 1986 FIRST VICE PRESIDENT

Gary also served four terms in the early 2000's as Chief Financial Officer (CFO). He alternated with Jeff Lipps as ASFA's CFO for 16 years.

During ACoDs Gary would often preface his thoughts or reports with detailed stories of his Mother. It felt as though his Mother was an active participant in ASFA. At every ACoD we always looked forward to his (facetious) motion to eliminate the rule which does not allow

drinking until after a trial is over. His subtle sense of humour always brought levity at the right moment during some arduous ACoDs.

Region 8 feels that Gary deserves to be inducted into the ASFA Hall of Fame in the year 2021.
