Message from ASFA President Scott Hurlbert

November 2025

Why Lure Coursing? -- As the coursing season winds down, I find myself reflecting on a simple yet profound question: Why

lure coursing? Why do I invest my time, energy, and money into this sport? Is it the recognition? The thrill of competition? The joy of watching my dog run—doing what he was bred to do? Or is it the people?

I got my first whippet in 1990 and ran our first course in 1991. He wasn't much to look at—27 pounds soaking wet—but we showed him anyway. He chased Frisbees with enthusiasm, thanks to his sire, Ashley Whippet Jr. We thought we were just rescuing a dog. But the moment he curled up in Julie's lap, we were hooked.

We entered lure coursing with little knowledge, but quickly learned our Whippet, Devo, was fast. Very fast. Sure, he sometimes ran his own course, but he always caught up. I didn't know any better—I just knew Devo gave it his all and came off the field breathing hard, wearing what I swear was the biggest smile I've ever seen on a dog.

We started traveling. I insisted we'd only drive three hours for a trial. So, we went to lowa. I brought a book to read between runs. Then Russ Jacobs suggested I help ICA as a huntmaster. "Sure, why not?", I said. I did it for my club. That's when things changed.

I started meeting people. Julie, my wife, was always more sociable than I was. They asked if I could help, and soon I was offering before they even asked. I'd go straight to whoever was setting up the field and ask if they needed a hand. I stayed after trials to help tear down—even when I had an eight-hour drive home. That three-hour limit? It vanished quickly.



Julie and I met incredible, generous, passionate people who were proud of their dogs. We didn't always get along with everyone, but we always took care of each other's dogs. I've helped carry injured dogs off the field, offering comfort and rushing them to the vet. I've held friends as they watched their dogs collide and not get up. I wanted to run to the dog, but the owner needed me more. Others were already sprinting to help. It didn't matter if they knew the dog—they just cared.

Years later, I got a call from a coursing friend in Georgia one November. He asked where I was headed next. Our club's last trial was in October, and SLASH used to host one in November. I told him we were done for the year. He laughed and said my dog, Dante, was second in the Whippets—and his was third. "Second in what?" I asked. He thought I was joking. I'd heard of Bowen points, knew they mattered for Field Championships and Lure Courser of Merit titles, but I never tracked them. I think Dante ended up fourth that year.

Since then, I've had many Whippets. My last hound was a Rhodesian Ridgeback who thought she was a Whippet—thanks to Dina, our last Whippet, who showed her the ropes. Dante was a phenomenal runner, earning LCM 2 in his second year and eventually reaching LCM 7. I've seen unforgettable courses—like the big Irish Wolfhound named Finn who made a wide turn, spotted a ravine with a safety fence, and leapt it mid-chase without missing a beat.

I've met wonderful people. I reconnect with many of them at the International Invitationals, where we share drinks, stories, and laughter. We talk about the runs, the dogs, and yes, sometimes even the judges. I cherish those moments—all of them.

So, as the year ends and you consider entering one last trial—whether to chase those final Bowen points or simply to see a good friend—ask yourself: *Why do I do this?*

Well ... didn't I just tell you?

This is the Time to Make Hall of Fame Nominations

Nominations remain open through January 31, 2026

Do you have a remarkable hound or person in mind to nominate for the Hall of Fame? This is how it works. All nominees – hounds and persons - must have been out of the sport for at least 5 years to be considered. Hound nominations are made through the ASFA clubs. Persons are nominated through the Regions. So, to nominate a hound, you will need to work through your club. To nominate a person, you will need to work with your Regional Director. The Hall of Fame Committee will select up to 5 nominated hounds and 3 nominated persons to present for consideration at the 2025 ACoD. The ACoD Delegates will then vote to induct 1 person and up to 3 hounds into the Hall of Fame for 2024. Direct all questions and all nominations to Michael Hussey at *dinnree@skybeam.com*.

The purpose of the ASFA Hall of Fame is to honor in perpetuity those hounds that have achieved outstanding performances or records in the sport of lure coursing. This fosters the continued remembrance of remarkable individual coursing careers and sets a high standard to help new hounds and owners achieve their goals.

The Hall of Fame shall also honor those individuals who have donated a great part of their life to improve and promote the sport of lure coursing for sighthounds. Since its inception, the sport of lure coursing has continually evolved. That evolution has taken place through the vision and energy of people who should be honored for their efforts on behalf of the sport. We shall endeavor to remember those individuals who have given their time and energy to make lure coursing what it is today. Their commitment serves as an inspiration to those who would, in turn, take the sport to greater heights.

The Hall of Fame was instituted in 1998. The 1998 Annual Convention of Delegates elected to the Hall of Fame the first Field Champion of each breed; the first Lure Courser of Merit of each breed; the first AKC conformation champion of each breed to become an ASFA Field Champion; the only three hounds to obtain the Grand Field Champion title; and the following people: Lyle Gillette, Tom Leone, Betz Leone and Gary Forrester. These hounds and individuals are the Charter members of the ASFA Hall of Fame.

Deadline for Submitting Nominations

The ASFA Hall of Fame nominations for the current year are now open and will remain open through <code>January 31, 2026</code>. They will be voted on at the 2026 Annual Convention of Delegates in <code>March 2026</code>. Gary Forrester Achievement Award Selection Committee

Request for Nominations

Nominations remain open through January 15, 2026

This is a request for nominations for the Gary Forrester Achievement Award. The recipient of the award for 2025 will be announced at the 2026 ACoD. The nomination and selection processes are described below.

How and When to Nominate

Nominations should be sent to one of the committee members. Their names and email addresses are listed at the end of this report. Nominations must be received by <u>January 15</u>, <u>2026</u>, for consideration at the 2026 ASFA ACoD. <u>Please also include a write-up detailing the nominee's ASFA lure coursing contributions, and achievements.</u>

Evaluating Nominees

The committee will give preference to people who have been active and involved with ASFA lure coursing for five years or more and who have made a long-lasting, significant, and positive impact on the sport and/or association. The committee will consider, but not be limited to, the following areas of involvement: a) lure field trial participation, b) judging, c) active leadership at the local level-clubs and trial activity, d) ASFA administration, e) promoting ASFA and the growth of the sport, f) improving the quality of trials, and g) exceptional performance or effort in any other area.

Ideally, the committee will name one recipient per year, but there may be good reasons for exceptions. It is possible there may be two or more equally deserving candidates or a team and naming one person might prove to be nearly impossible. Conversely, there may be a year when the committee cannot agree on any recipient.

A person who is <u>not</u> currently a member of the board or an active key committee chair will be given strong preference. This award should not appear to be an "in house" honor.

Selection Committee Process

An active committee of four people will make the choice rather autonomously. The committee members are chosen by the ASFA Board of Directors with consideration to selecting committee members that are spread evenly across the country. The committee chair is tasked with aggressively seeking nominations from the members of the board, from key committee chairs, and by request in the Communique'.

The committee will review all nominees (maintaining a file of past nominees to be reviewed each year with the new nominations), make a choice, and then report the choice to both the winner and the board no later than <u>January 31, 2026</u>. This will allow the

recipient time to arrange to participate in the ACoD, if they wish to do so. ASFA will offer to cover the cost of convention registration fees (only) as a small incentive to encourage the recipient to attend.

All members of the committee must agree on the winner.

The committee chair will supply the ASFA webmaster and the person presenting the award at the ACoD with written information about the recipient, listing major accomplishments.

INTRODUCING the CANDIDATES



Scott Hurlbert Candidate for President

I would like to thank the Nominating Committee for putting together this slate of candidates. It can be a difficult task, especially in an all-volunteer organization such as ASFA. I am honored to be nominated for a second term as President. My challenges during the past two years have been to keep ongoing

projects moving forward while entertaining new projects.

Some of you may recall I served on the board previously as the Region 5 Director in 2007. At that time, I was instrumental in rallying the RDs to set up the International Invitational 3-4 years in advance, so we could do advance planning and know where we would be going in the following years.

In 2022 I returned to the board as CFO, and in 2024 I was elected President. During these past 4 years I have seen many changes in how ASFA is run and how it is perceived by our clubs. Yes, the board has become more efficient. However, the challenges have also changed. Individuals now have many opportunities to participate in a great variety of activities with their dogs, which wasn't true in the past. This impacts lure coursing. Also, many of our volunteers are aging out.

As President, I am very committed to the vitality of ASFA. We have some of the same struggles we have always had—money and volunteer involvement. With that in mind, I have been working with the board, and more specifically with the Inter-Agency Committee (IAC), to reach out to the American Kennel Club (AKC) to discuss the future of lure coursing for both organizations. We have generated some positive communication, and the door is open for more. We have taken suggestions from our club members and will work with the AKC to help improve lure coursing together. Having an open, candid conversation without prejudice has been a desire since the creation of ASFA. It has been attempted several times and was met with barriers each time. The IAC is looking at this opportunity as one way to grow lure coursing, to make it safer, and hopefully to make judging more consistent between the organizations. We will continue to build on this beginning and see where it takes us.

The ASFA Board has promised a new records program and website for some time. Originally, several individuals stepped up and worked on the existing Microsoft Access program. But our needs soon exceeded that program's capacity due to changes to the

running rules and the addition of Singles and LCI. Thereafter, the Board contracted with a company to rewrite the complete application and to make it web based with the goal of enabling clubs to access records and submit their trial results online. Due to oversight issues, personnel changes, and a lack of clear understanding of what was needed, we had to break ties with that company and look elsewhere. After that, an individual did step up to fix several issues with the current program and started working on a new application with the same parameters as before. As President, I began directing more oversight of the process that had been going on for over two years. As we all know, life happens. The programmer, while having about three-quarters of the work completed, needed to bow out for personal reasons. We again entered the search for a programmer and now have found an individual who is willing to continue the work that was started and to build on it. We continue to keep our eyes on the prize. I want this to be completed. I do not want to see any more promises that cannot be kept.

My primary goals for the next year are to the get the records program completed; to update the current web site; and to create better communication with the clubs. It is important to keep on top of these projects, create better oversite, and listen to the clubs for their input.

If elected President, I believe I can help the ASFA Board achieve these goals. Thank you. –Scott Hurlbert



Marilyn Standerford

Candidate for First Vice President

I'm Marilyn Standerford. I have been in ASFA Lure Coursing since August, 1990. It all started when I married Kent. Nebraska Coursing Association (NCA) had a trial the week after our honeymoon. I was sitting in the pickup while Kent was out riding the little dirt bike restringing the course. Elaine McMichael came over to the truck and asked if I could add. I've been either a field clerk or field trial secretary at almost every trial I've attended ever since.

Progress has been moving forward—although not quickly—toward selecting a resource to develop the ASFA records program. We are currently developing both a clear project plan and an appropriate oversite plan.

Previous efforts to re-develop the records program were hampered by both a lack of clarity in the project plan and weak oversight. We understand how frustrating it is to all of you that after years of attempting to develop a new records program, we still do not have it. This is especially difficult for Lori Zorbaugh who must make the current system work.

We are using knowledge gained from past problems. As with building a house, we are creating a solid foundation. We are making sure that we really know what we are asking for, and what the program needs to do both today and in the future. And it is fundamental to the final success of the project that we find the appropriate resource to execute this task.

The committee is optimistic that a proposal will be presented to the Board soon. Once the Board approves the project plan and contract, the actual development can start.

All Things Must Pass:

On speed, style, chasing, and coursing by Ernest Abresch

Years ago, I was looking for racing Afghans, and I had a conversation with an Afghan hound racing breeder. I remember she said: "Ernie, why are you so bent on getting fast Afghans? You aren't racing in the United States and you don't need really fast dogs to win in lure coursing." I told her that my kennel, Synergon, isn't necessarily selecting fast dogs to chase plastic, we're selecting hounds that can course hares, so speed matters.

Lately though I've been thinking that she wasn't wrong. You might think I'm addressing the cries of "speed is not important", echoed by many. Well, not exactly. Speed and ability to sustain are very important. A courser knows this. Now, lure chasing falls short of recreating a course on hares and I suspect many know this too. Organized coursing under rules, which was the template for lure chasing, was really quite simple - speed for run-ups and ability to engage the hare are crucial.

I had another conversation once with a professional greyhound trainer. We were talking about English coursing and open field coursing. He said, "We don't care what the dog looks like when it turns the hare. You're judging what you're seeing. What is happening in front of you. We don't care if the dog is big or small or if the dog was clumsy or not, we care what the dog is actually doing to the rabbit. Not "what if." There are no style points. We're judging what the dog is actually doing to the hare."

A gallop is a gallop and all sighthounds have this ability. I remember ghost judging once and I heard, "Here come the saluki and next the borzoi. Watch their style and how they run, watch them running in a pack." Huh huh. Maybe I missed something, but I don't recall the early lure coursing judges judging "style."

Where did the notion that a dog represented its breed better than the others enter a judge's decision and how does one decide what the best representation of a breed looks like? Is there a magical template on each breed that is circling about? Who gets to decide what the best example of a breed looks like? How do you know? You don't know. You do know what the dog did and how it actually performed in front of you.

A judge's book has categories and it's hard enough to look at three dogs and score each category on three dogs. So, I remember again that conversation, "Ernie you don't need a fast dog." We need to be honest and realize that we aren't recreating a hunt. People say, "Oh, they're running in a pack, oh, they're anticipating the game." Do we think the hounds don't know the difference? A dog does know the difference between a bag and prey. They know it's a game. We need to realize that this is not a hunt. The dogs know this. The dogs don't react to an artificial lure the way they react on live game. We should be honest and understand that this is chasing, not coursing. That's why I don't mind letting all breeds participate in lure chasing. Chasing is not coursing.

The horse is out of the barn and it's too late. Lure chasing has so evolved that any semblance to its original intent is now a thing of the past. Now, my article may sound like I am railing against the machine. Ha. I'm not. Thank you, George Harrison. I think of your song, 'All Things Must Pass.' I get it, all things must pass. –Ernest Abresch

Retiring As An Official Event Photographer In Our Sport

We are all familiar with Mary Huff's dynamic photos of dogs in action on the lure coursing field. Mary acknowledges that the photos she takes are built on her knowledge of dogs and the events she is photographing, her ability to read dogs; and her desire to capture something unique that the dog is expressing—that is hard to define in words, but comes across in the photo.

Mary's knowledge of dogs and of dog sports is based on her lifelong experience with and understanding of animals, particularly dogs. Before discovering dog sports, Mary traveled the rodeo circuit competing in barrel racing. She then moved on to polo where she and her spouse trained and sold polo ponies. Mary also became deeply involved with rescue. She operated the Humane Society in Wright County, MN as well as being a state licensed wildlife rehabilitator. Sam has already proved remarkable.

Mary is impressed by the number of talented professional photographers that are

becoming active in lure coursing photography. While she is stepping back from her official duties, Mary will not be giving up lure coursing photography altogether. And she will be available to help the new and developing photographers in their work as her way of "paying back".

We are forever grateful to Mary for her friendship and for the many photos she has allowed us to publish in the Communique' over the years. We wish her the very best in her next chapter. 

Best of Breed Trophies Saturday

Afghan Hound

Gary Forrester Trophy

Gary was active as part of ASFA administration and on the field. One of the first all-breed judges in 1977, he continued judging until 1991; Chairman of judges licensing from 1978 to 1984; was a member of or chaired the following committees: AKC negotiation, computerization, reinstatements, budget, FAN, Constitution revision, rules' nominating, and several investigative committees of the board. He was 2nd VP 1978 to 1989, 1st VP 1980 to 1984, President 1984 to 1988 and the first Field Representative 1990 to 1991. He owned and lure coursed Afghan Hounds since 1974 – "Bandit" and "Piper".

Basenji

Merv & Wilma Bauer (1920 - 1987) Trophy

Their untiring promotion of Basenjis contributed to ASFA's acceptance of the breed. They were active members of the Central Illinois Sighthound Club, and together they worked to advance Basenjis on the field and in the show ring. The motorhome, packed with a mini-bike for restringing a drag line, lure equipment, electricity, warmth and Basenjis, was a familiar and welcome sight at trials in the Midwest (including Carbondale, Illinois – at the first International Invitational).

Borzoi

"Locket" Trophy

Zaraya of the Wild Hunt, LCMXVII, bred by Ariel Duncan, owned by Leigh Littleton and Ariel Duncan, and chauffeured primarily by Leigh Littleton. #l lure coursing sighthound in 1983 and 1984, #l Borzoi in 1985 and again in 1988 as a Veteran, and continuously in the Top Ten from 1983 through 1989, Locket was winner of Best in Field at the 1983 Grand National Lure Course. Locket's goals in life were smiling at as many people as possible, playing the coursing game with intensity and follow, and killing as many lures as possible, and she did a great deal of each. Her last field trial was the 1992 International Invitational at Lexington KY, where at 10 years of age she took first place in the Veteran stake against competition; by this time, she was the only sighthound to have earned an LCM XVII, and had defeated over 2200 Borzoi.

Greyhound

Mike Lorenzo (1948 – 2008) Trophy

This trophy, featuring a brace of coursing Greyhounds, is dedicated to the memory of Mike Lorenzo. Mike and his wife Karen bred and trained many top lure coursing Greyhounds under the banner of the Winds Greyhounds, and over the years traveled many miles to compete against the best runners on the field. Mike was one of the most talented lure operators in the sport, and there was no equipment problem that could best him. He served as Regional Director from Region 9 from 2004 until 2007, and often served as Field Trial Chairman for several clubs. He conceived and co-founded the ASFA National Greyhound Specialty. Above all, he was richly deserving of that rarest of accolades: "sportsman".

Ibizan Hound

Dean Wright

Dean was the president of the Ibizan Hound Club of the United States when the breed was accepted by ASFA in 1976 and recognized by the AKC for conformation in 1979. Dean has owned and bred Ibizan Hounds since 1967. He owned the first Ibizan ASFA Field Champion as well as the First Ibizan AKC Champion, both by the same hound, CH Sunking Eterna of Treybeau, FCh. Dean served on the ASFA board as a Regional Director for more than five terms and as First Vice President for two terms. He was the chairman of the Hall of Fame Committee. Dean remains very active in ASFA lure coursing.



Irish Wolfhound

Kevin Bryson (1947 – 1999)

A familiar, friendly face behind the lens, Kevin Bryson was a devoted fan, an ingenious artist, and trusted friend within the sport of lure coursing. Creating some of our finest memories on the field, Kevin spent tireless hours working his photographic magic to give us the timeless moments we treasure. Kevin shared his life with his wife Jill, Irish Wolfhounds, a Whippet or two, and Leaping Lizards Professional Photography.

Italian Greyhound Jack Downing /Teri Dickinson "Whirlwind's Italian Greyhound Trophy"

Breeding, showing, racing and coursing Italian Greyhounds under the Whirlwind prefix, Teri Dickinson and Jack Downing were instrumental in getting Italian Greyhounds approved as an ASFA breed, having performed breed presentations at several ACoDs and working tirelessly behind the scenes to promote their diminutive sighthounds from 1993 until 2001 when IGs were fully recognized. As part of their service to ASFA, Jack has served numerous times as Region 4 Director and as an all-breed ASFA judge and an accomplished lure operator, having been named Lure Operator of the Year in 2010.

Pharaoh Hound

George & Joyce Martin

George and Joyce were instrumental in the late 70s and 80s. George was the RD for Region 2 from 1985 – 1986. George attended Several ACoDs even when he was not the RD. They competed with their Pharaohs on the West Coast, and "Bandit" was their most notable Pharaoh Hound.

Rhodesian Ridgeback

Meg Willis-Redfern Perpetual Trophy

Meg is a long time Rhodesian Ridgeback breeder with the kennel name of Rare Earth Ridgebacks. Meg was instrumental in helping achieve recognition of RRs in the ASFA through her advocacy for the breed. From her breeding program, focused on form and function, to mentoring people in the RR breed about coursing, she led the change in making RR coursing a reality. Today, RRs are a huge part of coursing, both in large entries and the fact that RR owners are out working the trials in every capacity, including some of our top huntmasters, lure operators, and judges. She is a mentor and friend to many and has one of the best senses of sportsmanship in the lure coursing arena. Meg has been a strong advocate for the ASFA and believes deeply in the premise upon which the ASFA was founded.

Saluki

Bill Henry (1929 - 1983)

Bill was the 2nd VP – 1980 until his untimely death in Texas on January 9, 1983. An active judge and competitor on the field and a colorful "protest digester" on the board; may have been one of the only 2nd VPs to call an ACoD to order. President of Galveston Bay Saluki Club for many years and an officer (and active club member) of the American Saluki Association. Bill owned many top winning Salukis (bench and field) under the Henrad Kennel name.

Scottish Deerhound

Robert Sellers (1934 - 2002)

The Bob Sellers Memorial Trophy is offered in memory of Bob by his many friends in the lure coursing community. Bob, with his wife Norma, was the breeder of many top lure coursing Scottish Deerhounds under the Vale Vue kennel name. He was also a long-time ASFA judge and lure operator, and he served as President of the Scottish Deerhound Club of America. Vale Vue was the home of the first ASFA coursing trials on the East Coast, and Bob's enthusiasm and love for lure coursing helped bring many new people into the sport over the years.

Whippet

Tom Leone (1917 – 1980)

Together with both his wife Betz, and his friend Lyle Gillette, was a solid part of ASFA's formation and early years. He served as ASFA Treasurer from March 1976 to 1980. Sheridan Seabiscuit, UD was his 5^{th} Whippet FCh. Tom was an active judge, lure operator, and always ready with a smile and calm demeanor.

Trophies

Borzoi Darkling Perpetual Trophy

Will be presented to the Borzoi earning the right to represent the breed in the Gillette Stake in memory of Silkenswift Blaze's Darkfire. "Darkling", the #2 Borzoi on ASFA's Top Lifetime Achievement record, passed away on December 26, 2008. Darkling began lure coursing September 27, 1998 and retired almost eight years later on January 1, 2006. During that time, Darkling successfully participated in seven International Invitationals. He competed in ASFA trials in 16 states from Florida to Wisconsin, Colorado to Texas, Iowa to Pennsylvania, and from Delaware down the East Coast to his home state of Georgia. His record as #1 ASFA Borzoi in 2000 and 2001, as #2 Lifetime Borzoi, as well as his 69 Best of Breed wins, speaks volumes about his performance. But more significantly, we will never forget his noble presence and confident and peaceful demeanor when off the field.

Ibizan Hound Eterna Perpetual Trophy

The Eterna Perpetual Trophy will be presented to the Ibizan Hound earning the right to represent the breed in the Gillette Stake, in memory of Ch Sunking Eterna of Treybeau, FCh, LCM, who was owned by Dean Wright and Kathy O'Brien. Eterna was not even old enough to compete on the day that Ibizan Hounds were eligible to enter their first ASFA Field Trial on April 16, 1976. Eterna turned one year of age two months later in June and became the first Ibizan Field Champion. In January of 1979, when the breed was eligible to compete for an AKC Breed Championship, Eterna went to Florida in January along with 20 other Ibizan Hounds. Eterna did not place on the first day but earned 3 5-point majors on the next three days, making her the first AKC breed champion. Finally finishing her LCM at the age of 10, Eterna did truly combine form and function the way that it should be.

Irish Wolfhound Woople Perpetual Trophy

The perpetual trophy for the Gillette Stake was inspired by the memory of the past Irish Wolfhounds who demonstrated the beauty in the show ring and the drive in the field. Jill Bryson commissioned this trophy and dedicated it to her IW Woople, CH Franjo Pearla Dhu at Aeroglen, LCM, RA, RATI, TKN, VC.

Rhodesian Ridgeback Nitro Perpetual Trophy

This trophy is donated by Gayle A and Paul Kytta II in memory of BIF DC Rare Earth Top Fuel Eliminator, LCM7, VLCM4, GRC. JOR, MC, DC, CGC, TDI, TT, HIC, VC. Nitro was ranked nine times in the ASFA Top Ten Ridgebacks, achieving the #1 spot in 2010. He retired in 2016 as the #2 ASFA Lifetime Ridgeback and as the highest ranked male Ridgeback in ASFA history.

Whippet American Whippet Club Perpetual Trophy

Representing the breed in the Gillette Stake American Whippet Club.

Best in Gillette Stake Lyle Gillette (1910 – 1993) Trophy

The Father of organized lure coursing and ASFA. Tirelessly began promoting the sport in 1971; launched ASFA in 1972; Chairman '72 to '75; President '76 & '77. Without his vision and drive, we would not be here now celebrating the winners of this International Invitational.

Afghan Hound

"Bandit" Tamora's Image of Ali CD LCM7 CAN FCHX TT

Bandit shared a home with Gary & Marietta Forrester in Pennsylvania. #1 Sighthound (all breeds) in '76, '77 and '78 and #2 lure coursing Afghan (Top Ten) as of 2011. Bandit has 1167 hounds defeated, 31 Best of Breeds, and 4 Best in Fields. That black & tan, always impeccably groomed, very calm – until slipped and then a burst of power with the black and tan coat flowing in the wind! "Bandit" actively competed for 6 years and was known to be flown to some trial sites by his own personal pilot, Gary.

Azawakh "Cinnamon" Multi CH Kel Simoon Cinnamon, FCC

Cinnamon was the first Azawakh to fulfill the requirements of ASFA Field Champion. She was also a great show dog, a loving mother and a wonderful pet. Cin was tragically killed when she escaped from our yard in April of 2000. Her legacy lives on in her daughter, SBIS, Multi CH Kel Simoon Essari, FCC and her litter sister, SBIS, CH Kel Simoon Celie, FCC. These three dogs were the only Azawakhs awarded the FCC, before the breed was fully recognized.

Basenji "Sheena" Patrician Sheena Crimson Art, LCM3

Sheena was owned by Dave and Carol Phelps of Maryland. #1 ASFA Basenji in 1988 and was #1 ASFA lure coursing Basenji of all time, as of 1989. Sheena proved that Basenjis were truly competitive! Sheena was a pet that everyone hopes they will have one day. Unless something was moving, she was perfectly content to lie in front of the wood stove on a cold day. On the field she ignored the other dogs, and all her attention was focused on catching the "bunny". She squeaked and fought to be released when she heard the lure machine. All she wanted was to kill that bag at the end. Sheena would leap in the air to try to see where the bunny went if she lost sight of it. Sheena never did learn to "cheat". Sheena helped change the attitude toward Basenjis as lure coursers.

Borzoi

"Pyerun" Caspian Prince Pyerun Duncan, LCM2 CANFCH

Owned by G Ariel Duncan. The first LCM Borzoi on Sept 17, 1977, and first LCM II Borzoi in April, 1979. Dubbed "the alligator" by many lure operators in the later years of competition, this red dog's zeal for plastic set the standard for the others to follow.

Greyhound

"Fantasy" Treybeau's Fantasy, LCM 7 (March '84 – Sept '91)

Fantasy lived to run, and with Dean and Sandy Wright's help, she loved living. She began accruing lure coursing titles with a FCh in 1985 and finished her LCM 7 in '91. She was #1 lifetime Top Ten coursing Greyhound (1995); 847 hounds defeated, 133 BOBs, 30 BIFs, 151 Firsts, 2394 ASFA points, and ASFA Top Ten every year from 1985 to 1991, seven years and #1 for six of those years from '85 to '90. "THE PAST IS ONLY A MEMORY AWAY".

Ibizan "Flyer" Treybeau's Spanish Flyer, LCM3

Flyer was one of the first three Ibizan Hounds to compete in an ASFA trial at Vale Vue Kennels in 1976. Flyer was the first Ibizan Hound to earn the LCM title and was an original inductee into the ASFA Hall of Fame. Flyer was in the ASFA Top Ten ASFA 1976 to 1982; #6 Lifetime Ibizan in 1995 with 461 dogs defeated and 24 Best of Breeds. Flyer proved to all that you run on your heart and the desire in your head. It makes no difference as to your conformation.

Irish Wolfhound "Joshua" CH Just Plain Joshua Murphy, FCH

Josh was owned by Deborah Keplinger Sanders and bred by Dr Paul Palmer. Josh was the first Irish Wolfhound Field Champion (1974) and the first Irish Wolfhound Dual Champion. He received his AKC conformation championship two weeks after finishing his ASFA Field Championship. Josh is the only Irish Wolfhound to achieve his FCh under the original ASFA format, having to earn his points competing against Greyhounds, Salukis and Whippets. In the beginning, before ASFA instituted breed stakes, the dogs competed in mixed stakes determined by a random draw which included all breeds entered in the trial.

Italian Greyhound "D" FCC DC Whirlwind Blew By You LCM VFCh OA NAJ JOR VCM

"D" was an IG lure coursing pioneer. Born in February 1995, he ran in his first trial in March 1996, the year IGs were admitted to the Miscellaneous Stake. Famous for both suicide bunny kills and sideline histrionics, his durability and enthusiasm opened the mind of many a skeptic. He coursed in an era when the Miscellaneous Stake was optional and not offered at all trials. Competitors were few and far between. Despite that, he earned enough points to meet ASFA Field Champion requirements three different times. He was first awarded a Foundation Coursing Champion title, then after a rule change, earned the Miscellaneous Field Champion title. After IGs reached full recognition in mid-2001, he went on to earn Field Champion, LCM and Veteran Field Champion titles. His first entry in a standard ASFA stake was in the veteran's stake at the 2001 II. Among D's groundbreaking accomplishments were - first IG to earn an ASFA title, and the first IG dual titlist. He was the #1 Lifetime Miscellaneous Under 18" from 1996-2001, the entire duration of IGs competing from that stake, the #1 Miscellaneous Under in 1997, and a member of the IG Top Twenty every year from 1996 – 2004. "D" ran his last trial in 2006. Breeder/Owners Teri Dickinson & Jack Downing.

Pharaoh Hound "Bozo" CH Kamaraj Ra-Harakhte, LCM 6, CAN FCH

Bozo was owned by Frank Belinowiz of Massachusetts. Bozo is the only LCM 6 Pharaoh to date (2-94). #1 lure coursing Pharaoh ending 1989. A lure operator's worst nightmare. The BOZO Trophy is to honor all Kamaraj Pharaoh Hounds in the past, such as: BOZO, #2 Lifetime Ranking Pharaoh Hound; Tiye Tu, 1999 BIF at the II; Luxor the Brod, 2001 Gillette Stake Winner; Seeker "Shut Up", Hall of Fame.

Rhodesian Ridgeback "Ida" BII FC Redwing's Private Idaho LCM13 VFCH SC CGC

Ida was owned by Chuck Harper and Jeff Nearhoof. Bred by Sue and Dick Kaehler. In a crowded field of great coursing Rhodesian Ridgebacks, "Ida" has left a lasting impact on the sport. Blazing a coursing path since 1999 through 20 different states, she has set many records and often had been a pioneer, most notably as the first Ridgeback to go beyond LCM 5. Ida won Best in International Invitational in 1999, was the #1 Ridgeback for 1999, 2000, 2001 and 2002, and remained in the Top Ten for 2003 and 2004. She also went BOB at four non-consecutive IIs, and seven Regional Invitationals in four different regions. Ida has been #1 Lifetime Ridgeback since 1999.

Best of Breed Trophies Sunday (continued)

Saluki

"Haseeb" Sur-Ra Haseeb Amon Kahtahdin, LCM 8

Haseeb was owned by Dean Wright & Janis Copenhaver. Haseeb was the Number 1 Lifetime Saluki ending in 2000, with 976 hounds defeated, 56 Best of Breeds, and 13 Best in Fields. He made it look so effortless and easy over his many years on the field. Haseeb competed in 365 ASFA trials, plus some trials in Canada. Haseeb was a loner at home, preferring to do things alone. He would play for hours with an old football, throwing it in the air and chasing it.

Scottish Deerhound

"Pyns" AM/CAN CH Pibroch's Pyns Of Vale Vue LCM

AmCanCH Pibroch's Pyns of Vale Vue, LCM, owned by Norma & Robert Sellers of PA #4 lure coursing SD of '89.

Whippet

Betz Leone (1918 – 1993)

The "first lady" of ASFA, helped put together the first ASFA lure course on school grounds a stone's throw from her home in California and continued to be an active judge and handler throughout her lifetime. She was the FAN co-editor and printer (crank-style) beginning in 1974 and continuing for several years, served as Regional Director from 1981 to 1984 and 2nd VP in 1986 & '87. Always willing to help, always with a smile, always the lady.

The Gallant Greyhounds Trophy is awarded to the NGA Greyhound with the highest cumulative score for both days. They have been in ASFA since its very beginning and are direct ancestors in recent generations of many of the lure coursing Greyhounds of other registries.

The President's Cup

The President's Cup is offered in memory of ARNOLD ROSS who served on the ASFA Board as President in 1978 and 1979. Arnold competed on the West Coast with his Whippets. Ross was ASFA President when the first ASFA International Invitational was held in Carbondale Illinois. This was a one day II on Saturday, with the top hounds of each breed competing for top honors on Sunday. Today, Best of Breed hounds, from both days of the II, compete in the Best of International Invitational.

"Links to the Past"


The remarkable "Links to the Past" II Chain was awarded for the first time at the 2007 International Invitational' a truly fitting tribute to the 35th Anniversary Year of the ASFA. It is absolutely spectacular.

This truly unique trophy was the brainchild of Kathy Nelson and Jack Helder and was purchased (and is maintained) by individual donations from ASFA clubs and their memberships.

The "Links to the Past" Best in II Trophy is hand-crafted in sterling silver and is comprised of a chain bearing engraved links that recognize every Best in II hound in ASFA's history, stretching back to the first II in 1976. The hound's name is on one side, and the year on the other. The trophy links every former Best in II hound within one exceptional trophy. It remains in the possession of the ASFA President for presentation at IIs and is displayed in a case to protect the chain. Best in II hounds, and those who owned a former Best in II winner, can purchase an engraved sterling silver "take home link" – for a donation toward the future costs of maintaining this one-of-a-kind historical record – to us in display or as a piece of jewelry.



Comments from the II Judges



Linda D'Antonio

It was an honor and a pleasure to participate as one of the judges at the 2025 ASFA International Invitational. Like many of you, as someone who has experience organizing and running local trials, I know what a huge time and energy commitment it takes to make even a small trial work. So, I realize how much effort and commitment it must take to make an International Invitational a reality.

First and foremost, a special thank you to the ASFA Board and the Field Committee for everything you did to make this II happen. Scott Hurlbert was everywhere at once on his trusty golf cart. (And I had to hold on for my life whenever I caught a ride with him). Jennifer Gysler, you didn't go unnoticed or unappreciated in your corner of the barn conducting all of your "secretarying." That is hard work! You rock! Special thanks to Ping Pirrung and Aragon Farms. Wow! What an absolutely spectacular site for lure coursing. The fields were amazing and the hounds clearly enjoyed them. Those alone were worth a trip back all the way across country.

There were also some fun surprises out on the field that gave us pause and then laughs like when running hounds crossed over to visit the adjacent field, luckily and thankfully without negative consequences. I especially enjoyed judging the Gillette Stake with Tom Golcher. Every run in that stake was great. But for me, the whippet inched out the others, with one impressive tight agility turn at full speed.

Special thanks to the lure operators and huntmasters who kept things moving and kept everyone safe. Congrats to all the hounds and handlers. Lure coursing trials truly "take a village." Good job ASFA for coming together to make this ASFA II so fun, safe and successful. And thank you for the opportunity to judge at such a great event. –Linda D'Antonio



Tom Golcher

I was asked to put a few words together to describe my ASFA II judging experience. First, it was an honor to be asked to judge ASFA's premier event. I have had the fortune of lure operating at three previous II's, but this is my first time judging one.

This was my second time on these grounds, and I have to say, as before, the fields were in perfect shape. We were blessed with good weather and quality volunteers at every position. The course plans were challenging enough for the hounds and the lure operators did a good job, for the most part, in keeping the hounds safe and honest.

On Saturday I judged 39 courses with a total of 83 hounds. Sunday was very similar with 38 courses and a total of 84 hounds. The only disappointment was the lack of entry numbers in most of the breeds. Field locations and facilities adequate for events as large as the ASFA II are a challenge to find. This is one of ASFA's major concerns, and individual clubs are having the same issue in their local areas.

I was also selected to judge the Gilette Stake on Saturday. What a privilege to participate in this stake judging so many excellent coursers. There were not a lot of points separating the top 4 positions.

It was also a pleasure getting to judge with Rich Whritenour for the first time. It is always very interesting to judge with someone for the first time and compare notes after it is done to find out that most of the time you both saw it the same way. There is sometimes a different viewpoint on the best hound on some of the courses. That is to be expected. Of course, the best hounds rise to the top and show off their talents when given a chance, even if it is a tiebreaker.

The ASFA II also gives us a chance to browse the perpetual trophy display. The only time that all of these meaningful and beautiful trophies are seen together. Looking at the names on the trophies and remembering many of them from past events is good for the soul.

Cheers to the 2025 ASFA II. It was a quality event, run on quality fields, and run by very talented volunteers. May ASFA continue to provide the best coursing venues where the best hounds have a chance to compete against each other.

LURE OPERATION by Denny Reed

At the risk of sounding like I have absolutely no humility left, I am taking this opportunity to offer praise to an often unrecognized yet essential part of the Field Committee: the lure operator. The fact that I am a lure operator has no bearing on this action. Honest. A lot of attention is focused on getting judges for a trial and how those judges will be compensated. But the lure operator's position is usually filled as an afterthought.

Many owners first examine the premium list to see who will be judging their dog and what kind of course that dog will have to run. It is seldom considered, though, that the lure operator can affect the judge's scoring and a specific course plan can make or break a particular lure operator. It is possible that a good lure operator can compensate for a poor course plan, while a poor lure operator can make judging



impossible. Have you ever made the decision to attend – or not to attend – a trial based on who the lure operator would be? I would like to proceed with a few observations on how the lure operator influences your hound's running performance.

Setting Up a Course Plan

While it may be the Field Secretary's job to submit the premium list to ASFA, it should be an experienced lure operator's responsibility to design the course plan that goes into that premium list. Knowing how the hounds run a course and how the equipment can handle a specific plan makes the lure operator an ideal candidate for designing plans. The lure operator would know, for example, that a plan can take advantage of terrain, or that terrain variations can completely ruin a fine plan (one that looks good on paper may not be good on the ground).

A good course plan is designed to properly use hills. A lot of people place pulleys at the top of a hill. This may <u>look</u> fine, but how does it affect the hound running such a course? The dog is probably running hard uphill. If the pulley is at the top of the hill it creates a turn, which allows the lure to disappear temporarily (from the running hound's point of view). Many dogs are unsighted because of poor pulley placement. They reach the top of the hill and oops! no lure. They may continue over the hill (this is when the gallery starts laughing) or just run around in circles at the top of the hill (this is when the judges start deducting points). Setting the pulley on the side of the hill will give the dogs a chance to see that the lure has turned.

The lure operator may want to use small, shallow ditches in the course plan, but experience indicates that these must be easily seen by the hounds. Ditches hidden by tall grass are especially dangerous, as are ditches which immediately follow a turn or lay at the bottom of a

steep hill. In each of these examples the dogs have no chance to prepare themselves for the change in terrain.

Obviously, designing the adequate course plan can only be accomplished by being at the course site while in the planning stage. At this time the lure operator can take into account obvious hazards to the hounds: that tree that is at the end of a turn, the fence that comes up at the end of a 200 yard straight-away, the corner caused by the barriers like fences, trees, and bushes, just where you had planned to put a turn. It doesn't take the lure operator long to learn how easily sighthounds cue off natural barriers while lure cursing – and run accordingly (commonly known as the LCM Syndrome).

One other consideration while planning a course: will it still be a good plan when you reverse it?

Preparing for the Trial

Naturally, the line pulleys, lure machine, control button, batteries, etc. are all inspected, repaired, and maintained well before the meet. (Experience has taught me that <u>well before</u> means more than 24 hours – sufficient time to order replacement equipment if necessary). The site should be inspected well in advance also; if the grass needs mowing, it should be finished before the day of the trial. For one thing, this allows enough time to mow the entire field, instead of just following a path. If mowing a path – wide enough to accommodate all the dogs in the course.

The course should be set up and ready to run by the time the draw order is completed, this usually means the lure operator is on the trial site at least one hour before roll call. After the course is set up it should be walked to be sure there are no rocks, wire, or other objects that would pose a danger to the hounds. Then the lure can be run around the course once to be certain the lure operator is in a good position to see the entire course. The test dog can be run next, giving the lure operator (and judges) a chance to see if there are any problems with the course as it was designed.

The experienced lure operator also learns that different pieces of equipment react in different ways: Some are fast and some are slower. Practice helps the operator know the equipment and know how to adjust the lure's speed to keep it 10 to 30 yards in front of the hounds while also considering how the plan is set up. Compensation must be made to the 10 to 30 yard rule, depending on the equipment, the course plan, and the breed running. For example, a 10-yard lead is inadequate for any breed at a corner. Particularly for Greyhounds, 30-yards is often inadequate (this is even more significant when the corner is preceded by a long straight-away). If the lure machine has an adequate braking system, the lead can be slightly increased in the turn, then the brake can be applied just before the turn to make the turn slowly. If there is no

brake – or a poor one — the lead must be enough so that the lure can be slowed down just before the pulley to avoid whipping the lure around the pulley and unsighting the dogs.

Running the Lure

Even experienced lure operators forget sometimes to pay attention to how well they can hear in their position on the field. If the lure operator can't see the judges and the huntmaster and isn't close enough to hear them, an assistant could be very useful. The assistant listens for commands from the huntmaster or judges, such as, "Stop the lure" and can then relay this information on to the lure operator – who is usually busy concentrating all attention to the hounds on the field.

All lure operators probably have favorite breeds and least favorite breeds, but the cutting dog has got to be the worst. The best thing to do is to run the lure for the lead dog that is not cutting. This is not always easy. If all three dogs like to




cut, it's anybody's guess which dog is still in the running at any given point. In this case, I just try to keep the lure as close to the dogs as I can, without letting them catch it. Then there's always the innovative Borzoi (known as the Dental Floss Syndrome on the East Coast), you know the type: the hound lays in the middle of the field right next to the string and waits for the lure to pass by. Practically the only trick that works is to be prepared to apply the brake and turn on the gas, zapping the lure right by the dog, if you are lucky. If the dog catches the lure anyway, injuries could result if the brake isn't used quickly.

Afghans are another problem. If they cut across the line, their long hair can get tangled in the string. The assistant can be helpful here, too, in case the lure operator is concentrating on the lead dog in the course and doesn't see the caught Afghan immediately. It is important to be aware of any changes in the way the lure is acting, this could be a signal that a dog is tangled. Zapping (making the lure go very fast all of a sudden) can get the lure operator out of some tight spots (when a dog is about to become tangled or trying to make a take). However, the zap can work two ways: It can make the lure operator look real professional, or look like a schmuck. The zap often puts the lead dog –the one that was running the lure honestly—at a disadvantage. It can put a dog that was previously out of the running, by cutting for example, right back in the lead. Or, it can prevent a possible injury by keeping the Afghan away from the string. The zap must be used with discretion.

Trying to prevent reruns is important. Reruns irritate owners and can be hard on the dogs. The lure operator develops a style to deal with the tricky sighthound: zapping the lure when a dog cuts and goes for the take, zapping the lure from the Afghan about to become entangled, enticing the hound that is losing interest in the lure—just about anything allowable to prevent a no-course.

The lure operator develops, also, an ability to listen selectively. The gallery must be ignored when the course is running. Owners watch <u>their</u> dog—not the entire course—and often shout out orders which would help their dog, but would perhaps cause a no-course to be called (due to poor lure operation). The lure operator has to watch all the dogs on the field and run the lure for the lead dog, while pursuing safety for all three dogs simultaneously. Owners often want the lure operator to speed up the lure if their dog gets ahead of it. This can happen when the dog in guestion has

been cutting a lot of course. But, again the lure operator's job has got to be to run the lure for the "lead" dog—and that is often the dog who is running honestly, even if the honest dog is not always physically in the lead.



Experience comes only with practice. At the next fun meet, try running the lure. Some people have a natural ability to be good right from the start, for most it takes a lot of practice time. Then, there are some who will never be good, no matter how much they practice. Don't give up too easily. I have had a lot of fun running the lure over the years. You're right in the middle of the action, you have one of the best views of the field, and if you feel neglected from time to time, you can always write an article in praise of lure operators.

A note from Richard Hawkins

The machine, pictured above, was built by Jan Hugenholtz, an engineer, some 40 years ago in the Netherlands. I bought it from him to lure-train my Deerhounds and Galgo in the open field for competition lure coursing. Jan Hugenholtz may well have been the first and oldest foreign member of ASFA. He was a great advocate of lure coursing, bringing ASFA judging to the Netherlands and Belgium. Thanks to him, I read every ASFA FAN (precursor of Communiqué) from its inception to the mid-1990s. FAN published Jan's article The Mini-Coursing Experience: Proven methods from the Netherlands, July/August 1989, that advanced the concept of all-breed lure coursing. I was closely involved in promoting lure coursing in the Netherlands from the early 1980s, when the sport was overshadowed by West European track racing, and much less hidebound by regulations and titles than it is now.

When I moved to Canada, I brought the machine with me as a keepsake and tool after living and working in the Netherlands from 1968 to 1998. --Richard Hawkins

THE HISTORY OF THE AMERICAN SIGHTHOUND FIELD ASSOCIATION (ASFA) 1972 - 1989

This article was written by Leigh Littleton for the First ASFA Historical Book based in part on Gary Roush's presentation to the 1982 Annual Convention of Delegates, titled "ASFA the First 10 Years."

In the late 1960's with open field coursing established in California, Lyle Gillette began to envision how one might simulate open field coursing in a way that would be usable anywhere in the United States. Lyle set off around California and the Pacific Northwest to sell his concept with a hand cranked machine and unlimited enthusiasm. His program was a success, and with the help of Tom and Betz Leone, Betty Blalock, Bud Pine, Nancy and Mike Oliver and others, the American Sighthound Field Association was born.

The ASFA was established on **May 21, 1972**. A set of rules for lure field trials was drafted, and officers were approved with Lyle Gillette as chairman. The rules allowed for mixed and breed stakes. The breed club hosting the trial could run a stake for its breed, but all other hounds had to run in mixed stakes. All hounds competed in the preliminaries, but only the better ones were advanced to the final course. Clubs could choose from four specified course plans; each includes a 100 yard time trap. The computed miles per hour of each hound were added to the judge's score. Blanket colors were red, black and white. All courses were run from a walking start.

The breeds originally recognized were Afghans, Borzoi, Greyhounds, Irish Wolfhounds, Salukis, Scottish Deerhounds and Whippets. Club eligibility was limited to breed clubs that had applied for sanction by the AKC and/or approval by its breed parent club.

Five field trails were held in **1972** with a total of 150 hounds competing. Thirteen field trials were held in 1973 with a total of 300 hounds competing. By the end of **1973** twelve hounds had completed their Field Championship. The Field Championship required 100 points and either one-first or two-second placements.

1974

A number of rule changes were made in 1974. The time trap and miles per hour calculation were eliminated, and course plan samples were changed from requirements to suggestions. NGA Greyhounds were made eligible for ASFA competition. Dogs could be permanently disqualified for fighting twice within the same calendar year. All-sight hound clubs could now be licensed to hold trials (although they were not eligible for membership).

1975

Now all hounds were to be run twice, in prelims and finals. Rather than mixed and breed stakes, Open and Field Champion stakes were to be offered for each breed; Best in Field was made available as an option. Course lengths were required to be within a minimum of 375 and a maximum of 880 yards. The title of Grand Field Champion was instituted and awarded for 4 – first placements and 300 points after completing the Field champion title.

In 1975 it was decided that NGA registered Greyhounds should no longer be allowed to compete. There were 76 field trials held this year with a total of 1,900 entries.

1976

Ibizan Hounds were recognized for ASFA competition and NGA Greyhounds were readmitted. The ASFA governing body was changed to a nine member Board of Directors elected to a two-year term of office. ASFA membership was extended to multiple-breed sight hound clubs. The status of multiple-breed clubs was of enormous importance at this time in the ASFA's history. The policy question was undoubtedly complicated by political divisions between the original, California-based, founders of the organization and newer enthusiasts from other areas. Gary Roush was one of those in the forefront of the negotiations that resulted in this policy change.

Blanket colors were changed to the current yellow, pink and blue. The previous 30 point judging category "Enthusiasm and Follow" was divided into two, with 15 points assigned to each. Judges were prohibited from discussing scores until their sheets were turned in to the field clerks. And, the Grand Field Champion title was dropped.

1977

Pharaoh Hounds were recognized for ASFA competition, bringing the number of approved breeds to nine. The Irish Wolfhound height disgualification (a minimum of 32 inches for dogs and 30 inches for bitches) was instituted.

The current system of interference disqualifications and reinstatements was established. The title requirements were strengthened; the 50% qualifying score minimum was established, and the Field Championship requirement was increased to 2 - first placements or 3 – second placements – with competition. The Lure Courser of Merit title was instituted with the same requirements as the former Grand Field Champion, except that the conditions could only be met by competition within the Field champion stake. In addition, Field Champions were now prohibited from competing in the Open Stake. The ASFA titles of Dual Champion and Dual Titlist were instituted.

Licensing of judges was approved as an experiment controlled by the Board of directors. Regional Invitationals were established: the winners were to be eligible to compete in a "Continental Invitational".

There were 170 field trials held in 1977 with a total entry of 8,300.

1978

The ASFA Constitution and By-Laws were substantially revised. The revision included the addition of eight Regional Directors to the ASFA Board.

A continued phase-in of licensing of judges was approved. Rules revisions included the requirement that judges stand at least 10 feet apart and not converge until their score sheets were turned in. The Field Clerk was prohibited from changing any judge's score. Mid-course direction reversals were allowed if published in the premium list. A hound could be excused if it failed to run in either prelims or finals.

The first ASFA International Invitational was held in Carbondale, Illinois with a large entry and a great deal of rain. The ASFA was incorporated as a non-profit organization in the state of Colorado.

There were 227 field trials held in 1978 with a total entry of 8,700 hounds.

1979

Until this time, potential changes in the running rules had been raised at each convention, with discussion and revision being essentially unlimited. Starting this year, a rules conference, made up of the Regional Directors, reviewed proposed changes in advance. Those rule changes approved by the rules conference were presented to the Annual Convention of Delegates and voted upon without debate. This change provided a large increase in order at the Annual Conventions, together with a large decrease in interest. Rule changes approved at the 1979 convention included the elimination of mixed stakes.

The Basenji Club of America requested that Basenjis be recognized by the ASFA. The Convention referred this to the member clubs for a mail vote, and Basenjis were recognized in the fall of 1979.

In 1979 there were 231 field trials held with a total entry of 8,800 hounds.

1980

In 1980 for the first time, the ASFA Board had to investigate allegations of a serious infringement of the running rules. The resulting controversy occupied most of the energies of the Annual convention.

There were 244 field trials held in 1980 with a total entry of 10,010 hounds.

1981

The constitution was amended to provide a defined procedure for the recognition of additional breeds by the ASFA. A procedure was adopted for future rule changes whereby they would be submitted directly to member clubs for a mail vote.

Rule changes adopted by this convention under the previous procedure, included allowing the option of scheduling one rather than two judges for a breed. This use of one judge for a breed was given a two-year trial period. The lure operator was required to be the same for an entire stake, and was prohibited from running the lure for any dog he owned. Judges were now allowed to excuse hounds that coursed other hounds rather than the lure in cases where there was no actual interference. Judges licensing was fully implemented as part of the running rules. The minimum course length was raised to 500 yards, with at least 600 yards recommended.

In 1981 there were 262 trials held, with a total entry of 10,285 hounds.

1982

In the first year of ASFA's second decade, Mr. James Crowley of the American Kennel Club attended the Annual Convention of Delegates, with the possibility of AKC recognition of lure coursing the topic of discussion.

After extended research into the process of recording and publishing field trial results, a committee began work on the process of automating the ASFA's recordkeeping. (As it turned out subsequently; we were ahead of our time, the records were satisfactorily computerized, but the inexpensive computers then available simply did not have the power to make computerized trial recording practical).

It was decided that the ASFA should follow the AKC's corresponding date table, with exception for certain holiday weekends, in determining dates for which clubs held priority in succeeding years. Clubs were restricted to scheduling no more than four future weekends at any one time. The requirements for ASFA affiliation and membership were reviewed and refined.

1983

The Annual Convention approved the single judge option as a permanent feature of the running rules. The Convention referred to the rules evaluation subcommittee (with positive recommendation) a proposal to delete the Irish Wolfhound height disqualification from the rules. This issue was to resurface each year or two until 1989, when it finally passed. Consideration was given to publicity, as well as to methods of encouraging clubs to broaden their exhibitor base.

The major item of business at the convention was the definition of a proposal to be sent to the AKC, indicating the basis on which the ASFA would agree to incorporation of the ASFA system of lure coursing as an AKC program. Mr. Crowley of the AKC was again present for this discussion.

1984

Consideration of AKC recognition of lure coursing was dropped due to lack of response from the AKC. The Convention approved a procedure whereby selection of Convention sites would be made two years in advance.

The ASFA hosted a booth at the AKC Centennial Show in Philadelphia, Pennsylvania, which generated a great deal of interest.

There were 286 field trials held in 1984, with a total entry of 10,656 hounds.

1985

A committee was formed to investigate publishing of an ASFA Historical Book, (printed in 1991). The annual judges licensing fee was dropped, but an application fee was instituted.

The procedure previously implemented for revising the running rules proved to be a dismal failure – unless one was of the opinion that no changes should ever be approved. Consequently, the Convention approved a change to the procedure: rule change proposals that had been properly processed and published would now be voted on by the Annual Convention, rather than by a mail vote of the member clubs.

Over the years, a few positions had been changed from volunteer to paid status, Records coordination and the <u>Field Advisory News (FAN)</u> editorship, in particular. The 1985 Convention established a policy that no member of the Board of Directors would be paid for services rendered.

This year there were 338 Field Championship and 58 Lure Courser of Merit titles awarded by the ASFA.

1986

A committee was established and a budget approved, for advertising lure coursing. The advertisements were to appear in nationally distributed dog publications.

Guidelines for Field Secretaries, Field Clerks and Field Chairmen were published, in addition to the previously available guidelines for judging and for practices. The consecutive terms of office of Regional Directors were limited to two, as had already been the case for officers.

Following continued informal discussion with the AKC, a committee was appointed to further investigate possible AKC recognition of lure coursing.

1987

The 1987 Convention was extremely well attended. Although this may have been partially due to a few people's desire to party in New Orleans, it was primarily the result of one item on the agenda: a small but dedicated group had proposed a rule change whose effect would have been to remove Basenjis from the list of breeds recognized by the ASFA. The proposal lost

resoundingly, but did have the beneficial effect of bringing many people to the Convention who might not have attended otherwise.

A committee had been formed to write guidelines for lure operators. The committee reported to the convention that it had agreed on the importance of guidelines and that the lure operator should run the lure safely and not unsight the dogs. Other than that, the various talented lure operators on the committee could not agree on anything! It was decided to publish a questionnaire and continue the effort.

The rules were changed to credit a hound winning Best in Field with a first placement toward its next ASFA title, if it had not had competition in its stake. The Top Ten rating system originated by Michael John Bowen was recognized as an ASFA system, with the official Top Ten in each breed to be published each year.

1988

During 1988 and 1989 the ASFA investigated going to an outside firm to either (1), provide a computer program that could then be used by ASFA personnel to record trials, or (2), do our recordkeeping as a paid-for service. The conclusion was that, given cost factors, we would continue our incremental approach to improving our manual system.

A system was devised whereby the International Invitationals would move around the country on a regular basis. After an extra year of effort, the lure operator's guidelines committee was able to agree on enough issues to come up with a preliminary document to circulate in FAN. Guidelines for club delegates and for Regional Directors were also distributed.

There were 324 field trials held in 1988, with a total entry of 13,219 hounds.

1989

After several years of effort, a list of all current policies and rule interpretations was compiled and distributed to all clubs. Provisions were made for a yearly update of these policies. Also, after many years of effort, an ASFA video was completed and available for distribution.

Two very significant rule changes were made this year. First, the "Singles Stake" was approved; competition for unproven hounds, in which they run alone, get no ASFA points or placements, but are recorded and published by the ASFA. This stake provides an avenue for owners of hounds that have trouble finding available practices. Also, the "LCM" infinity" title was approved; after completing an LCM, repeating the same requirements will earn the hound an LCM II, and so on for LCM III, IV, etc. (requirements already met to be grounds for retroactive titles). Availability of these additional titles gives the owner of good coursing dogs a structured basis for additional competition beyond the Lure Course of Merit.

It was decided that the funds being spent on the advertising campaign could, at this point, be better used on an effort to improve the quality and uniformity of field trials. It appeared that we had reaped as much benefit as we could currently expect from advertising and now needed to work harder on retaining our clientele. The quality improvement effort was to result in additional major decisions in 1990 and following years.

The ASFA Scheduling Committee

The Scheduling of lure field trials was originally done by Nancy Oliver followed by Bud Pine. As the number of field trials increased, the title of Scheduling Chairman was created; the position was filled by Royce Northcott. With the number of trials continuing to increase the responsibilities were divided – Kathy Budney became the Eastern Chairman and Gary Roush became the Western Chairman. Daphne Lowe replaced Gary Roush in the West for a period. And then Kathy Budney volunteered to handle scheduling for the entire country, so the East and West Chair positions were combined. In 1982 Camille Mendicino replaced Kathy, followed by Ariel Duncan from 1983-1987. Jan Priddy became Chairman in 1987 and was followed by Jan Schreiber from 1988 to present. Under the last few chairmen the Scheduling Committee has typically included one of the previous Chairmen plus some other Board member, in addition to the current Chairman. Such a committee has been valuable for providing the Chairman advice on policy questions as well as providing continuity across changes of Chairmen.

THE HISTORY OF THE AMERICAN SIGHTHOUND FIELD ASSOCIATION – 1990 - 1994

Although five years may not seem like a long time, in the history of the ASFA it is almost 25% of our total existence and changes took place which affected the running of our hounds and the face and structure of the organization. Our objective here is to give you the highlights, as it were, to changes during this time.

Uniformity, or the lack thereof, in the running of field trials has been viewed with concern for a number of years. This led to the formation in <u>1990</u> of a Trial Improvement Committee, and then to the position of Field Trial Representative, the purpose being to report on the quality of our events, conformity to the Running Rules and bringing to the whole fancy new ideas and suggestions for the smooth running of the events. Our first Field Representative was Gary Forrester. This was then expanded to two Reps, East and West. This program was generally well received, even though the term "ASFA spy" was a popular expression. By 1994, evaluation of trials was the responsibility of Regional Directors, who also had access to more funds for the promotion of the sport. The Reps were requested by the Regional Directors or the Committee to evaluate "troubled" areas.

As Always, new policies appeared and, at times, it was difficult to sort them out. All policies were totally reviewed and updated on a yearly basis, divided into operational and administrative policies.

The work on lure operator seminars and a video was begun and finally culminated in a lure operator video in air. The development of a lure operator certification system was developed and is being evaluated for implementation.

The Lyle Gillette Stake and Trophy was finalized and awarded for the first time at the 1990 International Invitational. Hounds entering this stake had to meet a number of requirements: an ASFA Field Champion, and AKC or foreign country bench Champion, had to have accumulated 20 points in the previous year and be the high scoring hound of its breed on Saturday at the I.I.

Two other events occurred in 1990: Rhodesian Ridgebacks approached the ASFA for recognition and an ASFA "Introduction to Lure Coursing" video was produced.

In <u>1991</u>, the American Kennel Club announced the creation of a lure coursing program. This caused a great deal of activity regarding interaction between the ASFA and the AKC, both strongly pro and con and, of course, neutrality. At present, there are discussions between the two groups.

The ASFA Historical Book was available that year and a new committee for public relations was created. The committee established an annual top hound award from each of the parent clubs and was first awarded at the 1992 Annual convention of Delegates. Also in 1991, the Rhodesian Ridgebacks were awarded provisional status. Per capita was increased by \$1.00-to help offset costs of the Trial Improvement Committee.

In <u>1992</u>, a lengthy survey went out asking the fancy how they felt about the present state of ASFA and what changes they would like to see. Since that time, a number of other surveys have been done. From these a number of projects and rule changes were proposed. A Long-Range Planning group was formed to help our direction beyond the immediate future.

At the 1992 ACoD, the first Gary Forrester Achievement Awards were presented. The recipients were Lyle Gillette and Betz Leone. The purpose of the award is to give recognition to individuals who have made a significant impact on the sport. What two better enthusiasts to receive the first presentation! Sadly, it was not long after this that both of these founders of our organization passed away.

The First Field Representative report was given that year, and many new and innovative ideas were presented. The Rhodesian Ridgebacks failed to gain full recognition, however, their provisional status was extended for another year. At this ACoD, the AKC responded to questions put to them. Chief among the responses were: the ASFA will have no active role in AKC lure coursing, except for the influence of individuals and ASFA clubs holding events and, conversely, the AKC will take no role in the ASFA program.

In <u>1993</u>, as noted before, Regional Directors had expanded duties of trial evaluation and an increased budget. Anything done by them to promote, improve, inform and enlarge the sport had total support (within reason, of course!). Now we were beginning to see the development of new activities, seminars, lure operator training, regional competition and increase public relations both on and off the field.

After many years of waiting and hoping, a computer program was in place for records, thanks to the efforts of Camille Mendicino and Rick Brown. This program expands constantly, recording trials, Top Ten, Awards and Certificates, compiling judges' trial assignments and more.

A "Bad Call" policy, as proposed by Judges Licensing, went into effect. The purpose is to make sure that excusals, dismissals and disqualifications by judges followed the Running Rules. This has been very successful and effective. There are some times you don't want to see your name in print.

Other events in 1993: Rhodesian Ridgebacks were given full recognition and became the eleventh breed in the ASFA. The Novice Stake was incorporated into the Singles Stake. An improved procedure for the running of provisional breeds was instituted. The ACoD put a high priority on the development of a method to pre-qualify hounds, to be instituted in 1994. Interest was shown in splitting two Regions and re-structuring the Board of Directors.

In <u>1994</u>, all fines on individuals and clubs were discontinued excepting late receipt of records. In place of this, clubs had an ascending scale based on three or more significant errors. The mere fact it would be published, and could lead to possible suspension of the ability to hold trials, can be quite an incentive to double check the records before sending them off.

Interest was raised for the running of a miscellaneous class of those sighthounds recognized by the FCI. They would compete among themselves based on size. No ASFA points would be awarded. This could eventually take the place of provisional status for new breeds.

A certification requirement went into effect in 1994. This meant a hound must run cleanly with another hound and complete a course under the evaluation of a recognized judge prior to entering their first trial. The exceptions were if the hound had run with other hounds in another recognized organization and were titled by that organization. After years of discussion, the Veteran Stake became an optional, but regular, stake offered at trials.

Through this time the Field Advisory News continued to expand and improve under the watchful eye of the editor, Vicky Clarke. More information was put out in a more timely fashion, articles increased and records and schedules were more up to date.

As this is going to print in 1995, more changes are in the making. It will be interesting to see what the next addendum has to say about the American Sighthound Field Association and the sport of lure coursing.

THE HISTORY OF THE AMERICAN SIGHTHOUND FIELD **ASSOCIATION - 1995 - 2000**

As we move into the new Millennium, we find the ASFA continuing to hold its own true course as the premier lure coursing venue in the world. We have faced many challenges since the last historical book addendum went to print. We have met those challenges. We have seen too many wonderful ASFA supporters and great running g hounds lose their lives too soon. We have witnessed new, strong and enthusiastic supporters entering the ASFA along with new outstanding running hounds. The ASFA is bigger than any one person or group of persons. Every club proudly has an equal voice and the right to express opinions no matter how diverse. The clubs continue to control this organization and the direction it takes.

Here are the highlights:

The 1995 Annual Convention of Delegates (ACoD) was held in Phoenix, Arizona. There were 54 voting delegates. Following the AKC's creation of a lure coursing program in 1991, the ASFA's statement of purpose was changed to eliminate any reference to obtaining AKC recognition. Requirements for maintaining Member status were tightened by requiring Member clubs to hold trials every two years rather than every five years. After years of debate, two additional regions were approved by splitting Regions 2 and 8. Region 2 consisted of Northern California and Nevada, with the new Region 10 consisting of Southern California, Arizona and Hawaii. Region 8 continued to include New Jersey, Pennsylvania, Delaware, Maryland, Virginia and West Virginia. While the new Region 9 consisted of New York, Connecticut, Rhode Island, Vermont, New Hampshire, Massachusetts and Maine.

The Field Trial Regulation Committee changed its name to the Field Trial Improvement Committee. New Miscellaneous Classes were approved which offered the first coursing venue for the rare sighthound breeds in North America. The initial approved breeds were the Azawakh, Chart Polski, Galgo Espanol, Italian Greyhound, Magyar Agar and Sloughi. Combined premium lists were approved allowing clubs to submit one premium list per weekend. Written tests covering

knowledge of the running rules were approved for all apprentice judges wishing to


move to provisional status.

Rick Brown was presented with the Gary Forrester Award for the development of ASFA's computerized record system.

In 1996, Houston, Texas hosted the ACoD with 60 voting delegates. ASFA boasted 130 clubs this year and ran 17,087 hounds the previous year.

ASFA affiliation was opened to the first foreign country with the approval of the Greyhound Club of Canada's application.

In keeping up with the times, the ASFA web site was introduced. It included the names, addresses, phone and e-mail address of all Board members, Regional Directors and key chairs, the trial schedule, Frequently Asked Questions, a FAN subscription form, and a breed standards link to the AKC home page. Every Board member, Regional Director and key chair has Internet access. Technology has transformed the way we operate. It enabled us to increase communication between Board members and with the fancy, as well as improve the timeliness of our responses. This was and will continue to be an investment in ASFA's future.



The ASFA Hall of Fame proposal was approved, and a constitutional revision passed, allowing experimental programs. The state of Nevada was divided with Region 2 taking Nevada north of highway 6 and region 10 taking Nevada south of Highway 6. Huntmasters were now allowed to notify the judge(s) of any occurrence at the beginning or end of a course that might be grounds for excusal, dismissal or disqualification.

The Gary Forrester awards went to Denise Como and Richard Whritenour for their work with school children, and Kathy Budney for her long and influential tenure on the Board.

The **1997** convention was held in Charlotte, North Carolina. There were 56 voting delegates.

ASFA's total clubs dropped to 125 due to the more stringent membership requirements implemented in the previous year. The Running Rules and Field Procedures for Lure Field Trials was added to the web page. Work began on the "How to Put on a Field Trial" book.

In celebration and recognition of ASFA's 25th Anniversary, limited edition gold and silver pendants and a new line of wearables were developed.


The Convention approved giving lure operators the same status as the huntmaster in notifying judges of any occurrence that might result in an excusal, dismissal or disqualification. Breed Singles stakes changed to one Mixed Singles stake with placements awarded across breeds. The Animal Legislation Awareness Committee was formed.

The Forrester Award was not presented that year.

Sacramento, California hosted the <u>1998</u> ACoD with 53 voting delegates. Total clubs again rose to 130 and entries for the previous year were up to 18,861 at 407 trials.

Many changes were in the works for the International Invitational. The fancy wanted more involvement in the form of both personnel and financial assistance from the Board of Directors. As a first step, standardization of I.I. trophy discussion began.

The rulebook was re-indexed for the first time in many years. The new breed recognition proposal was accepted, which combined elements from the new Miscellaneous Class with the old methods of attaining new breed recognition. The first individuals and hounds were inducted into the ASFA Hall of Fame.



Once again, the Statement of Purpose was changed. It was approved to drop "throughout the United States," thereby allowing the ASFA to pursue increased assistance in the establishment of lure coursing in other countries. For the first time, the ASFA Board of Directors was given the authority to prefer charges against any individual or club for alleged misconduct prejudicial to the best interest of ASFA or any and all breeds of sighthound.

The earlier attempt to certify lure operators was dropped as unworkable. However, the development of a coordinated program of Lure Operation Training seminars and education was referred to the Regional Directors.

The Forrester Award went to Leigh Littleton, past ASFA President, 1st Vice President, 2nd Vice President and Corresponding Secretary.

In 1999, Minneapolis, Minnesota was the Convention site with 61 voting delegates. ASFA had 121 clubs that year.

In response to continued pressure from the fancy, the Board began taking a more active role in planning and conducting International Invitationals. The Board purchased permanent I.I. banners in 1998. An International Invitational Planning Guide was developed to assist future I.I. chairs in holding I.I's. The first standardized trophies were distributed at the 1999 I.I. with full standardization occurring at the 2000 I.I.

For the first time in many years, per capita fees were increased by \$1.00 per entry to \$4.00 for regular trials, \$5.00 for Regional's and \$6.00 for International Invitationals. The increase was essential to offset the increased expenses of records computerization enhancements, web site management and further development, financial assistance to the I.I's and the increased cost of doing business. The increase in per capita also made it possible for anyone, regardless of personal income, to become a member of the Board or a Regional Director. ASFA began paying all hotel and transportation cost associated with attending Board of Directors meetings.

Yet another change in the boundaries for Regions 2 and 10 was approved, further defining the division of California by county designations. This time, we think we got it right. The term "flight" was introduced to help define split stakes. Requirements for judges licensing were increased to require participation in the sport for a minimum of three consecutive years during which time the applicant has served at ten or more field trials. Additionally, all judges' forms requesting changes in status must be submitted within a three-year span of time.

The Azawakh, Sloughi and Italian Greyhound were granted provisional status effective January 1, 2000. The Peruvian Inca Orchid and Cirneco dell'Etna were added to the Miscellaneous Class.

For the first time since the AKC began offering its own brand of lure coursing, they requested discussion on the merging of the AKC and the ASFA programs.

The Coursing-in-a-Box program was completed and included various levels of information and assistance for foreign countries interested in the formation of their own lure coursing programs.

Marie Adams, well-respected judge and chair of the Judges Licensing Committee was presented with the Gary Forrester Award.

Baltimore, Maryland hosted the **2000** convention. An amazing 92 voting delegates attended, representing ASFA's 121 clubs.

The ASFA website continued to grow with official forms and policies added. Plans to add hound histories and judges' histories began. By popular demand, ASFA continued to offer new designs for wearables.

The first Miscellaneous Class foundation title certificates were awarded. Miscellaneous Class Field Champions and LCMs would now be earned from this class. The new Teen Lure Coursing program was approved. An experimental program to allow host clubs the option of running certain breeds in braces rather than trios was approved. Placements toward a Field Championship and LCMs could now be earned from the Veteran Stake.

The AKC sent a letter proposing a merger with the ASFA. Seventy-one ASFA clubs responded to a mail poll of all club delegates. An overwhelming 96% were against the merger as proposed by the AKC. Seventy-nine percent (79%) directed the Board to cease any further discussions of a merger.

Wes Shainline, long-time coursing enthusiast from Region 8, and Camille Mendicino, retired and beloved Records Coordinator, were presented with the Gary Forrester Award.

The American Sighthound Field Association remains a strong and independent organization. Its Board is committed to fair, honest, consistent governing. The Regional Directors have become a powerful force. They work together as a cohesive group and have been responsible for man of the new programs noted earlier. We have set high standards for the Board and those standards have been met and raised. We have accomplished a lot in the past six years. Trial procedures are more uniform, requirements for membership in the ASFA are consistently and fairly administered, education of lure operators, judges, huntmasters and trial secretaries has improved. But, let's not just celebrate our progress, let's continue to advance it.
