Official Results: New Regional Directors for Regions 8 and 9

You may recall that Regions 8 and 9 were holding Special Elections for their vacant Regional Director positions. Under Administrative Policy A-ELECT05, a candidate in a Special Election may take office as soon as he or she receives a majority of votes. **Wright** received more than half of the possible votes from the region, and was therefore the new Regional Director for Region 8. Requesting Trial Dates and Premium Submissions

- Debb Meyer, ASFA Scheduling Chair Some helpful information for requesting Trial Dates and Premium submissions.

I realize that it has been confusing with the changeover to a new ASFA Scheduling Chair. My learning curve, and the number of us (me included) who always sent our requests and premiums directly to Denise's email,



has at times caused delays. I also realize that my having a full time job outside of ASFA, as well as competing often with my hounds, can cause a longer turnaround time than some are accustomed to. I am not able to routinely respond to personal email or calls during the week between 7 am Central Time until at least 7 pm Central Time.

My goal is to get date requests and premium lists in, approved, and back out – to keep the process flowing. The form for requesting Trial dates is on the ASFA

website, under the heading 'Field Trials'. The link

is: <u>http://www.asfa.org/trial_date_request.htm</u>.

We may be making some changes to the form as we update the website, but we will keep everyone updated when that happens. For now it is very important that the form be used, as the fields on it give us all the information we need to enter the trial into the schedule. If you have questions about the form, please feel free to contact me. Currently the schedule is updated online monthly, so it can take some time for your trial to appear on the website. Please request your dates early so everyone can make their travel plans.

When submitting your premium for approval I could use some help. I am receiving premiums that are intentionally incomplete, as Judges, locations, course plans, etc. are not confirmed. I cannot approve



an incomplete premium. [continued on page 3]

Conditional Entries

It has been brought to our attention that occasionally a club will hold a certification run on the morning of a trial. If this certification run is held after the close of day of trial entries, the newly certified dog is not eligible to run. To prevent this, it's best to a voice mail or text please give me your name, club name, and a phone number to call back.
