

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhound, Whippets. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

STAKES OFFERED:

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE: Any ASFA Field Champion

VETERAN STAKE: Any eligible hound whose age is at least 6 years, except Irish Wolfhounds, whose age shall be at least five years, and Afghans, Rhodesians Ridgebacks, Salukis, Whippets whose age shall be at least seven years.

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

LIMITED STAKE: Any eligible sighthound of a Limited stake breed that has met certification requirements.

Best in Field will be offered.

CONDITIONS OF ENTRY:

- All entries must be one or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- Spayed, neutered, Monorchid or cryptorchid hounds without breed disqualifications may be entered.
- Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Hounds not present at the time of roll call will be scratched.
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

ADDITIONAL INFORMATION:

- Muzzles are not required. It is the responsibility of the owner to determine if their hound needs to be muzzled.
- Lure machine is battery powered, continuous loop. Back-up equipment is available.
- The lure will consist of highly visible plastic strips.
- A fee of \$20.00 will be assessed for any returned checks.
- There will be a \$5.00 fine for any loose hound on the field that is not part of the course in progress.
- Course will be reversed for finals.
- Persons exhibiting conduct detrimental to ASFA/TSA/any hound(s)/other person(s) will be asked to leave the trial site.
- Hound Certification runs will be offered.
- Due to the fact that this trial is held in conjunction with a dog show, breeds should be ready to run approx. 30 min after BOB is judged.

Fees are payable by cash, check, or money order. Foreign checks are not acceptable.

Please make checks/money orders payable to TSA.


First time entered dogs must have a copy of their registration paper and the completed ASFA certification form or waiver form to send to ASFA with the entry form(s). Unless these two additional documents are presented at the time of entry, the entry will not be accepted.

Single stake entries do not require an ASFA certification form.

HOUND CERTIFICATION

Rule effective October 1, 1994: Ch. V, Sec. 4 (a) OPEN STAKE: To be eligible to enter the open stake, a hound must have been certified by a licensed judge within the year preceding the closing date for the entry or have previously competed in the Open Stake. This eligibility requirement also applies to a hound entered in the Limited or Veteran Stake, which has not competed in Open previously.
