Only purebred whippets may be entered. All entries shall be individually

registered with the AKC, FCI, UKC or an ASFA recognized foreign or an ASFA approved registry. For first-time ASFA entries, a photocopy of the Whippet's individual registration form from an acceptable registry and a completed and signed ASFA Certification or Waiver form must be submitted with the entry form. **YOUR WHIPPET MUST CERTIFY PRIOR TO THE CLOSE OF ENTRIES.**

TRIAL STAKES OFFERED

OPEN STAKE: Any eligible whippet excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE: Any ASFA Field Champion whippet.

VETERAN STAKE: Any eligible whippet whose age is at least 7 years. Points & placements go to a V-FCh. or V-LCM title.

SPECIAL STAKES

KENNEL STAKE: For two whippets, designated at time of entry, in one of the regular stakes being owned and kenneled by the same person.

BREEDER STAKE: For two whippets, designated at time of entry, bred by the same individual.

Conditions of Entry and General

1. All entries must be one year or older on the day of the trial.
2. The entry of each hound entering the Open or Veteran Stake for the first time MUST include a completed & signed ASFA Certification Form or Waiver Form (with proof of title) AND a copy of the hound's registration certificate. (certification is waived for Single Stake entries only)
3. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. The Stake Split will be done at the Trial Site on Saturday, April 20, 2013 at 6:30 pm.
4. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
5. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
6. Hounds not present at the time of roll call will be scratched.
7. All hounds will run twice, in trios if possible or braces, unless excused, dismissed or disqualified.
8. Bitches in season and lame hounds will be excused. Entries will be refunded.
9. A \$5.00 fine will be assessed for any loose hound on the field that is not competing in the course in progress
10. Battery powered, continuous loop equipment will be used. Lures consist of white plastic
11. Back-up equipment will be available
12. AWC reserves the right to alter the course due to field and/or weather conditions on the day of the trial
13. Course will be reversed for finals. Direction for run-offs and BOB will be at the discretion of the judges.
14. The field is fenced
15. Bring your own shade and water

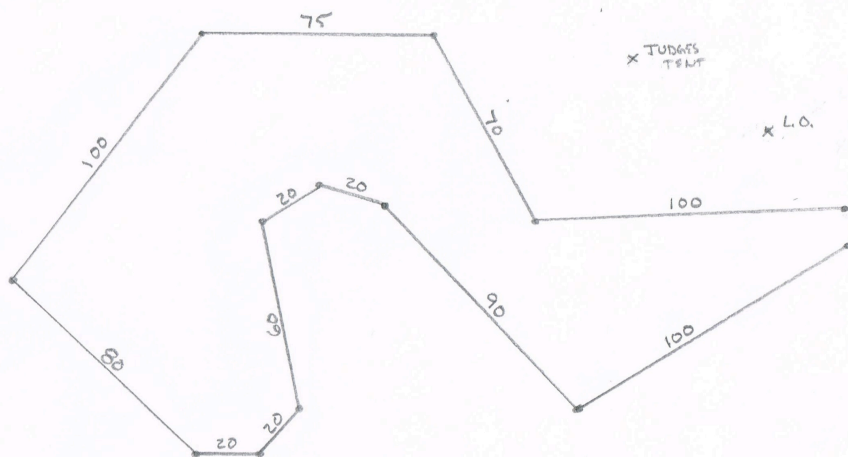
