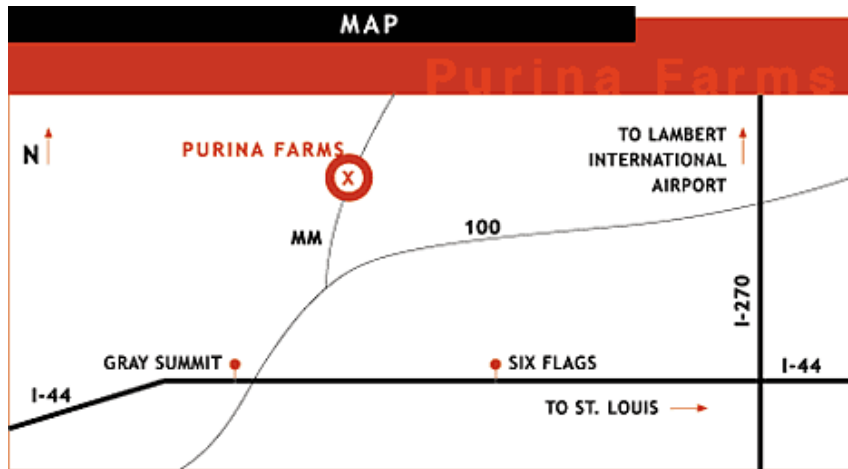


## Directions to Purina Farms



### From St. Louis or Springfield, MO

Take I-44 to the Gray Summit (Highway 100) exit. (About 20 miles west of I-270/St. Louis). Go north on Hwy 100 until you spot Hwy MM and the Purina Farms sign (approximately 1/2 mile). Turn left onto Hwy. MM and drive about 3/4 mile until you reach the Purina Sheep and Cattle Barns on your left and a silo on the right. Turn left to the cattle barns and Field is located right behind the barns. If you find yourself at the main visitors' gate for Purina Farms, you have gone too far.

### From Kansas City

Take I-70 east to the Warrenton exit at Hwy. 47. Go south on Hwy. 47 for approximately 25 miles until you reach Hwy. 100 in Washington. Turn left onto Hwy. 100 and continue to I-44 (approximately 10 miles). Go east on I-44. Follow the directions above from Springfield.

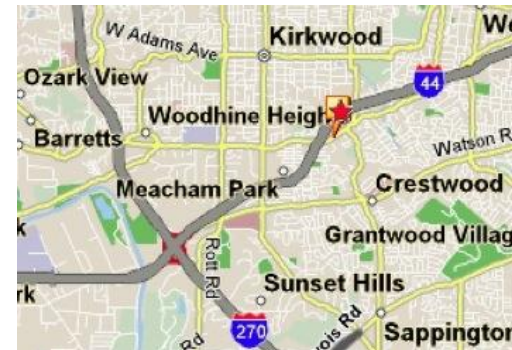

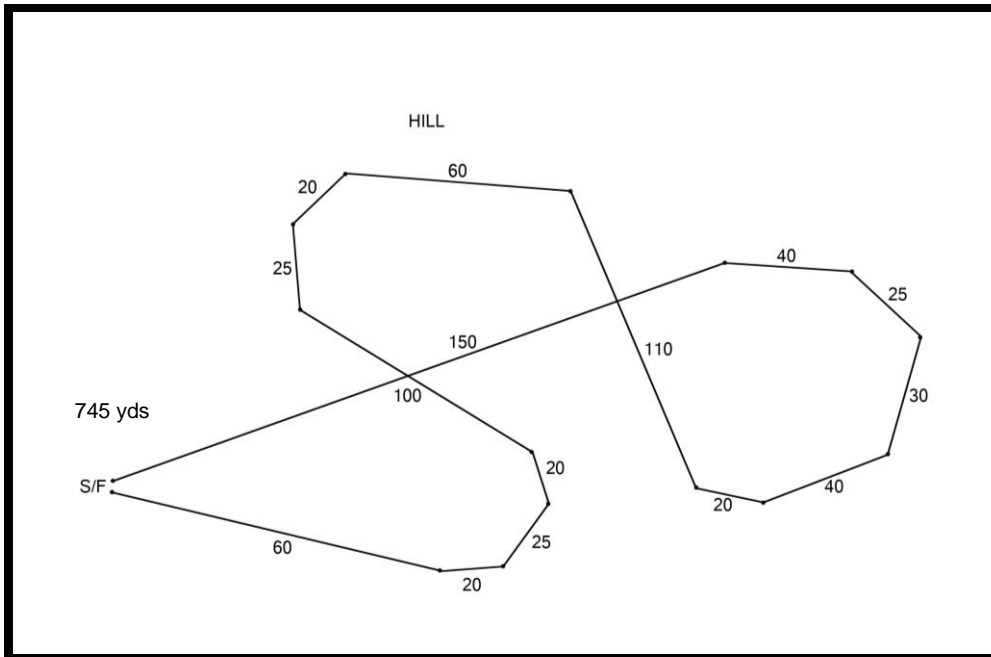

### Regular Stakes Offered

<b>Single</b>	Any eligible basenji including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake.
<b>Open</b>	Any eligible basenji that has met certification requirements, excluding ASFA Field Champions of record.
<b>Field Champion</b>	Any ASFA Field Champion.
<b>Veteran</b>	Any eligible basenji that has met certification requirements whose age is at least six years.

### Additional Stakes Offered

<b>Kennel</b>	Open to 2 entries owned by the same person and kenneled together. Must be indicated on entry. NOT RUN AS A SEPARATE STAKE.
<b>Breeder</b>	Open to 2 entries bred by the same person. Must be indicated on entry. NOT RUN AS A SEPARATE STAKE.
<b>Bench</b>	Open to AKC bench champions of record. Must be indicated on entry. NOT RUN AS A SEPARATE STAKE.

### Eligibility Requirements

Only purebred Basenjis may be entered in the regular stakes. All entries in the regular stakes shall be individually registered with the AKC, the UKC, an ASFA-recognized foreign or ASFA Board approved registry. Dogs with an Indefinite Listing Privilege (ILP) or a Purebred Alternate Listing (PAL) from the AKC shall be considered registered with that body.

Incomplete, unsigned, conditional, or late entries WILL NOT be accepted. Entry forms by minor owner/handlers (under the age of eighteen years) must be signed/co-signed by a parent or guardian. BCOA will not be responsible for accidents at this trial. **ENTRIES WILL NOT BE ACKNOWLEDGED BY MAIL.** Substitutes for lame or in-season hounds are allowed if substitute has same owner and the Field Secretary is notified at least one hour prior to roll call. The name of any substituted hounds would not appear in the catalog, if catalogs are offered.

Any entry marked "First Time Entry" must be accompanied by a completed ASFA hound certification form (not required for entries in the Singles Stake). A photocopy of acceptable registry must be submitted with a hound's first ASFA field trial entry.

- All entries must be one year of age or over on the day of the trial.
- Stake will be split if the entry in any one stake is 20 or more hounds at the time of the draw.
- Bitches in season, hounds with breed disqualifications, and lame hounds will be excused.
- Hounds not present at roll call will be scratched.
- Monorchid, cryptorchid, spayed, or neutered hounds may be entered.
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- Muzzles are not required. It is the responsibility of the owner to determine if their hound needs to be muzzled.
- Lure machine is battery powered, continuous loop. Back-up equipment is available.
- Lure will consist of highly visible plastic strips.
- A fee of \$20 will be assessed for any returned checks.
- There will be a \$5 fine for any loose hounds on the field that is not part of the course in progress.
- There will be a \$15 fine for any owner/handler who does not clean up after their hound.
- Course will be reversed for finals and again for run-offs and Best of Breed..
- Persons exhibiting conduct detrimental to ASFA/BCOA/Purina/any hound(s)/other person(s) will be asked to leave the trial site.
