Trial Hours:

Check-in for dogs belonging to the field committee will begin 30 minutes before published trial hours.

Monday, September 1 – "Day of" entries close at 8:30 am. Roll Call at 8:40 am – Draw at 8:50 am with trial to start immediately after the draw.

Certification runs will be offered before the trial for dogs planning to enter this trial. Dogs not entering this trial may certify after the trial completes. The handler presenting the Qualifying Hound shall be responsible for providing the Testing Hound for the qualifying course.

Entries will not be acknowledged by mail or telephone.

Late, incomplete, unsigned or conditional entries will not be accepted.

List of Breeds Eligible to Enter:

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, Whippets, and Provisional breeds may be entered in the regular stakes. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

Stakes Offered:

OPEN STAKE – Any eligible sighthound, excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE - Any ASFA Field Champion of record.

VETERAN STAKE – Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

LIMITED STAKE – Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLE STAKE – Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

Conditions of Entry:


- All entries must be one year or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- All hounds will be examined at inspection for breed disqualifications.
 Spayed or neutered hounds <u>MAY</u> run.
- Hounds not present at the time of roll call will be scratched.
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- Hound certification runs will be offered before the trial for dogs planning to enter this trial. Dogs not entering this trial may certify after the trial completes. The handler presenting the Qualifying Hound shall be responsible for providing the Testing Hound for the qualifying course.
- Any hound that displays aggressive behavior during trial hours will be excused for the day.
- A penalty of \$5 will be assessed for any loose hound not competing in the course in progress.

Equipment:

- Battery powered continuous loop machine will be used. Backup equipment will be available.
- Lure will consist of black and white plastic strips and/or strips of fur.

Course Plans:

Monday's course is 650 yards, reversed for Finals and BOB. Terrain is mowed field with uneven ground. Hounds need to be in top physical condition due to the high elevation. USRCC reserves the right to alter the course diagram as required by weather and/or field conditions on the day of the trial.



Directions to Field/Rob Young Lane:

Take I-80 east from Salt Lake to exit 155, UT-32 S toward Wanship/Kamas. Turn right onto UT-32 South and drive 7.5 miles. Turn left to stay on UT-32 South and drive another 4.5 miles. Turn right onto Rob Young Lane (3700 N). The field is 0.4 miles ahead on the right.

Basic information about the weekend:

- No littering.
- Pick up after your dogs. There will be a fine for NOT cleaning up after your hounds.
- There will be a Port-a-John on the field.
- Weather in Utah is very unpredictable expect anything from very hot temperatures to snow – bring raingear, layers of clothing, hat, gloves, sunglasses & sun screen! (Also remember that it is usually VERY windy in Utah – make sure to bring stakes for your shade cloths and canopies!)
- As there is NO shade on the field bring shade and water for your dogs (and yourself).
- Club owned coursing blankets and slip leads will be available for use at the field for those who don't have their own. First aid supplies will be available at the field.
- There IS camping on site with motorhomes, but NO hookups and NO DUMPING! Dogs may not be off leash on the field.
