DIRECTIONS TO CLINTON STATE PARK

Daily park permits are required and can be purchased at the front gate for \$5.00 per day.

For I-70 Drivers - Take I-70 (East from Topeka, West from Kansas City), exit at Lecompton, turn South, this is Highway 10. Take this to the Clinton Parkway Exit, at the stop sign, turn right. At the next stop sign, turn right again, then take your 2nd left into Clinton State Park. Stop at the permit station and follow signs to the field.

From Host Hotel - South on McDonald Drive. Take US-59 S ramp. Slight right onto S Iowa St/US-59. Slight right onto Clinton Parkway. Stay on Clinton Parkway until it dead ends. Turn right. Then take your 2nd left into Clinton State Park. Stop at the permit station and follow signs to the field.

All entries shall be individually registered with the American Kennel Club, the Federation Cynologique Internationale, an ASFA recognized foreign or ASFA Board approved registry. If this is your borzoi's first ASFA trial, you must submit a copy of his registration paper, and the ASFA Certification Form. If your dog has earned the AKC senior courser, AKC field champion, LGRA GRC, NOTRA ORC, or Canadian field champion title, fill out the "Wavier" portion of the ASFA certification form, & include a copy of the dog's title. Otherwise, fill out the "Certification" portion, which has to be signed by a licensed ASFA judge who has watched your dog coursing with another dog.

Late, incomplete, conditional, unsigned, unpaid entries will NOT be accepted. Owners may not substitute for lame or in-season borzoi.

Entries will not be acknowledged by mail.

STAKESOFFERED

Open Stake: Any eligible Borzoi who has met certification requirements, excluding ASFA Field Champions of Record. A photocopy of the Borzoi's registration must be submitted at the Borzoi's first trial. An AKC Qualified Courser certificate is acceptable as a waiver for a first time entered Borzoi.


Field Champion Stake: Any ASFA Field Champion Borzoi.

Veteran Stake: Any eligible Borzoi whose age exceeds six years, who has met certification requirements. Points earned in this stake are towards the V-FCH or V-LCM titles.

CONDITIONS OF ENTRY

All entries must be at least one year of age on the day of the trial. Stakes will be split if entry in any one stake is 20 or more at the time of the draw. Bitches in season and lame Borzoi at Roll Call will be excused and entry fee refunded. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Borzoi not present at the time of Roll Call will be scratched. Hound cerification runs will not be offered. A battery operated, continuous loop lure machine, with backup equipment, will be used. Lure will consist of highly visible plastic strips. A \$5.00 fine will be assessed for any hound loose on the field not competing in the course in progress. All Borzoi run at the owner's sole risk. Please be responsible Borzoi owners and clean up after your dogs and yourselves.
