Stakes Offered

OPEN: Any eligible Scottish Deerhound that has met certification requirements,
excluding ASFA Field Champions of Record.

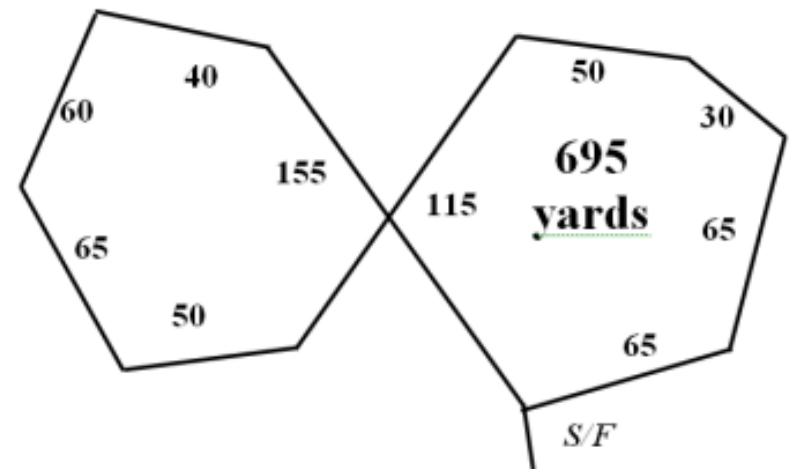
FIELD CHAMPION: Any Scottish Deerhound ASFA Field Champion

VETERAN: Any eligible Scottish Deerhound that has met certification requirements
that is at least 6 years of age.

SINGLE: Any eligible Scottish Deerhound including those disqualified to run in other
stakes. Not eligible to run for Best of Breed.

KENNEL: Any two eligible Scottish Deerhounds designated at the time of entry in
one of the regular stakes and owned by the same individual.

BREEDER: Any two eligible Scottish Deerhounds designated at the time of entry in
one of the regular stakes and bred by the same individual.

SDCA reserves the right to alter course plan due to weather or field
conditions. A battery-operated continuous loop lure machine will be used
with highly-visible plastic strips. Diagram approximate to scale. Course
will be reversed for finals and again for run-offs and Best of Breed.

The field is mostly fenced except for some pass-through openings.



-  Stakes will be split into flights by public random draw if entry in any regular stake is 20 or more.
-  **Entries WILL BE acknowledged by email if you include a legible email address on your entry form.**
-  Bitches in season, hounds with breed disqualifications and lame hounds will be excused. Refunds will be given.
-  Hounds with breed disqualifications are not eligible to run except in Single stake.
-  Hounds not present at roll call will be scratched and no refund will be given.
-  **Hound certification runs will be ran after the AKC trial on Monday, May 8 for those only competing in ASFA trial.**
-  A complete list of all award sponsors will be posted at the secretary desk on the day of trial and are listed in the Show Catalog.
-  Those wanting to run certification runs on Monday must provide the hound used to certify their hound.
-  No smoking allowed anywhere on the trial grounds. Porta-Potty will be on site. Bring water & shade.
-  **FIRST TIME ENTERED entries must include a photocopy of an acceptable registration form along with a completed ASFA Certification or Waiver form at time of entry.**
