Eligible Breeds and Registry

Only purebred Italian Greyhounds. All entries shall be individually registered with the AKC (ILP and PAL included), an ASFA-recognized foreign or ASFA Board approved registry.

STAKES OFFERED:

OPEN STAKE: Any eligible Italian Greyhound that has met certification requirements, excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE: Any ASFA Field Champion Italian Greyhound.

VETERAN STAKE: Any eligible Italian Greyhound whose age is at least six years.

SINGLE STAKE: Any Italian Greyhound, including those disqualified to run in other stakes. Hounds are eligible to earn TCP and CPX titles from the Singles Stake. Each hound runs alone.

GENERAL INFORMATION:

1. All entries must be one year of age or over on the day of the trial.
2. Stake will be split if the entry in any one stake is 20 or more hounds at the time of the draw.
3. Bitches in season, hounds with breed disqualifications, and lame hounds will be excused.
4. Hounds not present at roll call will be scratched.
5. Monorchid, cryptorchid, spayed, or neutered hounds may be entered.
6. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
7. Muzzles are not required. It is the responsibility of the owner to determine if their hound needs to be muzzled.
8. Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
9. Lure machine is battery powered, continuous loop. Back-up equipment is available.
10. Lure will consist of highly visible plastic bags.
11. A fee of \$20 will be assessed for any returned checks.
12. There will be a \$5 fine for any loose hounds on the field that is not part of the course in progress.
13. Hound will be reversed for finals and again for run-offs.
14. Hound certification runs will be offered after the trial.
15. Practices will be held after the trial, equipment and weather permitting.
16. Persons exhibiting conduct detrimental to ASFA/IGCA/any hound(s)/other person(s) will be asked to leave the trial site.

NOTES FOR THE WEEKEND:

- Please park in the grass along the curve in the road, as close to the road as possible.
- Do drive on the field.
- No cigarette smoking in or near the field
- Do not turn dogs loose in any of the fenced areas
- Please keep your dogs away from the horses.
- We will need assistance from all to help getting dogs to the line, paddock, and inspections to speed things along.

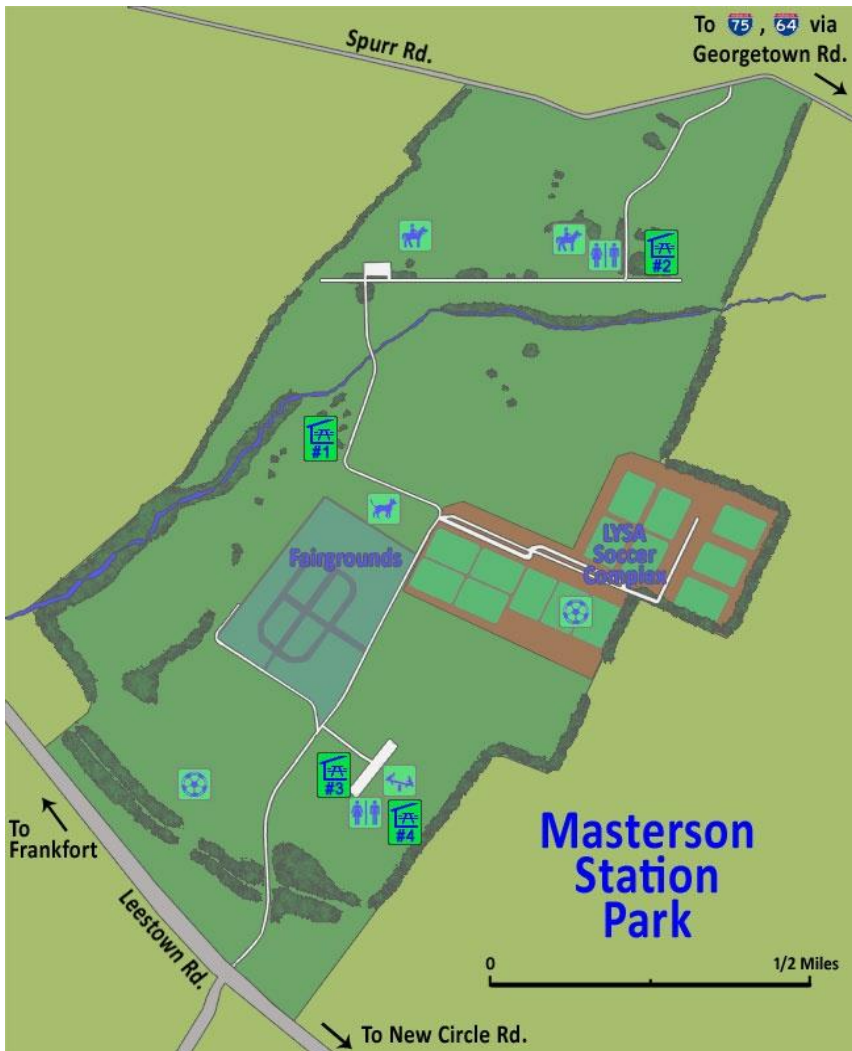

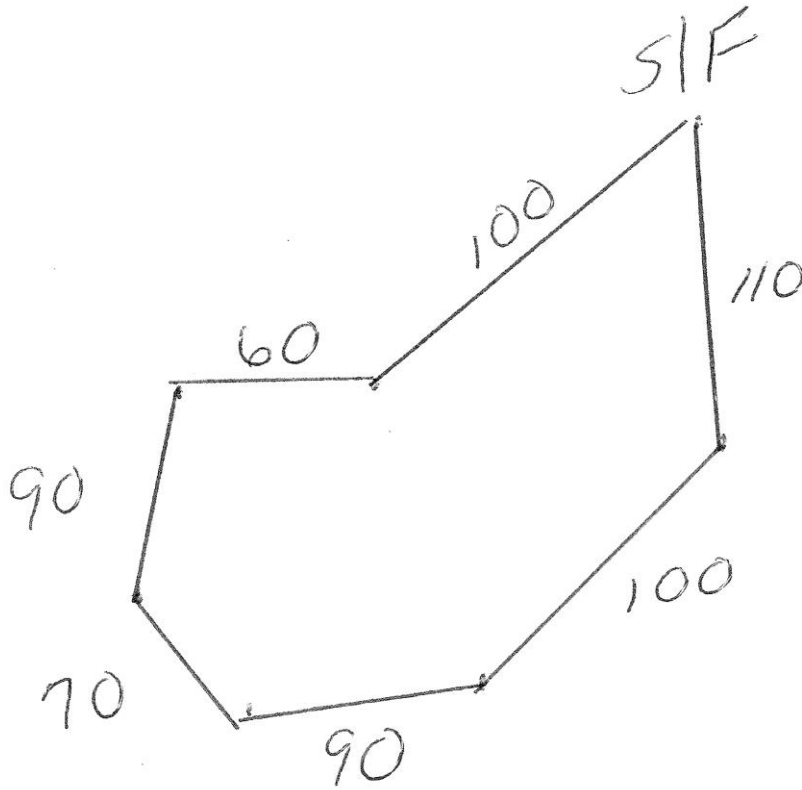
