Alternate route to get around I-85 bridge collapse.

If you are traveling South on I-85 take exit 95A towards Augusta/Macon Merge onto I-285
Take exit 62 for GA-14 Spur toward S Fulton Pkwy
Turn Right onto Cedar Grove Road
Turn Right onto Cascade Palmetto Hwy
At the traffic circle, take the 3rd exit onto Cedar Grove Rd to your destination

From I-75 North & South of Atlanta: Take I-285 West to Exit 62 Spur 14 S. Fulton Pkwy, then below. From I-20 heading West: Take I-285 heading south to Exit 62 Spur 14 S. Fulton Pkwy, then below. *

From I-85 heading South: Take Exit 69 Spur 14 S. Fulton Pkwy from South Fulton Prkwy, then below. *

*Below for all directions above: Stay on S. Fulton Pkwy for 7.5 miles then Right on "Hwy 92 Campbellton Fairburn Rd". Go 4.5 miles then Left on "Hwy 70 Cascade Palmetto Rd". Go 0.3 miles then Right on "Cochran Mill Rd". Go 1 1/4 mile, then follow signs for Chattahoochee Hills Eventing to show entrance (on right).

From I-20 heading East: Take Exit 37 Hwy 92 Fairburn/Douglasville; end of ramp go Right on 92 South/ Fairburn from I-20 heading East: Take Exit 37 Hwy 92 Fairburn/Douglasville; end of ramp go Right on 92 South/ Fairburn Rd. Go 5.2 miles then go Right at light staying on 92 South Fairburn Rd. Go for 4.2 miles then at light go Right on Cascade Palmetto Rd. Go 0.3 miles then Right on Cochran Mill Rd. Go 1/2 mile, then right onto Cedar Grove Road show entrance is 1 1/4 mile on the right- follow signs for Chattahoochee Hills Eventing.

From I-85 heading North: Take Exit 61 Hwy 74, Fairburn; end of ramp go left heading North on 74. When the 4-lane lane turns into a 2-lane, stay straight (do not continue on 74; go straight for 2.3 miles until the road dead ends into Rivertown. Go left on Rivertown for 3.5 miles to S. Fulton Pkwy. Cross over S. Fulton Pkwy staying on Rivertown for .7 miles. Turn slight right onto Cedar Grove Road go 7.2 miles show entrance will be on the right- follow signs for Chattahoochee Hills Eventing.

REGULAR STAKES:

OPEN STAKE: Open to all eligible Ibizan Hounds, excluding ASFA Field Champions of record. First time entrants must include a certification form and copy of registration.

FIELD CHAMPION STAKE: Open to Ibizan Hounds that are ASFA Field Champions

VETERAN STAKE: Open to Ibizan Hounds whose age is at least six years.

SINGLE STAKE: Any eligible Ibizan Hound including those disqualified to run in other stakes. Not eligible for Best of Breed. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

NON-REGULAR STAKES***

BREEDER STAKE: For two Ibizan Hounds, designated at time of entry, bred by the same individual.

KENNEL STAKE: For two Ibizan Hounds, designated at time of entry, owned and kenneled by the same individual.

BENCH CHAMPION STAKE: For any hound eligible to enter a regular stake, that is an AKC, CKC, UKC or ASFA-approved International show champion of record. A copy of the hound's championship certificate must accompany each Stake entry.

PERFORMANCE TITLED: For any hound eligible to enter a regular stake, that is an AKC, CKC or UKC performance/companion title holder of record (excluding Field Trial Titles). A copy of the hound's title certificate must accompany each entry.

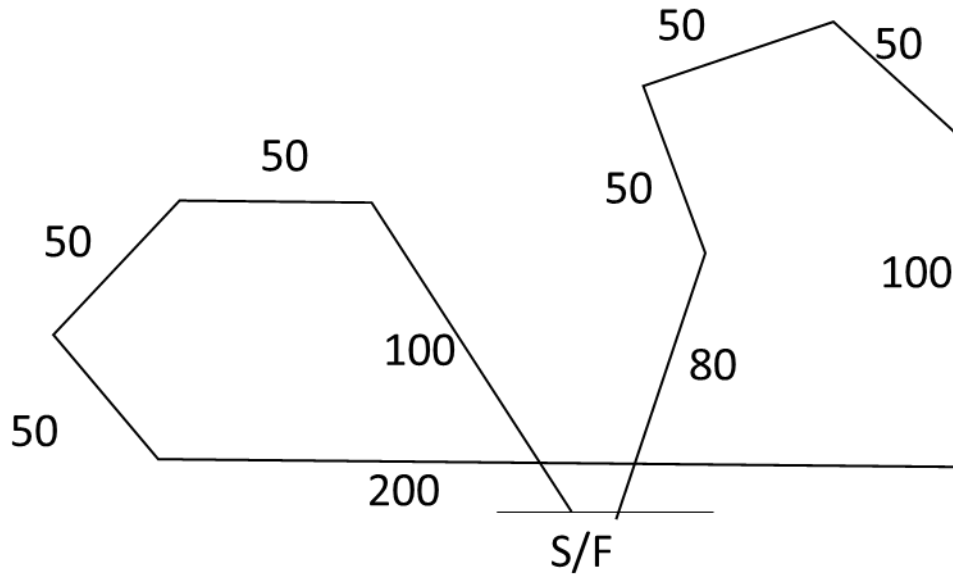
***If a tie exists after the final runs then the dog(s) with the highest FINAL score will be declared the winner. IF the final score is tied then the dog(s) with the highest Preliminary score will be declared the winner.

GENERAL INFORMATION

1. All entries must be one year of age or older on the day of the trial.
2. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
3. Bitches in season, lame hounds and hounds will be excused at roll call, Hounds with breed disqualifications will also be excused, unless entered in Singles Stake.
4. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake.
5. Hounds not present at the time of roll call will be scratched.
6. Hound certification runs will not be offered....*email any questions to the Trial Secretary*
7. Battery powered continuous loop machines will be used. Lures will consist of white plastic bags. Backup equipment will be available.
8. The course will be reversed for the finals and again for the BOB run-offs. Course subject to change based upon condition of the field and weather.
9. The Field Committee reserves the right to alter the course diagram as required by weather and/or field conditions on the day of the trial.
10. **Please bring you own shade and water.**
11. No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Chairman.
12. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
13. IHCUS assumes no liability for injury to any person or dog before, during or after the Trial.
