# **Eligible Breeds and Registry**

Only purebred Afghan Hounds, Azawakh, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhound, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughi, and Whippets may enter the regular stakes.

Limited breeds may be entered in the Limited or Singles Stake. Limited Stake breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequino) and Portuguese Podengo (Medio and Grande) and must be individually registered by the appropriate registry.

All entries shall be individually registered with the AKC (ILP and PAL included), NGA, FCI, UKC or an ASFA recognized foreign or an ASFA approved registry or possess a CRN from SPDBS. Limited stake entries shall be individually registered with the appropriate registry. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry. This requirement is waived for hounds registered with the NGA.

## **Stakes Offered**

<u>Open:</u> Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

<u>Field Champion:</u> Any ASFA Field Champion <u>Veteran:</u> Any eligible sighthound that has met certification requirements whose age exceeds 6 years (5 years for IWs, 7 years for Afghans, Rhodesian Ridgebacks, Salukis and Whippets.)

<u>Single:</u> Any eligible sighthound including those disqualified to run in other stakes. (Hounds run alone and are not eligible for BOB or BIF.) Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

<u>Limited:</u> Any eligible sighthound of a Limited beed that has met certification requirements. Not eligible to compete in BOB or BIF.

Best in Field: will not be offered.

All entries must be one year or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except in the Single Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces, (except in the Single Stake), unless excused, dismissed or disqualified. Battery powered, continuous loop lure machines will be used. The lure will consist of white plastic strips Back up equipment will be available. and/or skins. Hound certification runs will be offered following the trial. The members of TSSC reserve the right to alter the course plans as required by weather and/or field conditions on the day of the trial. There will be a \$5 fine assessed for any loose hound not taking part in a course in progress. 

SUNDAY Course Plan 800 Yards


