## Rosettes & Trophies

First Place: Blue, Second Place: Red, Third Place: Yellow, Fourth Place: White, NBQ (Next Best Qualified): Dark Green, Highest Scoring Single: Navy & Gold, Best of Breed: Purple & Gold, Non-Regular Stakes: Pink & White. Trophies will be awarded for 1st through NBQ and any Non-Regular Stake winners. First placement in each regular stake receives a SCOA medallion. The Best of Breed winner is awarded the ASFA Best of Breed SCOA National Specialty Plaque and the SCOA Pyramid Cup (perpetual trophy). The Highest Scoring Single is awarded the SCOA Sky Song Trophy (perpetual).

## Eligible Breeds and Registry

Only purebred Salukis that are one year of age or older on the day of the trial may be entered.

All entries shall be individually registered with the American Kennel Club (ILP/PAL included), the United Kennel Club, the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA board approved registry, or possess a CRN from the Society for the Perpetuation of Desert Bred Salukis.

Incomplete, unsigned, conditional, or late entries will NOT be accepted. Substitutes for lame or in-season hounds are allowed if the substitute has the same owner and the Field Trial Secretary is notified by the applicable Roll Call days and times. Entries will NOT be acknowledged by mail or telephone.

Owners must keep their hounds under control and clean up after them. A \$10 fine will be assessed for any hound loose on the field not competing in the course in progress.

## Stakes Offered:

**Open:** Any eligible Saluki that has met the certification requirements at the time of closing, excluding ASFA Field Champion Salukis of record.

**Field Champion:** Any ASFA Field Champion Saluki.

**Veteran Stake:** Any eligible Saluki whose age exceeds seven years, who has met certification requirements at the time of closing.

**Single:** Any eligible Saluki including those disqualified to run in the other stakes. Each Saluki runs alone. Not eligible to run to in Best of Breed competition. Salukis are eligible to earn TCP and CPX titles from the Singles Stake.

**Breeder Stake:** Any two Salukis bred by the same person and designated at the time of entry.

**Kennel Stake:** Any two Salukis owned and kenneled by the same person and designated at the time of entry.

**Bench Stake:** Any Saluki with proof on file with the ASFA of a conformation champion title from the AKC, CKC or both, or a conformation grand champion title from the UKC.

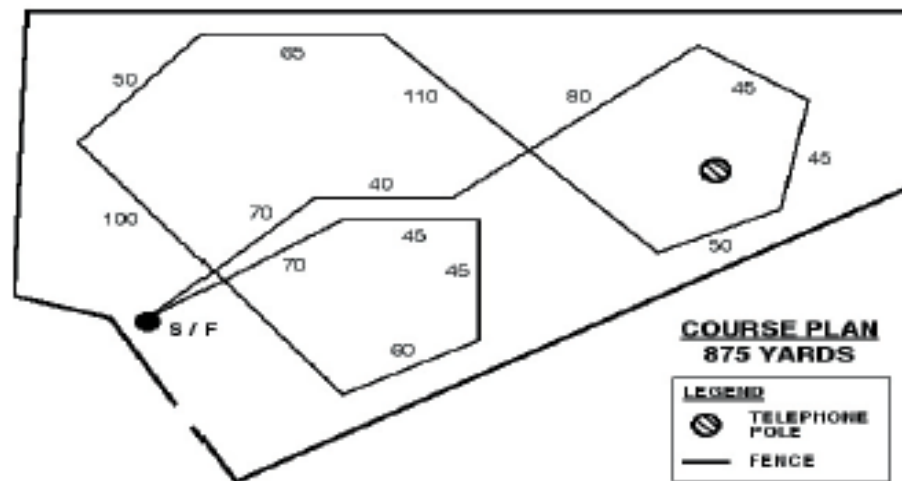

## Conditions of Entry:

All entries must be one year old on the day of the trial. Stakes will be split if 20 or more entries are present in any one stake at the time of the draw. Salukis not present at roll call will be scratched. Bitches in season and lame Salukis will be excused. Spayed, neutered, monorchid, and cryptorchid Salukis may be entered. A gas-powered or battery-powered continuous loop machine will be used. The lure will consist of plastic strips.

The course will be reversed for finals, tie run-offs and BOB. SCOA reserves the right to alter the course as required by weather and/or field conditions.

**Hound Certification Runs will not be offered at this trial.**  
**Hound Certification Runs will be offered on Wednesday, June 5th 2019.**
