Due to the (hopefully) atypical environment in which we find ourselves . . .

- Entries for these trials will be limited to 25 hounds on a first received, first entered basis. Only <u>paid</u> entries will be counted as complete. No new entries will be accepted on the day of the trial, but substitutions will be allowed.




