Due to the (hopefully) atypical environment in which we find ourselves . . .

- Entries for these trials will be limited to 25 hounds on a first received, first entered basis. Only paid entries will be counted as complete. No new entries will be accepted on the day of the trial, but substitutions will be allowed.
- Certifications will be offered on Friday, October 23, 2020 from 3pm to 5pm only. Dogs successfully certifying at that time may enter the weekend's trials providing the 25 hound entry limit has not been met.
- All attendees must fill out and sign the liability waiver on the following page. Any who do not will be asked to leave the field. This is a legal requirement, and one more stringent than other clubs may have, due to the field's unresolved ownership.
- We ask that you observe social distancing guidelines at all times, when not completely impractical, including the parking of your vehicle. This may require some attendees to park on the field north of the coursing field, the one you drive through to get to where you have parked in the past.

As for the coursing itself . . .

- SISFA will follow State and local guidelines.
- All Field Committee personnel and Lure Operators will wear facial coverings.

- All participants will wear facial coverings when distancing is not possible.
- No food will be served, bring your own breakfast and lunches. Sorry!!! Please bring your own food, water and shade for yourself and your dogs. None will be available at this time.
- At inspection we will ask the owners of females to wipe their dogs and show the inspection committee the tissue.
- Roll Call will be done at everyone's car, instead of near the FTS's table as in the past. The roll call committee will wear facial coverings.
- Wickets will be wiped down after each dog is inspected.
- Hand sanitizer and wet wipes will be available in the paddock area.
- The porta-potty door will be propped open when not in use for more air flow to cut down on bacteria.
- Huntmasters will stand 6 feet from the dogs after inspecting blankets and slip leads.
- At the starting line, all dogs will stand 6 feet apart.
- Please be aware that the running orders will be posted as usual; if needed, we will use a bull horn to notify you if you choose to stay by your car.

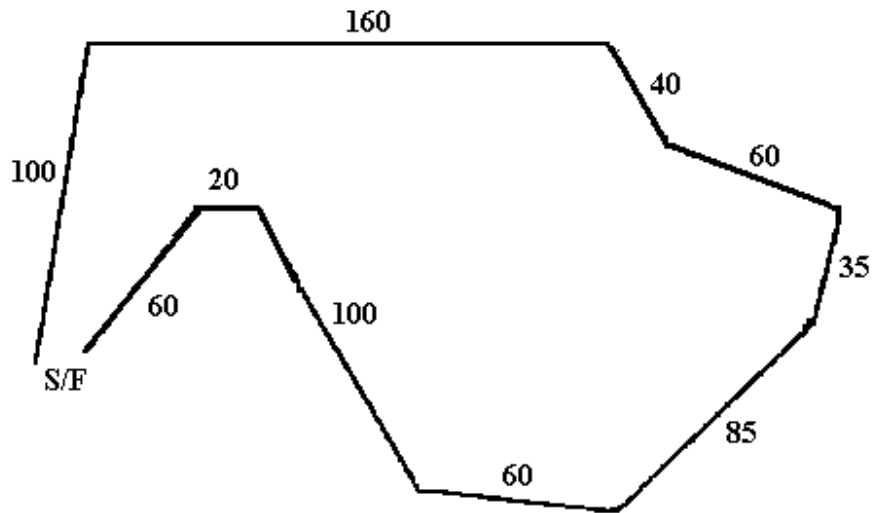

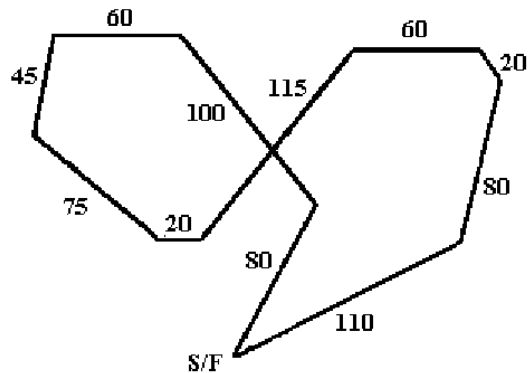

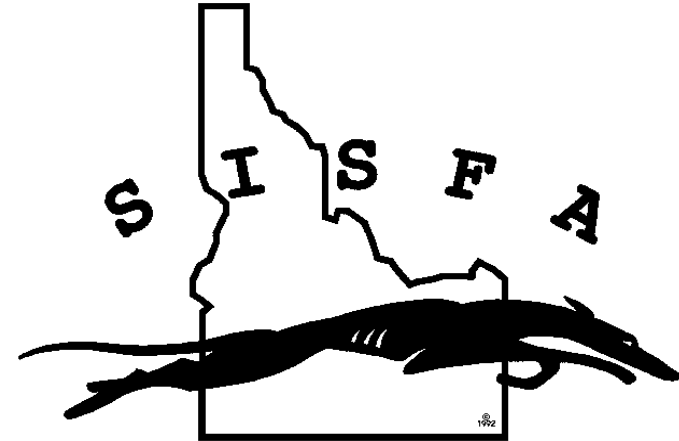

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, and Whippets may be entered in the regular stakes. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A **printed photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry**; this requirement is waived for hounds registered with the NGA.

INCOMPLETE, UNSIGNED OR CONDITIONAL ENTRIES WILL NOT BE ACCEPTED.
Entries will not be acknowledged by mail or telephone. Email, IM, or text Jose or Corrine for confirmation.

REGULAR STAKES OFFERED

Open Stake: Any eligible sighthound excluding ASFA Field Champions of record that has met certification requirements.

Field Champion Stake: Any ASFA Field Champion.

Veteran Stake: Any eligible sighthound that has met certification requirements and whose age exceeds six years, except Irish Wolfhounds, whose age shall exceed five years, and Afghans, Ridgebacks, Salukis, and Whippets who must be at least seven years old. Points go toward V-Fch or V-LCM titles.

Limited Stake: Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

Singles Stake: Any eligible sighthound, including those disqualified to run in other stakes. Not eligible to run in Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

Best in Field: Offered Saturday and Sunday.

GENERAL INFORMATION

- All entries must be one year or older on the day of the trial, and have a completed hound certification form if entered in open or veterans stake for the first time.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, hounds with breed disqualifications, and lame hounds will be excused at Roll Call and the entry fee will be refunded.
- Spayed, neutered, monorchid, and cryptorchid hounds without breed disqualifications may be entered.
- Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Hounds not present at time of Roll Call will be scratched without refund of entry fee.
- Any hound that displays aggressive behavior during trial hours will be excused for the day without refund of entry fee.
- All hounds will run twice in trios, if possible, or braces (except in the Single Stake) unless excused, dismissed, or disqualified.
- A penalty of \$5.00 will be assessed for any loose hound not competing in the course in progress.
- A penalty of \$5.00 will be assessed for any waste material left on the grounds by a dog or person. Waste disposal equipment and containers will be available.
- There will be no certification runs during the trial. Certifications will be offered on Friday afternoon.
- Battery powered, continuous loop lure machine will be used; backup equipment will be available.

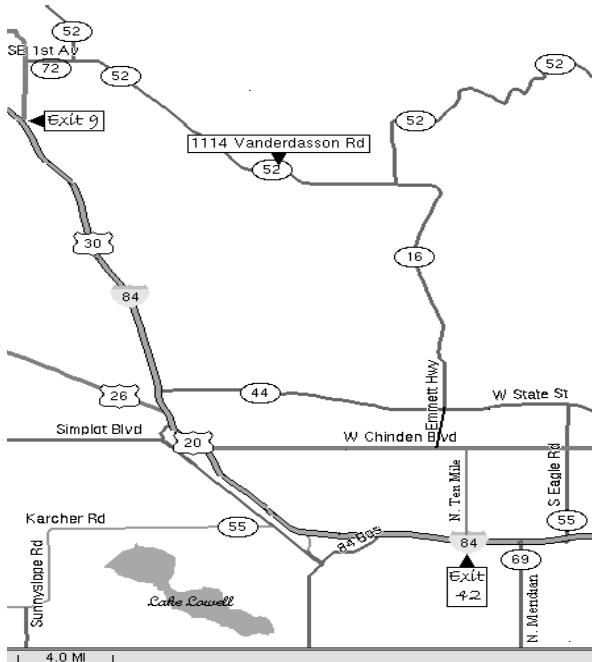

From the **west**: Take the second US30 exit (#9) from I-84. Turn right onto Idaho 72 (SE 1st Av). Go straight at Sand Hollow Road to get on Idaho 52, still heading east. Proceed to Vanderdasson Road.

From the **east**: Take exit #42 (Ten Mile) from I-84. Proceed on N. Ten Mile 4.7 miles to Idaho 20/26 (Chinden Rd.) Turn left, go 2 miles to Idaho 16 and turn right. Proceed on Idaho 16 to the junction with Idaho 52 and go straight 4.75 miles to Vanderdasson Road.

Vanderdasson Road is between mileposts 25 and 26 on Idaho 52. Tom's Cabin Café is approximately on the opposite corner. Turn north onto Vanderdasson and proceed across the railroad tracks. The driveway to the field is a right turn immediately after crossing the bridge over the irrigation ditch. The address on the mailbox is 1114. There will be signs on Idaho 52 and on Vanderdasson indicating the direction to the field.

Please close any gates you open after entering the driveway from Vanderdasson.
