### ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis and Whippets may be entered in the regular stakes. **Provisional breeds** (PVL) may be entered in the Provisional Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry. All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

### STAKES OFFERED

**OPEN STAKE:** Any eligible sighthound, excluding ASFA Field Champions of record, that have met the certification process.

**FIELD CHAMPION STAKE:** Any ASFA Field Champion

**VETERAN STAKE:** Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds,

Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

**Provisional STAKE:** Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

**SINGLE STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

**Lure Coursing Instinct STAKE:** Open to all Non-Sighthound breeds. All entries shall be individually registered with the AKC (including ILP & PAL), the UKC, the FCI, an ASFA recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry.

**Small** will run half of the course as laid out in this premium up to a maximum of 400 yards. All other sizes will run the full course length.

## GENERAL INFORMATION

### Conditions of Entry:

- All entries must be one year or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Hounds not present at the time of roll call will be scratched and entry fees will not be refunded.
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- **Certifications will be offered after the trial as time permits. A \$10 fee is applicable per run.**
- Early-entry fees submitted and accepted with early-entries will be refunded in full if the withdrawal of said entries is requested by the hound's owner or agent prior to the closing deadline for early-entries. Requests may be made by time-stamped email to the FTS or by direct contact (phone or in person) with the FTS. No refunds for early-entry fees will be returned after the closing of early-entries unless the entered hound upon inspection is lame or in season.
- Day-of-trial-entry fees submitted and accepted with day-of-trial-entries will be refunded in full if the withdrawal of said entries is requested by the hound's owner or agent prior to the closing deadline for day-of-trial-entries. Requests must be made in person to the FTS. No refunds for day-of-trial-entry fees will be returned after the closing of day-of-trial-entries unless the entered hound upon inspection is lame or in season
- Electrical-powered, continuous loop lure machine will be used with back-up equipment available
- The lure will consist of light and/or light colored plastic and/or fur.
- Muzzles are not required; it is the responsibility of the owners to determine if their hound should be muzzled. If a muzzle is used, it must be of a color other than yellow, pink or blue
- Late, conditional, unsigned, incomplete or unpaid entries will not be accepted
- Early-Entries will not be acknowledged by mail; Entries will be acknowledged by e mail if requested and if an e-mail address is provided
- Substitutions may be made for hounds lame or in season **at the time of roll call**
- or the Regional Invitational, all hounds must have earned at least AS A point in previous trials
- Hounds may enter the SINGLES stake without having ASFA certification, but must provide a copy of their official registration papers

We will follow State and local guidelines.

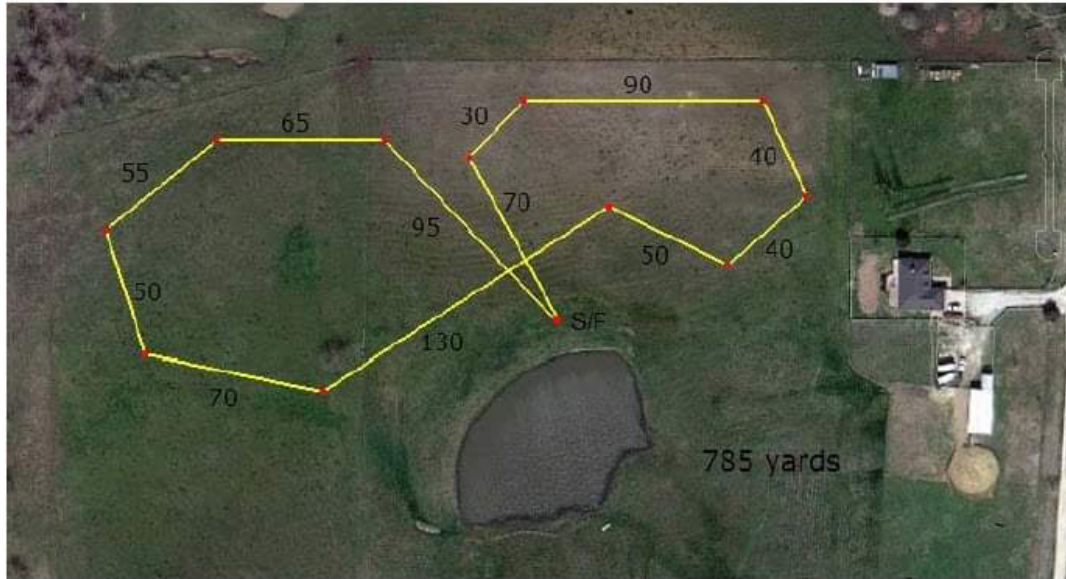
1. All Field Committee and Lure Operators will wear facial coverings.
2. All participants will wear facial coverings.
3. No food will be served, bring your own breakfast and lunches. Sorry!!! Please bring your own food, water and shade for yourself and your dogs. None will be available at this time.
4. We ask that you park at a safe distance away from each other.
5. Roll Call will be done at everyone's car. The roll call committee will wear gloves and facial coverings. We will ask the owners of females to wipe their dogs and show the inspection committee the tissue.
6. Wickets will be wiped down after each dog.
7. We will have hand washing stations or instant hand sanitizer and wet wipes.
8. We will prop open the portapots when not in use for more air flow to cut down on bacteria.
9. Huntmasters will stand 6 feet from the dogs after inspecting blankets and slip leads.
10. At the starting line, all dogs will stand 6 feet apart.
11. Practice social distancing the best you can. I know we all have been cooped up but act responsibly!!
12. Please be aware of the running order will be posted as usual.
13. We will also post running order and scores on our **Gazehounds in Texas** Facebook page.
14. No self-serve ribbons anymore due to cross contamination.

## Lure Chasing Instinct Program Open to NON sighthounds and sighthound mixes

All entries shall be individually registered with the AKC (including ILP & PAL) or the UKC. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry.

- A. AKC Registration as one of the recognized breeds.
- B. AKC Canine Partners, which is for mixed breed dogs and dogs ineligible for AKC registration.
- C. Purebred Alternative Listing (PAL) program, which is for purebred dogs that cannot be fully registered with the AKC to participate in AKC events.
- D. Foundation Stock Service® (FSS), which is for recorded breeds on the road to full AKC recognition.
- E. United Kennel Club (UKC) registration as one of the recognized breeds.

Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry. NO FIRST TIME ENTERED DOGS AT THE REGIONAL. If the permanent number is not yet available from ASFA, the owner will supply a copy of the Request for Unique Entry Number as proof of request and payment until permanent number is provided to the owner by ASFA.

### **LCI Stakes:**

**Small Open:** for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

**Small Senior:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

**Small Veteran:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

**Large Open:** for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.

**Large Senior:** is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC.

**Large Veteran:** for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

**Sighthound Mix Open:** for dogs with a sighthound breed in its background who have not achieved the title of LCC.

**Sighthound Mix Senior:** for dogs with sighthound breed in its background who have achieved the title of LCC.

**Sighthound Mix Veteran:** for dogs with sighthound breed in its background over the age of 7 years
