

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhound, Whippets.

Provisional breeds may beentered in the Provisional Stake, or the Singles Stake Provisional breeds currently include purebred Chart Polski, Galgo Española, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

STAKES OFFERED:

OPEN STAKE: Any eligible sighthound that have met the certification requirements, excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE: Any ASFA Field Champion

VETERAN STAKE: Any eligible hound whose age is at least 6 years, except Irish Wolfhounds, whose age shall be at least five years, and Afghans, Ibizian Hound, Whippets, Ridgebacks, and Salukis whose age shall be at least seven years. SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles. PROVISIONAL STAKE: Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible for Best of Breed or Best in Field.

Best in Field will be offered.

CONDITIONS OF ENTRY:

- All entries must be one year or older on the day of thetrial.
- Stakes will be split into flights by public random draw if the entryin any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disgualifications will be excused at roll call.
- Spayed, neutered, Monorchid or cryptorchid hounds without breed disqualifications may be entered.
- Hounds with breed disqualifications are not eligible toenter except in the Single Stake.
- Hounds not present at the time of roll call will be scratched.
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed, or disqualified.

ADDITIONAL INFORMATION:

- Muzzles are not required. It is the responsibility of the owner to determine if their hound needs to be muzzled.
- Lure machine is battery powered, continuous loop. Back-up equipment is available.
- The lure will consist of highly visible plastic strips.
- A fee of \$35.00 will be assessed for any returned checks.
- There will be a \$5.00 fine for any loose hound on the field that is not part of the course in progress.
- Course will be reversed for finals.
- Persons exhibiting conduct detrimental to ASFA/TSA/any hound(s)/other person(s) will be asked to leave the trial site.
- Hound Certification runs will be offered.

Fees are payable by cash, check, or money order. Foreign checks are not acceptable.


