General Information

- There will be a \$5.00 fine assessed for any loose hound not taking part in course in progress.
IGCA will strictly enforce this assessment.
- Hounds not present at the time of Roll Call will be scratched after 5-minute grace period.
- BITCHES IN SEASON AND LAME HOUNDS WILL BE EXCUSED. Each entry will be examined at inspection for breed disqualifications.
- Field Committee reserves the right to bar aggressive dogs from the event site.
- Incomplete, unsigned, conditional or unpaid entries will not be accepted. No fax or on-line entries will be accepted. Entries will NOT be acknowledged by mail.
- Muzzles are not required, but are permitted at the handler's discretion.
- The Club, Field Committee, their agents, employees, etc., assume no responsibility for any loss, theft, damage, injuries or death sustained by exhibitors or handlers to any dog or property, and further assume no responsibility for injury to children while at or on the Trial grounds, or in transit to/from the Trial grounds.
- Dogs must be ready for judging. Judges need not wait for dogs holding up a stake.
- Entry fees shall not be refunded in the event that a dog is absent, disqualified or dismissed by a judge, barred from competition by action of the Field Committee, or because the dog is ineligible to compete due to a check being returned. The returned check must be made good by cash or money order before the dog will be entered correctly. Returned checks do not constitute a valid entry fee.
- The Club and/or Trial Secretary assume no responsibility for wrong or incomplete information given on the entry form by the owner or agent of the owner. The Club and/or the Trial Secretary assume no responsibility for the owner or owner's agent for entering a dog in a stake in which the dog is not eligible to compete
- Changes, additions or corrections to entry forms must be received in writing or by electronic mail prior to the close of entries. Those received by telephone are not acceptable.
- Please bring your own water, chairs and shade.
- All trophies and prizes must be claimed the day of the Trial; none will be mailed. IGCA reserves the right to substitute a trophy or prize of equal or greater value.
- All hounds must be 1 year or older on the day of the trial.
- Alcoholic beverages are not allowed at the field.

PHOTOGRAPHER - There will be no professional photographer at this event. Please feel free to take your own photos.

ELIGIBLE BREEDS & REGISTRY

Only purebred Italian Greyhounds may be entered.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

REGULAR STAKES OFFERED

OPEN STAKE: Any IG who has met the certification requirements. ASFA Field Champions of record are excluded.

FIELD CHAMPION STAKE: Any ASFA Field Champion

VETERAN STAKE: Any IG who has met the certification requirements and whose age is at least six years. Points go toward V-FCh or V-LCM titles.

SINGLE STAKE: Any IG including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

Conditions of Entry: All entries must be one year or older on the day of the trial

- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake
- Hounds not present at the time of roll call will be scratched
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed, or disqualified.
- The members of IGCA reserve the right to alter the course plan as required by weather and/or field conditions on the date of the trial. Exhibitors are requested to not bring bitches known to be in season to the field.
- There will be a \$5.00 fine assessed for any loose hound not participating in the course.

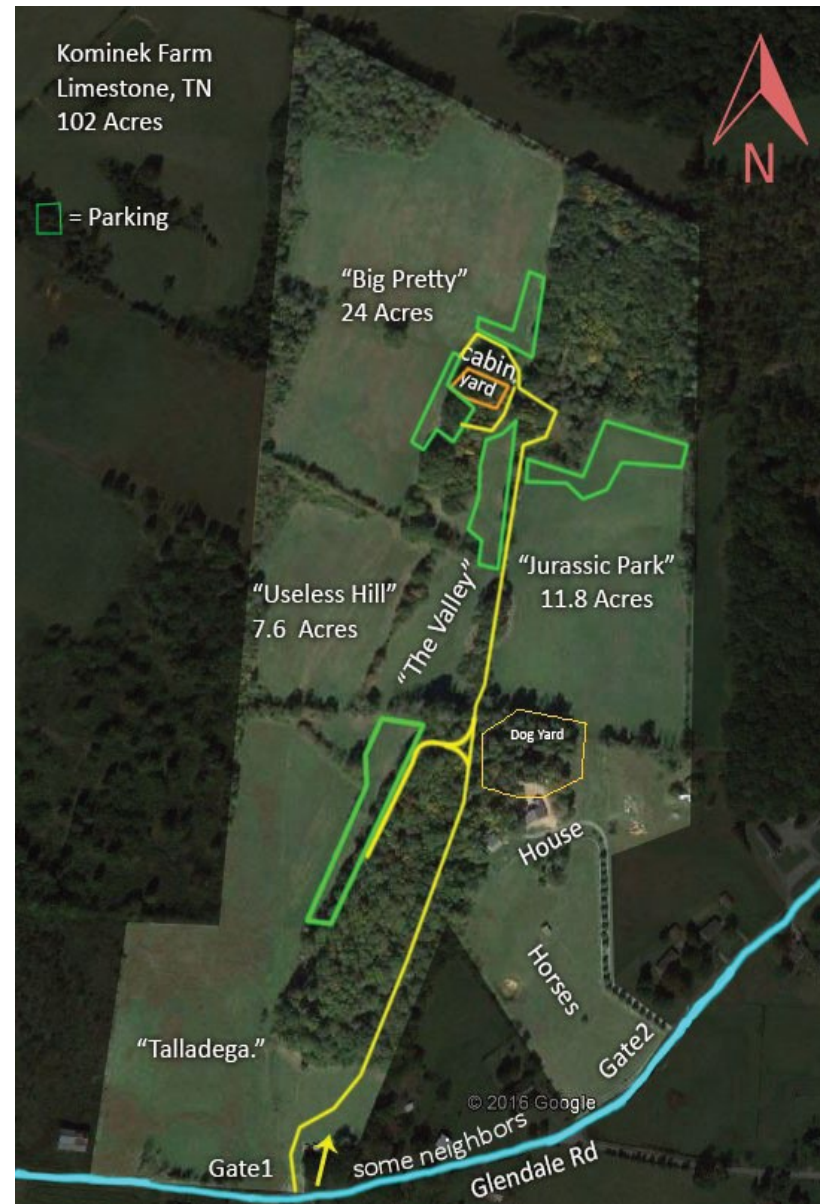

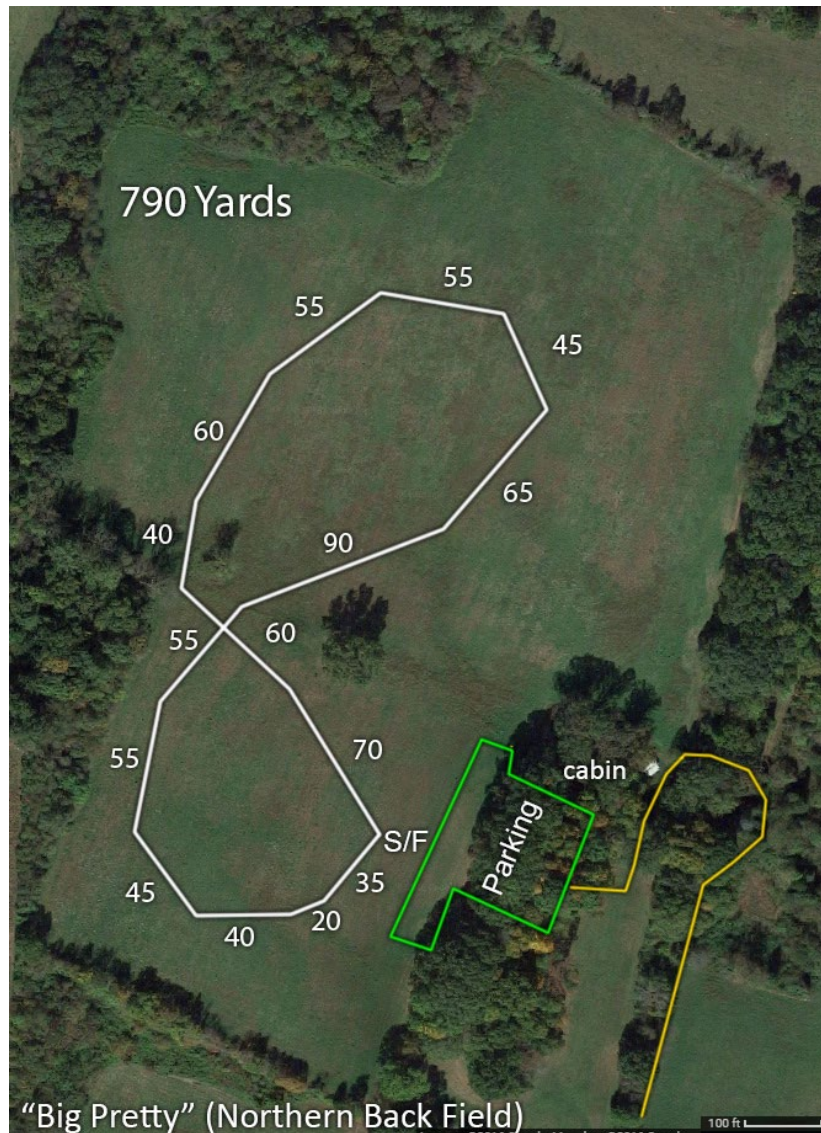

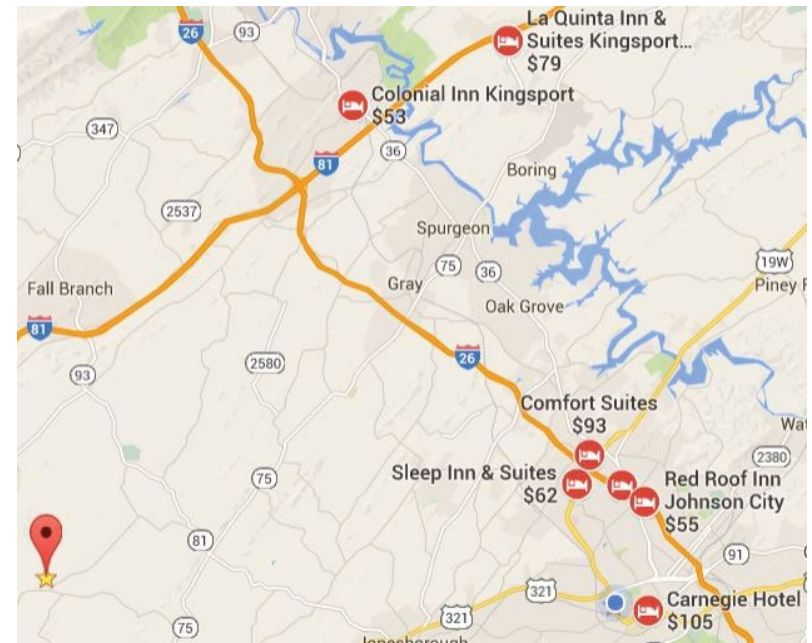
Directions

Expect 20-30 minute travel times from most hotels. Google Maps works well. Verizon has the best cell coverage, but reception on the field may be spotty. **From I-81 (N, E, W) (12 mins): NEVER USE EXIT 44. Take exit 50** for TN-93 south for 1.8 miles. Continue straight onto TN-81 for 2.2 miles. Right on Cherry Hill Rd for .6 miles.

Bear left to Marn Rd. for .9 miles. Right on Glendale for 2.7 miles. **From I-26 (S) (40 mins):** Take exit 37 north on TN-107/TN-81 for about 22 miles. Follow signs for TN-81N through Jonesborough. After passing the Marathon, keep an eye out for a sharp right turn, where you’ll continue straight onto Pleasant Grove Rd. for .8 miles. Turn right onto Glendale Rd for 3.4 miles.
