#### ELIGIBILITY FOR THE INTERNATIONAL INVITATIONAL

Any hound that has earned at least 20 lifetime ASFA points, or equivalent points in its country of residence, or is an AKC or equivalent foreign Field Champion of Record in another lure coursing field trial-sanctioning organization or has placed in a Regional Invitational (with competition) is eligible to enter. Singles and LCI entrants must have earned 20 lifetime ASFA points. Entrants in breed stakes must have earned the 20 lifetime ASFA points running against competition in their specific breed's stake. Points earned in Singles stakes do not count towards eligibility to compete in the breed stakes.

Proof of non-ASFA title and non-ASFA points for hounds should be in the form of a photocopy of the certificate, or page of formal printing, and included with the entry. For a Provisional breed to be eligible, the entry must have one first placement, or two second placements, with competition in the Provisional Stake. All points or placements must be earned by the entry closing date (12<sup>th</sup> of September) of the event

Only purebred Afghan Hounds, Azawakh, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, and Whippets may enter the regular stakes. Provisional breeds may be entered in the Provisional Stake. Provisional Stake breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno) and Portuguese Podengo (Medio and Grande) and must be individually registered by the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), NGA, FCI, UKC or an ASFA recognized foreign or an ASFA approved registry or possess a CRN from SPDBS.

#### **REGULAR STAKES OFFERED**

**OPEN:** Any eligible sighthound that has met certification requirements and a hound must have earned at least 20 lifetime ASFA points or equivalent in its country of residence, or is an AKC or equivalent foreign Field Champion of Record in another lure coursing field trial sanctioning organization or has placed in a Regional Invitational (with competition) prior to the close of entries (12 September 2025).

Hounds that have earned an ASFA Field Championship title are not eligible to enter the Open Stake.

FIELD CHAMPION: Any ASFA Field Champion.

**VETERAN**: Any eligible sighthound that has met requirements to enter the Open or Field Champion stake and that is six years of age or older (5 years for Irish Wolfhounds; 7 years or older for Afghans, Ibizan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets).

**PROVISIONAL:** Any sighthound of an eligible breed that has met certification requirements and has one 1<sup>st</sup> placement or two 2<sup>nd</sup> placements, with competition in the Provisional Stake. Not eligible to compete in Best of Breed or Best in Field.

<u>SINGLES</u>: Any hound otherwise eligible for competition in regular or Provisional stakes, including hounds with breed disqualifications and competition disqualifications, shall be eligible for entry in this stake. Not eligible to compete in Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPS titles from the Singles stake. Provisional breeds are not eligible for these titles.

LURE CHASING INSTINCT (LCI) STAKE: Open to NON sighthounds and sighthound mixes that have earned 20 lifetime ASFA points. All entries shall be individually registered with the AKC (including ILP & PAL) or the UKC or ASFA number.

Small Open: for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

**Small Excellent**: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

**Small Veteran**: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

**Large Open**: for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC. **Large Excellent**: is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC. **Large Veteran**: for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

Sighthound Mix Open: for dogs with a sighthound breed in its background who have not achieved the title of LCC.

Sighthound Mix Excellent: for dogs with sighthound breed in its background who have achieved the title of LCC.

Sighthound Mix Veteran: for dogs over the age of 7 years with sighthound breed in its background.

All entries must be one year of age or older on the day of the Trial.

#### NON-REGULAR STAKES OFFERED (LCI & SINGLES ARE NOT ELIGIBLE)

**BREEDER STAKE:** An entry shall consist of two hounds bred or co-bred by the same individual. Hounds must be entered in one of the regular stakes (Open, Field Champion, Veteran). Scores of the two hounds will be added and the highest combined score will be awarded the Breeder Stake Award.

**KENNEL STAKE:** An entry shall consist of two hounds owned and living with the same person. Hounds must be entered in one of the regular stakes (Open, Field Champion, Veteran). Scores of the two hounds will be added and the highest combined score will be awarded the Kennel Stake Award.

\*Please Note: For Breeder and Kennel Stake: entries may consist of the identical pairing of dogs, but each dog may only be entered once in each stake. Hounds are named at the time of entry.

**<u>GENERATION STAKE</u>**: An entry shall consist of a stud dog OR a brood bitch and one dog produced by that dog. Both must be entered in one of the regular stakes (Open, Field Champion, Veteran) but need not be owned or bred by the same person. Each Stud Dog or Brood Bitch can only be paired with one chosen offspring; however an offspring can be paired with either one or both parents. Scores of the two hounds will be added and the highest combined score will be awarded the Generation Stake Award.

**BENCH CHAMPION STAKE:** For any hound eligible to enter a regular stake, that is an AKC, CKC, or ASFA-approved international show champion of record. A copy of the hound's championship certificate must accompany each Stake entry. The ASFA does not recognize the UKC show champion as of Jan. 1, 2022.

#### Gillette Stake – Saturday Only

The competition will be run following the same procedures as Best in Field. The eligible hound in each breed that receives the highest qualifying combined score during competition in the Field Champion or Veteran Stake on Saturday will be randomly drawn to run in the Gillette Stake. Refer to the eligibility instructions on the Gillette Stake Entry Form.

#### Best in International Invitational – Sunday Only

This competition is run on Sunday, following the same procedures as Best in Field, except that all Best of Breed winners from Saturday and Sunday are eligible to compete provided they have been entered and received qualifying scores, running in prelims and finals, both Saturday and Sunday. The hound that wins Best in International Invitational will be credited with winning a Best in Field.



#### **RUNNING PROCEDURE**

- Stakes will be split into flights, in public view at 5:30 PM, Friday, 10<sup>th</sup> of October, if the entry in any one stake is 20 or more hounds.
- All hounds (except Singles and LCI) will run twice, in trios if possible, or braces unless excused, dismissed or disqualified.
- Hounds not present at roll call will be scratched after a five (5) minute grace period.
- Bitches in season, hounds with breed disqualifications and lame hounds at roll call/inspection will be excused and entry fee refunded.
- Monorchid, cryptorchid, spayed or neutered hounds may be entered.
- Muzzles are not required.
- The Field Committee reserves the right to alter the course plans as required by weather and/or field conditions on the day of the trial.
- A gas/battery-powered continuous loop lure machine(s) will be used on each field.
- Backup equipment will be available.
- The lure will consist of highly visible plastic strips.
- The course will be reversed for the finals and run-offs at the judges' discretion.
- There will be **a \$5 fine** for any loose hound on the field not taking part in a course in progress.
- <u>NO ONE</u>, EXCEPT FIELD COMMITTEE MEMBERS, WILL BE ALLOWED ON THE FIELD WITHOUT EXPRESS PERMISSION OF THE FIELD TRIAL CHAIRMAN.

## NOTICE TO EXHIBITORS

- 2. Be an ASFA Field Champion.
- 3. Be entered in the Field Champion or Veteran Stake on Saturday.

\*The ASFA does not recognize the UKC as a foreign based registry for Bench Champion as of the 1st of January 2022.

Requirements must be met prior to close of entries. Proof of bench title should be in the form of a photocopy or page from formal printing and MUST BE INCLUDED WITH THE ENTRY. NO EXCEPTIONS WILL BE MADE. The Field Trial Secretary must receive a special entry form for the Gillette Stake by the closing date for regular entries. There is no additional fee for an entry in this stake.

Use the entry form provided in this premium list to enter the Gillette Stake.

#### <u>REFUNDS</u>

100% of entry fees will be refunded if a written request is received by the trial secretary on or before the trial closing date. After the trial closes, a refund will be given for ill or injured dog or handler, bereavement, and/or family emergency if the trial secretary is notified by the owner/handler prior to the close of roll call for the trial.

Bitches in season will be fully refunded if the Trial Secretary is notified by the owner/handler prior to the close of roll call for the trial. <u>No refunds will be given if a request is presented</u> <u>after the close of roll call for the trial.</u> Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.


## **Field Conditions**

From the North (Atlanta) avoiding I-75 *The roads are good and there is not much traffic. Be careful on US 27 south of Columbus and the road around Lumpkin, GA, there are often speed traps* I 85 South from Atlanta to Columbus Take exit #21 for I-185 South towards Columbus Exit 1A to US 27 South towards Bainbridge Take US 27/US 84 bypass around Bainbridge Take GA 97/Faceville Highway Turn right onto GA 97 at the top of the ramp Entrance to the field will be about 4.2 miles on the left. Horseshoe Bend Road will be on your right.

From the North (Atlanta) using I 75 I-75 South from Atlanta Take Exit #62, US 319 south from Tifton towards Thomasville Take US 84 West from Thomasville towards Bainbridge Take the US 27 & US 84 bypass around Bainbridge Take exit for GA 309 Turn right onto GA 309 at the top of the ramp At the light, turn left onto GA 97/Faceville Highway The entrance to the field will be about 4.2 miles on the left and Horseshoe Bend Road will be on your right.

From South (Tallahassee)

Take I-10 west to Exit #192, US 90 west towards Quincy Go approximately 12 miles on US 90 west to Quincy In Quincy, at the square, turn right at the 3<sup>rd</sup> light onto Adams Street, which becomes FL 267 At the GA state line the road becomes GA 301. Keep going straight, be careful not to turn onto Spur GA 302 Merge onto the Faceville Highway – GA 97 north (GA 302 ends) Continue another 5.8 miles on the Faceville Highway to entrance to the field on right – between mile marker 16 & 17. Horseshoe Bend Road will be on your left. (Approximately 18.8 miles from Quincy)

# MAKING THE FTS' LIFE BEARABLE

These are some things to consider when completing and sending in your entries which will be most helpful to the FTS and make the job a little easier. Thanks!

An easy online entry and reservation portal is available for use for this event at the following URL: https://form.iotform.com/251426453325150

You can do all your entries, make reservations for many things and more, Exhibitors are strongly encouraged to take advantage of this simple system that makes it easy to pay for everything with your credit card or PayPal account. It also slashes the data entering effort for the FTS and those that prepare the catalogue.

If you prefer to process your entries and reservations via snail mail please follow these guidelines carefully:

\*\* Be aware of the closing date! EVERYTHING is due on or before the 12<sup>th</sup> of September 2025. Please check and make sure that you have included all applicable forms and documents with a check made out the ASFA or PayPal for the total.

\*\* Please write clearly – the accuracy of information in the catalogue depends on being able to correctly spell your hound's name and your name.

\*\* Please include your phone number and e-mail address in case there are questions. E-mail is preferable.

\*\* If you are using preprinted entries for your dogs, double check that all the necessary information is included such as stake, sex etc. Be sure that the top of the entry form has the following:

47<sup>th</sup> ASFA International Invitational

The date (Saturday, 11 October 2025 or Sunday, 12 October 2025)

\*\* If your dog has multiple titles, please put a comma between each title so that it can be put into the catalogue accurately.

\*\* Be sure your entries are signed.

\*\* For Kennel, Breeder and Generation stakes, it is much easier if the regular entries for all the dogs entered in kennel, breeder or generation stakes are included in the same envelope. For example, you want to enter breeder stake and a different person owns one of the dogs you want to enter, if you could co-ordinate your entries to be sent in together that would be ideal. Be sure to include the applicable payment of \$10 per each Kennel, Breeder or Generation Stake per day. \*\* For the Gillette stake, please <u>attach the proof of Championship to the Gillette</u> <u>Stake entry form</u> and be sure they qualify for ALL of the requirements. They are listed at the top of the Gillette stake entry form.

\*\* For the Bench Stake be sure to check the appropriate box on the entry form AND fill out the form and <u>include a copy of the hound's Championship certificate with the entry.</u> Be sure to add the \$10 fee for each day with your entry.

\*\* When you put your entries in the envelope, please take a moment to cut the entry forms apart so they are separate; it is very time consuming for the FTS to have to cut or tear apart entries. (Often when entry forms are left on one sheet one entry's information tends to be over-written onto another.)

\*\* Put all the entries for Saturday together and then the ones for Sunday in the order of Open, FCh. then Veteran for each day.

\*\* Check your entries again to be sure all the information is accurate and complete, especially if you are completing them at the last minute. <u>All entry forms must be  $5\frac{1}{2}$ " X  $8\frac{1}{2}$ ".</u>

\*\* If you do send your entries overnight, please be sure it <u>does NOT require a</u> <u>signature.</u> You'll need to check the box on the address label for no signature required. Please do NOT send entries by CERTIFIED MAIL as this does require a signature. Entries sent via mail that requires a signature will not be accepted.

\*\* Plan to send in or process your entries <u>well</u> before the deadline so they can be checked and if there are questions, they can be answered. You can well imagine the huge amount of entries that would have to be processed if everyone mailed the week before the closing.

\*\* Use the worksheet to help figure the total amount of your payment. <u>Please use</u> <u>the worksheet even if you are only sending in an entry for one dog.</u> The worksheets are used as a quick reference for questions.

\*\* If you want to confirm receipt of your entry, please enclose a stamped, selfaddressed envelope or post card that can be dropped in the mail. Please do not email the FTS asking if an entry has been received.

\*\* Please note that if you need to change the stake of your entry please notify the FTS before the trial, preferably by Monday, 6<sup>th</sup> of October 2025. These changes will not appear in the catalogue.

\*\* If you need to substitute for a lame or in season hound, the FTS needs to be notified no later than Monday, the 6<sup>th</sup> of October 2025. There will be no substitutions on the day of the trial. These changes will not appear in the catalogue.
