Late/incomplete/unsigned/unpaid/conditional entries will not be accepted.

BREEDS AND ELIGIBILITY: Only purebred Ibizan Hounds.

All entries shall be individually registered with the AKC (including ILP & PAL), the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

ENTRIES WILL NOT BE ACKNOWLEDGED BY MAIL: Late, incomplete, unsigned, unpaid/conditional entries will not be accepted. Substitutions may be made for hounds lame or in season prior to roll call.

STAKES OFFERED:

Open: Any eligible Ibizan Hound that has met certification requirements, excluding ASFA Field Champions of Record.

Field Champion: Any ASFA Field Champion Ibizan Hound.

Veteran: Any eligible Ibizan Hound 7 years of age or older that has met certification requirements. Points & placements go toward V-FCH & V-LCM titles.

Single: Any eligible Ibizan Hound including those disqualified to run in other stakes. Not eligible for Best of Breed. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles

Best in Field will not be offered.

Conditions of Entry: All entries must be one year or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified. Hound certification runs will be offered following the trial, weather and equipment permitting.

NOTE: CHAPTER II, SECTION 2.9 WILL BE STRICTLY ENFORCED:

any hound that exhibits uncontrolled aggressive behavior will be excused from the field; a penalty fee of \$5 will be collected from the owner or agent of any hound that is loose on the field when not in competition.

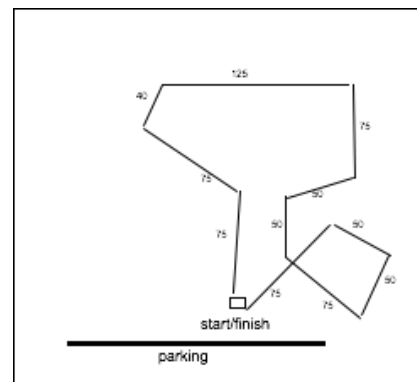
