US 27 & US 90 East of Tallahassee, can reach field by taking Chaires Crossroad, Crump Road & Roberts Road. Turn right on Centerville, entrance on your right before reaching the farm managers driveway.

From Capital Circle NE, take Centerville Rd. 5.9 miles, past Roberts/Bradfordville intersection entrance on your right before reaching the farm managers driveway.

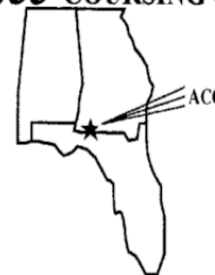

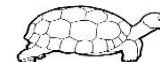

Additional information

Kathy Archibald has once again graciously offered us the use of this beautiful field northwest of Tallahassee. Please take the time to thank her if you get the opportunity. For those of you joining us at this lovely site, the field is approximately 15 acres, generally flat & open yet still undulating, covered in dense grass. It is bounded on 3 sides by fences (2 adjacent to roads) & on the 4th by a tree line, but it should not be considered absolutely dog proof. A barbed wire strand tops the heavy vegetated fences & runs through the tree line, but the courses will stay away from this.

Running water & portable toilets are available. Parking will be on field.

Prior to entering the gate off of Centerville Rd., ensure that NO hounds are running before you open the gate to drive onto the field, after driving through the gate CLOSE the gate behind you.

We ask that everyone attending restrict themselves to the coursing field & parking areas. Plastic tape & signs will be posted to indicate closed areas including inside the barn.

Dogs may not be walked along the back side of the tree line, do not enter the old dog walk area.

Please be considerate & CLEAN UP AFTER YOUR HOUNDS & PICK UP YOUR CIGARETTE BUTTS. Thank you, we hope you enjoy the event & weekend!

Trial hours: 8 AM Saturday & Sunday until complete, trial roll call 9 AM Saturday & Sunday. Entries will NOT be acknowledged by mail. Early entries, with payment must be received no later than February 28, 2018. No phone entries, late, unsigned, incomplete or conditional entries will be accepted.

Eligible breeds & registry

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Silken Windhounds, Salukis, Scottish Deerhounds, Sloughis, and Whippets may be entered in the regular stakes. Limited breeds include purebred Chart Polski, Galgo Espanol, Magyar Agar, Peruvian Inca Orchid, Portugese Podengo (Pequeno), Portugese Podengo (Medio & Grande), and must be individually registered with the appropriate registry. All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS or an AKC SC title, a photocopy of acceptable registry must be submitted with each hounds first ASFA field trial entry; this requirement is waived for hounds registered with the NGA. All hounds will be checked for breed disqualifications. Late, conditional, unsigned, incomplete or unpaid entries will not be accepted.

Stakes Offered

Open - any eligible sighthound that has not met certification requirements, excluding ASFA Field Champion of record.

Field Champion - any ASFA Field Champion.

Veteran – any eligible sighthound whose age is at least 6 years, except Irish Wolfhounds whose age shall be at least 5 years; and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least 7 years. Points go toward V-FCH or V-LCM titles.

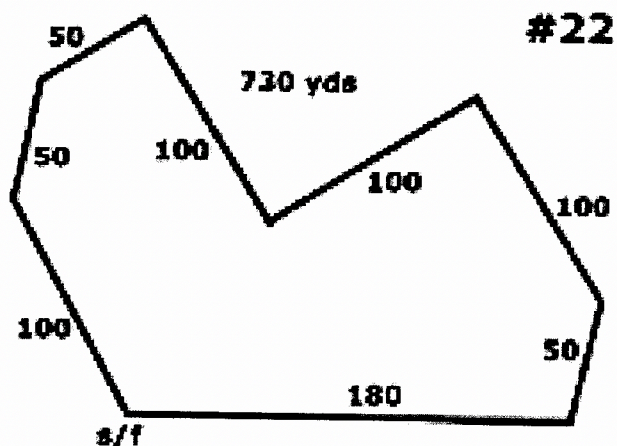
Singles – any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for BOB or BIF. Hounds are eligible to earn TCP or CPX titles from the singles stakes. Limited breeds are not eligible for these titles.

Limited - any eligible sighthound of a limited or provisional stake breed that has not met certification requirements. The winner of this class is not eligible to compete in BOB and/or BIF event courses.

BIF – offered on Saturday. **BIF** – will not be offered on Sunday.

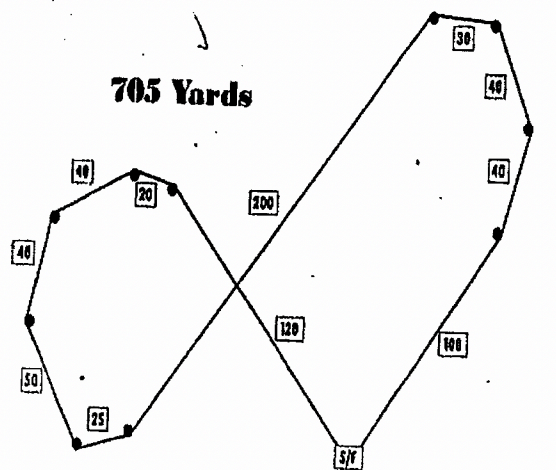
Conditions of Entry

All entries must be 1 year or older on the day of the trial. Stakes will be split if entry in any 1 stake is 20 or more at the time of the draw. Bitches in season, hounds with breed disqualifications and lame hounds will be excused, and entry fee refunded if refund is requested. All hounds will be checked for breed disqualifications; spayed, neutered, monorchid or cryptorchid hounds w/o breed disqualifications are eligible. Hounds with breed disqualifications are not eligible to enter except in the single stake. Hounds not present at the time of roll call will be scratched. Hounds will run twice in trios, if possible, or in braces unless excused, dismissed or disqualified. A \$5.00 fine will be imposed for any loose hound on the field not competing in the course in progress. A battery-powered continuous loop lure system will be used. Spare equipment will be on hand. The lure will consist of highly visible white plastic strips.

The courses will be reversed for finals, and again for run-offs and BOB. ACC reserves the right to alter course plans as required by weather and/or field conditions on the day of trial.

Hound certification & practice runs

The Robert Nix Perpetual Trophy is offered annually by ACC at its spring field trials in recognition of the contributions to the sport of lure coursing by photographer Robert Nix and in memory of Les Pekarski, who donated the trophy to ACC. The BIE winner's name, hound name and breed along with the date is inscribed on the trophy, but the trophy is kept by ACC.

To be eligible to compete for the Nix trophy, your hound must meet these requirements: must compete on Saturday & Sunday, must receive a qualifying score each day in prelims & finals, must have won BOB on/at least Saturday or Sunday. Best in Event is run on Sunday after all breed run-offs.

Hound certification & practice runs

ACC will hold hound certifications Saturday morning before competition begins & after the trial; then practice, weather, time & equipment permitting. You must have a sighthound with similar running ability available to run with the hound attempting to be certified. ACC recommends that new hounds be practiced alone as well as with other hounds before attempting a certification run. Sighthound certification cost \$10.00 per hound. Practice cost \$3.00 per dog.
