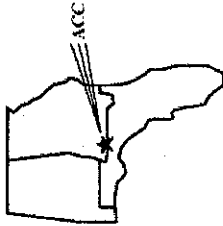

**DIRECTIONS:**

**From I-10:** Take Exit #203 (Old 30), Thomasville Rd., US 319, North 4.5 miles; turn right at the traffic light on Bradfordville Rd, go 3.8 miles to Centerville Rd., turn left onto Centerville Rd, entrance will be on your right before reaching the farm managers driveway.  
**From Georgia via US 319:** Just after crossing the state line, Highway 12 breaks off on the right; stay on 319, continue south 8.3 miles to Bradfordville Rd., on left (just past Publix shopping center); turn left, go 3.8 miles to Centerville Rd., turn left onto Centerville Rd, entrance will be on your right before reaching the farm managers driveway.  
**US 27 and US 90 east of Tallahassee:** Can reach field by taking Chaires Crossroad, Crump Road, and Roberts Road. Turn right onto Centerville Rd, entrance on your right before reaching farm managers driveway.  
**From Capital Circle NE:** Take Centerville Rd., 5.9 miles to Roberts/Bradfordville crossing, continue on Centerville. Entrance on your right before reaching farm managers driveway.

## ADDITIONAL INFORMATION

Kathy Archibald has once again graciously offered us the use of this beautiful field northeast of Tallahassee. Please take the time to thank her if you get the opportunity. For those of you new to joining us at this lovely site, the field is approximately 15 acres, generally flat and open yet still undulating, covered in dense grass. It is bounded on three sides by fences (two adjacent to roads) and on the fourth by a tree line, but it should not be considered absolutely dog proof. A barbed wire strand tops the heavily vegetated fences and runs through the tree line, but the courses will stay well away from this.

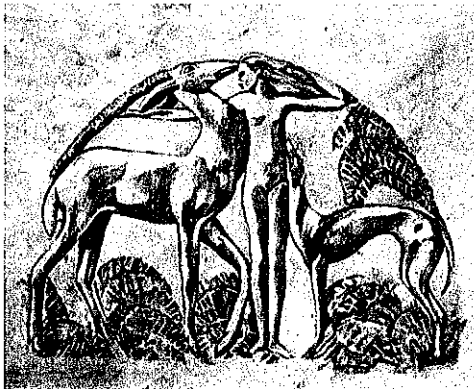
Running water and a portable toilet are available. No camping on site will be permitted.

**NOTICE: New entry to the field! Do not enter via farm manager's driveway, see directions on front cover.** Parking will be along the fenceline below the barn if soft ground is not an issue. If conditions are wet, watch for guides to firmer ground. Once the trial begins, entry and exit to the field will be controlled by the field committee. Do not open the gate to enter or leave if hounds are running without clear signal from the field committee.

We ask that everyone attending restrict themselves to the coursing field and parking areas. Plastic tape and signs will be posted to indicate closed areas (including inside the barn). Dogs may be walked along the back side of the tree line or throughout the parking areas. Please be considerate and **CLEAN UP AFTER YOUR HOUNDS and PICK UP YOUR CIGARETTE BUTTS.** Thank you, and we hope you enjoy the event and weekend.

All hounds entering Open, Veteran, or Limited Stakes for the first time **MUST** include a completed ASFA certification form or waiver form and a copy of the hound's registration certificate (registration is not required for NGA Greyhounds **ONLY**; certification waiver is not required for Singles Stake entries **ONLY**).

Trial Hours: 7:00 a.m. Saturday and Sunday until complete. Trial Roll Call 8:00 a.m. Saturday and Sunday.

Entries will NOT be acknowledged by mail.

Early Entries, with payment, must be received no later than February 27, 2013. No phone entries, late, unsigned, incomplete or conditional entries will be accepted.

### ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzois, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Whippets, and Provisional Breeds may be entered in the regular stakes. Current Provisional breed: Silken Windhound. Limited Breeds may be entered in the Limited Stake or the Singles Stake. Limited Breeds currently included purebred Chart Polski, Galgo Espanol, Magyar Agar, Peruvian Inca Orchid, Portugese Podengo (Pequeno), Portugese Podengo (Medio & Grande), and must be individually registered with the appropriate registry. All entries shall be individually registered with the AKC, (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

### STAKES OFFERED

**OPEN:** Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

**FIELD CHAMPION:** Any ASFA Field Champion.

**VETERAN:** Any eligible sighthound that is at least 6 years of age or older (5 years for Irish Wolfhounds, 7 years for Afghan Hounds Rhodesian Ridgebacks & Whippets), that has met certification requirements.

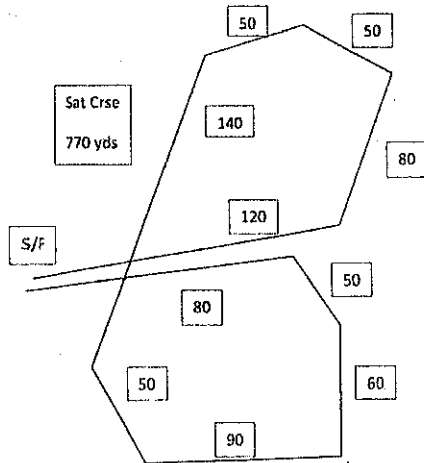
**SINGLES:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited Breeds are not eligible for these titles.

**LIMITED:** Any eligible sighthound of a Limited or Provisional stake breed that has met certification requirements. The winner of this class is not eligible to compete in Best of Breed and/or Best in Field / Event courses.

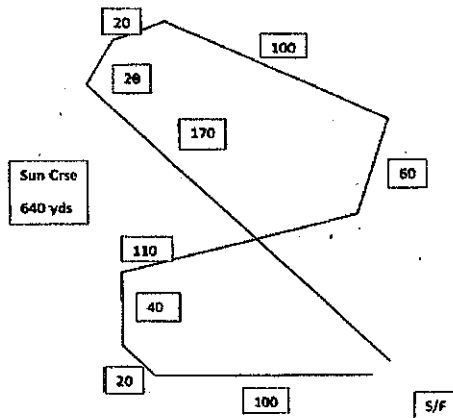
**BEST IN FIELD:** Offered on Saturday. **BEST IN FIELD:** Will not be offered on Sunday.

### CONDITIONS OF ENTRY

All entries must be one year of age or older on the day of the trial. Stakes will be split if entry in any one stake is 20 or more at the time of the draw. Bitches in season, hounds with breed disqualifications, and lame hounds will be excused and entry fee refunded if refund is requested. All hounds will be checked for breed disqualifications; Spayed, neutered, monorchid or cryptorchid hounds w/o breed disqualifications are eligible. Hounds with breed disqualifications are not eligible to enter except in the Single Stake. Hounds not present at the time of roll call will be scratched. Hounds will run twice in trios, if possible, or in braces unless excused, dismissed, or disqualified. A \$5.00 fine will be imposed for any loose hound on the field not competing in the course in progress. A battery-powered continuous loop lure system will be used. Spare equipment will be on hand. The lure will consist of highly visible, white plastic strips.



The courses will be reversed for the finals, and again for run-offs and BOB. The club reserves the right to alter the course plans as required by weather and/or field conditions on the day of the trial.

The Robert Nix Perpetual Trophy is offered annually by ACC at its spring field trials in recognition of the contributions to the sport of lure coursing by photographer Robert Nix. The Robert Nix Trophy was donated to ACC by Les Pekarski. Pictured below is last year's winner, Am GCH, Can Ch Shaldras Rags to Riches, owned by Kyle Sebiunouie, pictured with Ron & Cheryl Bigford serving as agents. .



To be eligible to compete for the Nix Trophy, your hound must meet these requirements:  
Must compete on Saturday and Sunday; must receive a qualifying score each day in prelims and finals; must have won Best of Breed on at least Saturday or Sunday.  
Best in Event is run on Sunday after all breed run-offs.

The winner of the Nix Trophy is allowed to keep the trophy until the following year's spring ACC field trials.

*The Robert Nix Trophy was presented to ACC by Comet Sighthounds (Les Pekarski). ACC is enlarging its base so we may continue to award it in Les Pekarski's name, the Grand Old Man of Lure Coursing. It's the least we can do for a great man, a legend, a friend.*

**HOUND CERTIFICATION AND PRACTICE RUNS**

ACC will hold Hound Certifications Saturday morning before competition begins and after the trial, then Practice, weather, time, and equipment permitting. You must have a hound with similar running ability available to run with the hound attempting to be certified. ACC recommends that new hounds be practiced alone as well as with other hounds before attempting a certification run. Hound Certification cost \$10.00. Practice cost \$3.00.
