### **Ribbons, Rosettes and Trophies**

Rosettes will be awarded for first thru NBQ In Open, FCh, and Vet Stakes: first place blue; second red; third yellow; fourth white; NBQ dark green. High scoring Single: navy and gold rosette. Singles 1st thru NBQ: Placement ribbons. Best of Breed: purple and gold rosette. The Brahma II Cup Trophy and ASA Medallion will be awarded to high scoring ASA owned saluki.

### **Eligible Breed & Registry**

Only purebred Salukis that are one year of age or older on the day of the trial may be entered. All entries shall be individually registered with the American Kennel Club (ILP/PAL included), the United Kennel Club, the Federation Cynologique Internationale, and ASFA-recognized foreign or ASFA board approved registry, or possess a CRN from the Society for the Perpetuation of Desert Bred Salukis.

### **Stakes Offered**

**Open:** any eligible Saluki that has met the certification requirements at the time of closing, excluding ASFA Field Champion Salukis of record

**Field Champion:** any ASFA Field Champion Saluki

**Veteran Stake:** Any eligible Saluki whose age exceeds 7 years, who has met certification requirements at the time of closing. Points and placements go to a V-FCh or V-LCM title.

**Single:** Any eligible Saluki including those disqualified from other stakes. Each Saluki runs alone. Not eligible for Best of Breed competition or Brahma II Cup Trophy and ASA Medallion. Salukis are eligible to earn TCP and CPX titles from this stake.

**Conditions of Entry:**

\*All entries must be one year old not the day of the trial. \*Stakes will be split into flights by public random draw if the entry in any stake exceeds 20 hounds. \*Salukis not present at roll call will be scratched. \*Bitches in season and lame Salukis will be excused at roll call & entry fees refunded. No other refunds will be given. \*Spayed, neutered, monorchid, and cryptorchid salukis may be entered. \*All hounds will run twice, in trios if possible (except for the Singles Stake) unless excused, dismissed or disqualified.

**First time entries:** The entry for each hound entering the Open Stake or Veteran Stake for the first time MUST include a completed and signed ASFA Certification Form or Waiver Form (with proof of title) AND a copy of the hound's registration certificate. (Certification is waived for Singles Stake entries only).

**Equipment:**

A gas-powered or battery-powered continuous loop machine will be used. Back up equipment will be available. The lure will consist of plastic strips.

Incomplete, unsigned, conditional, or late entries will NOT be accepted. Substitutes for lame or in-season hounds are allowed if the substitute has the same owner and the Field Trial Secretary is notified by the applicable Roll Call day and time.

Owners must keep their hounds under control and clean up after them. A \$10 fine will be assessed for any hound loose on the field not competing in the course in progress. Any person may be asked, upon reasonable complaint, to leave the grounds of the field trial by the Field Trial Committee.

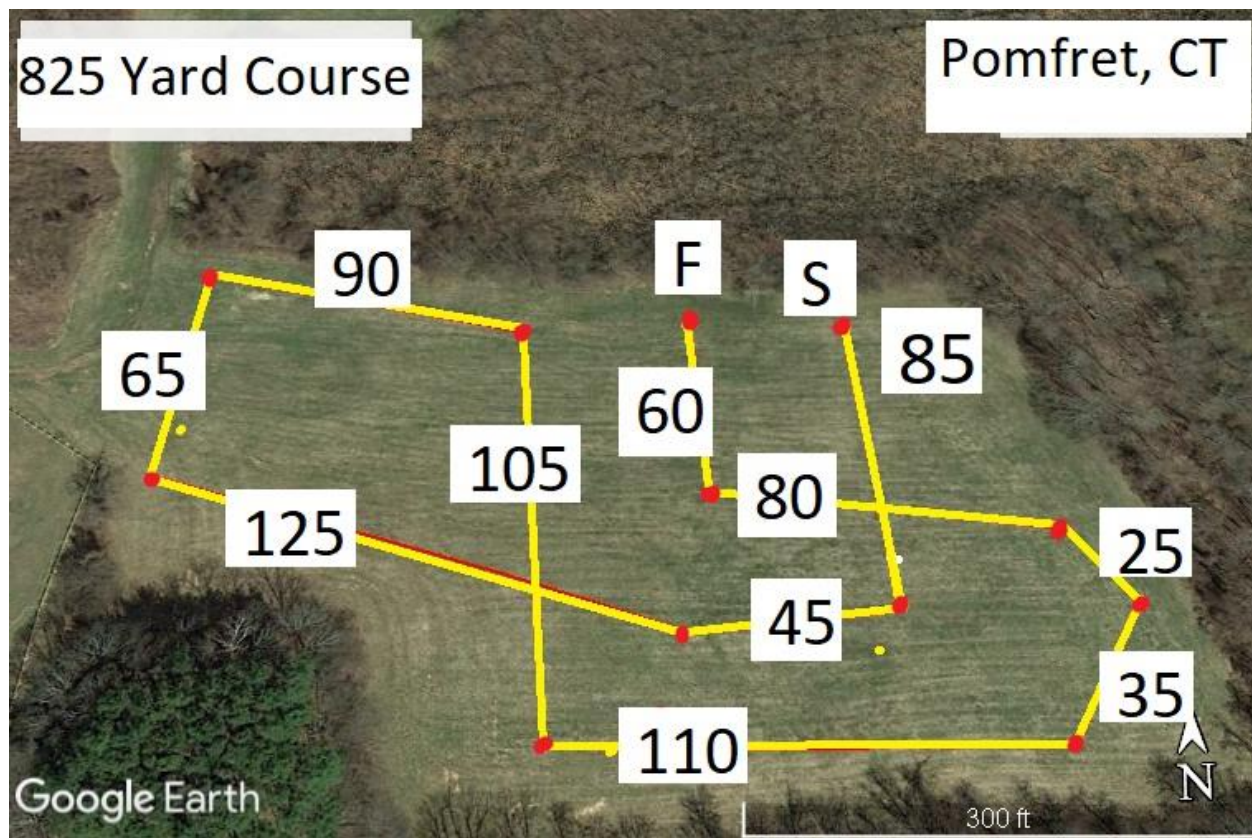

**DIRECTIONS to FIELD**

From Rt 90 (MA Pike). Go east on Rt 90 toward Boston for 27 miles. Take Exit 9 to merge onto I-84. In 1 mile take exit 3B onto US-20 W. Go 0.7 miles and turn left. In 4.4 miles, at roundabout, take first exit onto E Main St. In 0.6 miles, keep right onto N Woodstock Rd. Continue 3.2 miles to Route 169. Go 7.3 miles and turn right ... onto Rt 169. The destination is 1.5 miles ahead on the left.



The course will be reversed for finals, tie run-offs and BOB. ASA reserves the right to alter the course as required by weather and/or field conditions.

### **The BRAHMA II CUP**

***Eligibility Requirements:*** any hound eligible to earn the Brahma II Cup and ASA medallion must be owned by an American Saluki Association member in good standing at the time of roll call. ASA Membership applications will be available prior to roll call at the FTS table. Bring a check for \$62.50/ASA membership dues. Under no circumstances can a non ASA owned Saluki win the Brahma II Cup or ASA Medallion.

The Brahma II Cup and ASA Medallion will be awarded to the high scoring ASA owned Saluki from the Open, Field Champion, or Veteran Stake. Salukis entered in the Singles stake are *not* eligible to compete for the Brahma II Cup and ASA Medallion.
