ELIGIBLE BREEDS & REGISTRY

Only purebred Irish Wolfhounds may be entered in regular stakes.

All entries shall be individually registered with AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial.

The entry for each hound entering the Open or Veteran Stake for the first time MUST include a completed & signed ASFA Certification Form, AKC QC or Wavier Form (with proof of title) and a copy of the hound's registration certificate.

STAKES OFFERED

OPEN STAKE: Any eligible Irish Wolfhounds, excluding ASFA Field Champions of record that has met the certification requirements.

FIELD CHAMPION STAKE: Any Irish Wolfhounds ASFA Field Champion.

VETERAN STAKE: Any eligible Irish Wolfhounds whose age shall be at least five years, That has obtained an ASFA certification, AKC QC, or other qualifying waivers prior to the closing date. A copy of the certificate MUST be submitted with the entry forms. Points go toward V-FCh or V-LCM title.

SINGLES STAKE: Any eligible Irish Wolfhounds including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

NON-regular Stake: Must be designated at the time of entry

KENNEL STAKE: An entry shall consist of two Irish Wolfhounds, owned, and kenneled by the same person.

BREEDER STAKE: An entry shall consist of two Irish Wolfhounds bred by the same individual. **BENCH STAKE:** For Irish Wolfhounds with <u>proof on file</u> with ASFA of a conformation champion title from the AKC, CKC or both or a conformation grand champion title from the UKC.



McKinney is located approximately 33 miles northeast of downtown Dallas via U.S. Highway 75 (North Central Expressway). From U.S. Highway take the Highway 75, take the Highway 308 exit and head West approximately 2.5 miles until you reach FM 1461. Turn right (NORTH) on FM 1461 and travel approximately 3.8 miles to County Road 166. Turn right (NORTH) on County Road 166. Go about a mile. You will see the MPEC on your left. DO NOT TURN IN.
