Stakes Offered (Regular Stakes)

<u>Open</u>: Any eligible Whippet that has met certification requirements, excluding ASFA Field Champions of record. The hound certification will be waived for a hound that has earned a lure coursing title from another recognized organization, if such title requires competition, and if a waiver for such title has been approved by the ASFA. If first time entered hound—proof of title and waiver form must accompany entry.

Field Champion: Any ASFA Field Champion Whippet

Veteran: Any eligible Whippet that has met certification requirements whose age is at least 7 years.

<u>Singles</u>: Any eligible whippet, including those disqualified to run in other stakes. Singles entries are not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Entries in the Singles Stake are **LIMITED TO THE FIRST 15 SINGLES TO ENTER.** No first time entered dogs are allowed to enter the Singles Stake.

Non-Regular Stakes Offered (\$10 each entry)

<u>Kennel</u>: For two Whippets, designated <u>at the time of entry</u>, each entered in one of the regular stakes, owned and kenneled by the same person.

<u>Breeder</u>: For two Whippets, designated <u>at the time of entry</u>, each entered in one of the regular stakes, bred by the same person.

ASFA Operational Policy:

O-TRIALS41--An owner may have more than one entry in a Kennel or Breeder Stake as long as the two hounds comprising each entry are properly identified at the time of the entry. <u>A hound may be part of only one Kennel and one Breeder entry</u>.

Bench: an entry shall consist of a single whippet with proof on file with the ASFA of a conformation champion title from the AKC, CKC or both or a conformation grand champion title from the UKC. (Proof of championship must accompany entry. A printed copy of the certificate is acceptable.)

Dual Champion: For ASFA FCh Whippets that have been awarded the AKC Bench Championship by the closing date of entries. The championship status of the winner must be verifiable. (There is no charge for this entry)

<u>Generation</u>: Each entry in this stake shall consist of a stud dog OR a brood bitch and one dog produced by that dog. Both dogs must be entered in a regular stake but need not be owned or bred by the same person. Each Stud Dog or Brood Bitch can only be paired with one chosen offspring; however, an offspring can be paired with either one or both parents.

**In <u>all non-regular stakes</u> there will be only one winner with no championship points awarded.

Use a separate form for each entry in each of the above stakes!

RIBBONS

Rosettes will be offered for placements in each Stake: 1st Blue, 2nd Red, 3rd Yellow, 4th White, NBQ Green, and High Scoring Singles—Navy/Gold

CONDITIONS OF ENTRY

- All Whippets must be one year or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call (unless entered in the Singles Stake) and entry fee refunded.
- Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- Whippets with breed disqualifications are not eligible to enter.
- Whippets not present at the time of roll call will be scratched. No refund will be issued.
- All Whippets will run twice, in trios if possible or braces, unless excused, dismissed, or disqualified.
- Battery or gas powered, continuous loop lure machines will be used. The lure will consist of black or white plastic strips and/or skins. Back up equipment will be available.
- The members of the field committee reserve the right to alter the course plan as required by weather and/or field conditions on the day of the trial.
- There will be a \$5 fine assessed for any loose hound not taking part in a course in progress.
