Eligible Breeds:

This is a Cirneco dell'Etna specialty trial.

General Information:

All entries shall be individually registered with the AKC, the UKC, the FCI, an ASFArecognized foreign or ASFA Board approved registry. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry.

Stakes Offered:

OPEN STAKE – Open to Cirnechi excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE - Any Cirnechi ASFA Field Champion of record.

VETERAN STAKE – Any Cirnechi whose age is at least six years. Points go toward V-FCh or V-LCM titles.

SINGLE STAKE – Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

Conditions of Entry:

Hounds must be one year or older on the day of the trial. All hounds will run twice, in trios if possible or braces (except in Single Stake), unless excused, dismissed or disqualified. Bitches in season and lame hounds will be excused. Hounds not present at the time of roll call will be scratched after a five-minute grace period. Each entry will be examined at inspection for breed disqualifications. Hounds determined to have a breed disqualification at the time of roll call are not eligible to enter except in the Single Stake. Spayed, monorchid, cryptorchid, and neutered hounds without breed disqualifications may be entered. Regular stakes will be split if 20 or more entries are present in any one stake at the time of the draw. Any hound that displays aggressive behavior during trial hours will be excused for the day. A penalty of \$5 will be assessed for any loose hound not competing in the course in progress.



Equipment & Field Information:

Terrain is natural field with uneven ground. Hounds need to be in top physical condition due to the high elevation. Battery powered continuous loop machine will be used. Backup equipment will be available. Lure will consist of white and or black plastic strips. USRCC reserves the right to alter the course diagram as required by weather and/or field conditions on the day of the trial.

Course Plan:

The course is 670 yards, reversed for finals, BOB direction at the discretion of the judge.



Trial Information:

The second running of the Cirneco Caccia (hunt) Classic ASFA Specialty is a dream of the original Cirneco owner in Utah, Janie Hale, and made possible through the support of USRCC and its members. We are excited to be hosting this trial and to gather breeders and friends from across the West and Mid-West holding most of the top 10 annual ranking Cirnechi in ASFA.
