#### Eligible Breeds and Registry

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgeback, Salukis, Scottish Deerhounds, Sloughis, Whippets and Provisional breeds (if any) may be entered in regular stakes.

Current Provisional Breed: Silken Windhound

Limited stake breeds, if any, may be entered in the Limited Stake. Limited breeds include purebred Chart Polski, Galgo Espanol, Magyar Agar, Peruvian Inca Orchids, Portuguese Podengo.

All entries shall be individually registered with the American Kennel Club, National Greyhound Association, the United Kennel Club, the Federation Cynologique, an ASFA recognized foreign or ASFA Board approved registry or possess a Critique Registration number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). Dogs

with an Indefinite Listing Privilege (ILP) or a Purebred Alternate Listing (PAL) from the American Kennel Club shall be considered registered with that body. Limited and/or Provisional stake breeds shall be individually registered with the appropriate registry. A photocopy of acceptable registry must be submitted with each hound's first ASFA trial entry; this requirement is waived for hounds registered with the National Greyhound Registry.

**HOUND CERTIFICATIONS WILL BE RUN** before the start of the trial. Owners are responsible for finding their hound's running partner. After Certification, hound's can be entered for that day in Open/Single/Limited Stake at the day of entry fee of \$20.00

#### STAKES OFFERED:

**OPEN STAKE:** Any eligible sighthound, excluding ASA Field Champions of record, that have met the ASFA certification requirements.

**FIELD CHAMPION STAKE:** Any ASFA Field Champion

**VETERAN STAKE:** Any eligible hound whose age is at least 6 yrs, except Irish Wolfhounds whose age shall be at least 5 yrs, and Afghan hounds, Rhodesian Ridgebacks and Whippets whose age shall be at least 7 yrs. Points go toward V-FCh or V-LCM titles.

**SINGLE STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are now eligible to earn TCP and CPX titles from the Single Stake. Limited breeds are not eligible for these titles

**LIMITED STAKE:** Any eligible sighthound of a Limited or Provisional stake breed that has not met certification requirements. Not eligible for Best of Breed or Best in Field.

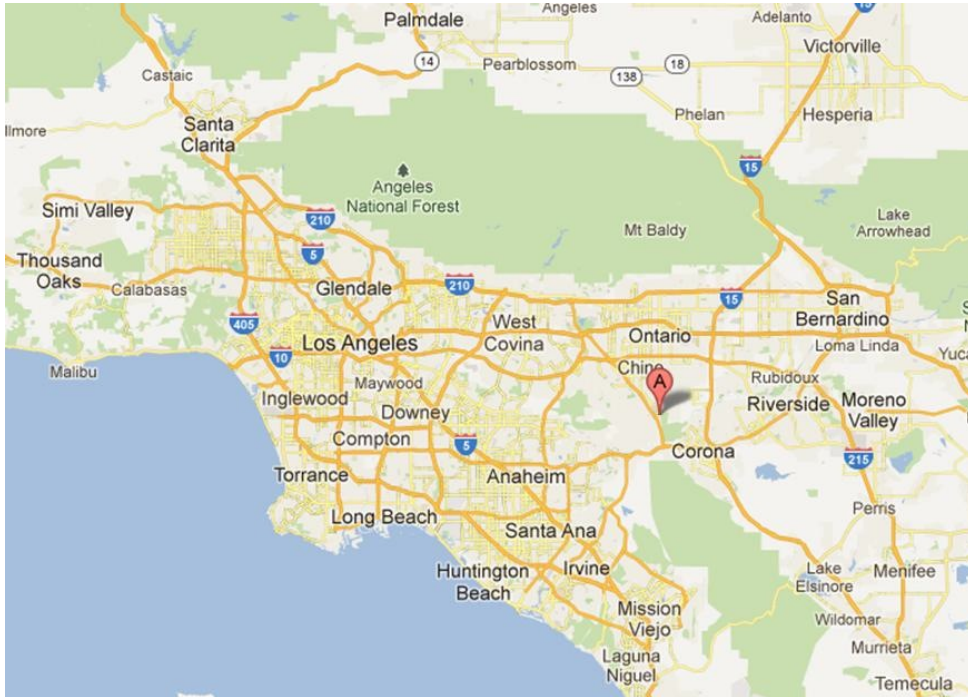
#### **BEST IN FIELD WILL BE OFFERED**

**Conditions of Entry:** All entries must be one year or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. Bitches in season, lame hound and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in Single Stake. Hounds not present at roll call will be scratched. All hounds will run twice, in trios if possible or braces (except in Single Stake) unless excused, dismissed or disqualified. Greyhounds shall run in braces-if not possible, a course shall be run as a trio. **Equipment:** Battery-powered continuous loops system with highly visible white plastic strips.

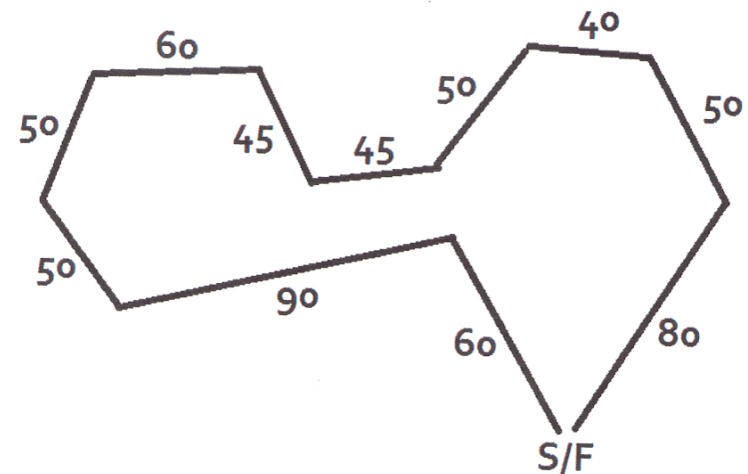
## PARK ADMISSION - IMPORTANT
