Turn LEFT onto TX-195 N and travel 16 miles to Stan Schlueter Loop / FM-3470 ramp. Turn RIGHT onto Old Florence Rd / FM 3470 and go 1.9 miles, then turn LEFT onto S W S Young Dr. The clinic is 1.4 miles down the road

ELIGIBLE BREEDS AND REGISTRIES

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, Whippets, and Provisional breeds may be entered in the regular stakes.

Limited breeds may be entered in the Limited Stake or the Singles Stake.

Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

STAKES OFFERED

OPEN: Any eligible sighthound, excluding ASFA Field Champions of record, that has met certification requirements.

FIELD CHAMPION: Any ASFA Field Champion.

VETERAN: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

SINGLES stake: any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles Stakes. Limited breeds are not eligible for these titles.

LIMITED stake: Any eligible sighthound of a Limited or Provisional stake breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

BEST IN FIELD WILL NOT BE OFFERED

Conditions of Entry: All entries must be one year or older on the day of the trial

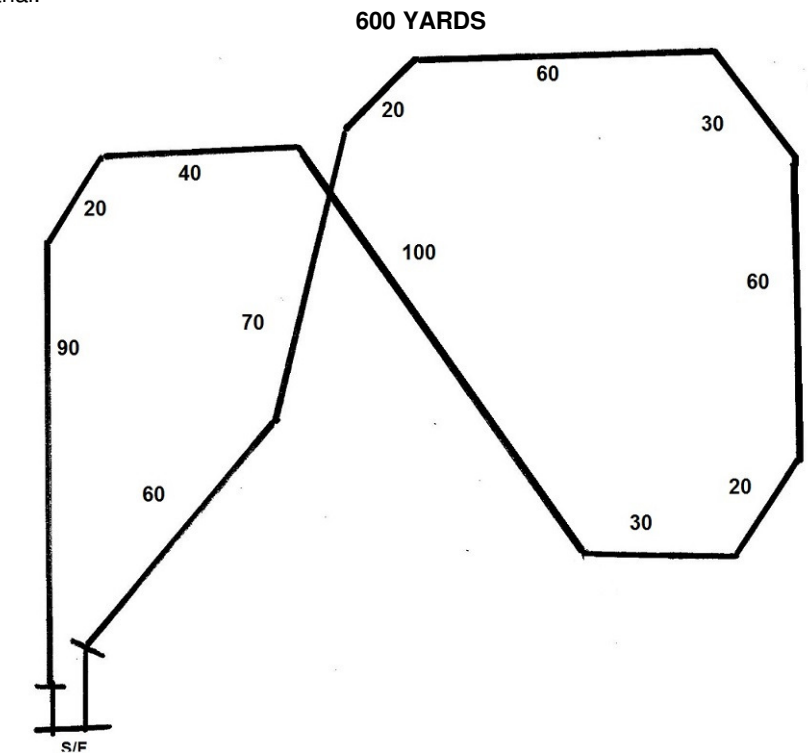
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake
 - Hounds not present at the time of roll call will be scratched
 - All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

Equipment: Type of lure machine: generator-powered continuous-loop system.

- Type of lures: highly-visible white plastic strips
- Back-up equipment will be available.

COURSE PLANS

Course will be reversed for finals. Run-offs and direction will be determined at the judge's decision. AHCoA reserves the right to alter the course as required by weather or field conditions on the day of the trial.

NOTICE TO ALL EXHIBITORS

- The pasture field has no shade available. Flush toilets are available. Please ensure your comfort and the comfort of your hounds by bringing your own portable shade/shelter and water.
- This event is on rural ranchland.
- There is no food vending on site. The closest eateries are approximately 12 miles away
- Each hound requires an individual entry form for each event in which it is entered.
- No hound may enter more than one stake.
- No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.
- Entries will not be accepted without fees, signatures or the "Agreement" found on the Official ASFA Entry Form
- Muzzles are not required; it is the responsibility of the owners to determine if their hound should be muzzled.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.
- No entry fees will be refunded if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or its members and representatives.
- All first time entered dogs with the exception of NGA Greyhounds must provide a copy of their registration papers which will be kept by the Field Trial Secretary
- Persons exhibiting conduct detrimental to ASFA/AHCoA/any hound(s)/other person(s) will be asked to leave the trial site.
- The owner of the property, the event-hosting club, its agents, members, representatives, volunteers, etc, assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children or spectators.
- All rights to televise, videotape, advertise, photograph, promote or otherwise exploit this event are vested in the club, or in persons to whom assignments of such rights have been made in writing by the club. All persons and animals attending these shows grant the club the right to use their likeness and voice in any matter without further consent.
