Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds and Whippets may be entered in the regular stakes.

Provisional breeds may be entered in the Provisional Stake or the Singles Stake. Provisional breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid,

Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. That has obtained an ASFA certification, AKC QC, or other qualifying waivers prior to the closing date. A copy of the certificate MUST be submitted with the entry forms. Points go toward V-FCh or V-LCM titles.

PROVISIONAL STAKE: Any eligible sighthound of a provisional breed that has met certification requirements. Not eligible to compete for Best of Breed, Best in Field, or Best in Event. Points and placements are awarded, but not title certificates are issued until the breed is fully recognized by ASFA. **SINGLES STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

LURE COURSING INSTICT (LCI STAKE): Open to <u>non-sighthounds and sighthound mixes.</u> All entries shall be individual registered with the AKC (including ILP, CP, and PAL) or the UKC. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registry fee at time of entry.

CONDITIONS OF ENTRY

- All entries must be one year or older on the day of the trial
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more



ADDITIONAL INFORMATION

- There will be a \$5.00 fine assessed for any loose hound not participating in the course.
- Any person may, upon reasonable complaint, be asked to leave the grounds by the Field Trial Committee.
- Any first time entry which is entered in a trial must have a copy of the hound's registration papers to send in with the entry.
- Dakota County Fairgrounds are not securely fenced; it is strongly recommended that prior to running your hound, you have good control over your dog, as the dogs will run off leash.
- Handlers should wear comfortable, sturdy shoes and be able to hold, catch, and release their dogs.
- Coursing is a physically demanding sport and can tax a hound's physical strength. Hounds that are old, have physical ailments, or are out of condition may be at greater risk for injury. Consult your veterinarian if you have any concerns.
- Muzzles are not required but are permitted at the handler's discretion.
- Please do not bring bitches known to be in season to the field.
- Each entry will be inspected for breed disqualifications, lameness, fitness to compete, and females in season. Any entry found to be unfit to safely compete shall not be allowed to enter and entry fees shall be refunded. Hounds with breed disqualifications will be excused and entry fees will not be refunded.
- The club will have coursing slip leads and blankets available to those who need them. Please return these when you are finished with them.
- MCA issues entry fee refunds for dogs that are in season or lame. You must inform the FTS before roll call to request a refund if your dog will not be attending the trial for these reasons.
- Certifications and practices will be offered on Saturday upon completion of the trial if weather, equipment, and judges time permits. Cost is \$5/hound for MCA members and \$10/hound for non-members.

FOOD

MCA will host a potluck lunch during this trial. Please join us by bringing a dish to share or a \$5 donation. If you prefer, there are additional food options near the field.

HOW TO ENTER

- Pre-entry: mail completed entry form and payment to the FTS. Do not send entries without a signature.
- Day of trial entry: provided an entry limit has not been reach (if applicable), bring entry form and payment to the event before close of entries.
- Checks should be made payable to Minnesota Coursing Association.
- Separate entry forms and entry fees are required for each dog.
- A fee of \$40.00 will be assessed for any returned checks.

- Incomplete, unsigned, conditional, or unpaid entries will not be accepted.
- The club and/or the Field Trial Secretary assume no responsibility for wrong or incomplete information given on the entry form.

Lure Chase Instinct (LCI) Program

All non-sighthounds, sighthound-mixes, and mixed-breeds entered must have a registration number with one of the accepted registries or obtain a unique entry number from ASFA (see below). A photocopy of the acceptable registry must be submitted with each dog's first ASFA field trial entry. Acceptable registries:

- American Kennel Club (AKC):
 - Registration as a recognized breed
 - Purebred Alternative Listing (PAL) program, which is for purebred dogs that cannot be fully registered with the AKC to participate in AKC events.
 - Canine Partners (CP), which is for mixed-breed dogs and dogs ineligible for other types of AKC registration.
 - Foundation Stock Service (FSS), which is for recorded breeds on the road to full AKC recognition.
- United Kennel Club (UKC) registration:
 - Registration as a recognized breed
 - A Performance Listing (PL) number

If the dog does not have one of the above registrations, ASFA will provide a unique entry number for a one-time \$10 charge.

- 1. The owner has to complete an ASFA request for a unique entry number.
- 2. The Trial Secretary will submit a copy of the form with the records.
- 3. The owner will retain a copy as proof of request and payment until a permanent number is provided.

Small Open: for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

Small Senior: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

Small Veteran: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

Large Open: for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.

Large Senior: is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC. **Large Veteran**: for dogs over 17-1/2 inches at the withers who are over the age of 7 years. **Sighthound Mix Open**: for dogs with a sighthound breed in its background who have not

achieved the title of LCC.

Sighthound Mix Senior: for dogs with sighthound breed in its background who have achieved the title of LCC.

Sighthound Mix Veteran: for dogs with sighthound breed in its background over the age of 7 years.

When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.
