


## Map of area



## Events will be held at Haggard's Farm

**Directions to the Haggard's farm in Celina, TX:** 7655 Rawhide Rd, Celina, TX 75009 GPS does work. From Dallas: Take the Dallas North Tollway NORTH until it officially ends at US Hwy 380 at the north end of Frisco. When the official Tollway ends, CONTINUE STRAIGHT across US 380 on the Tollway Extension (2 lane road.) When the Tollway Extension dead ends at FM 428 in Celina, TURN RIGHT (East) on FM 428. Follow 428 around the curves until it dead ends into FM455. TURN LEFT (west) on FM 455 and continue around the curve about 1 mile and turn LEFT on County RD 9. Go approximately 1/2 mile on RD 9 and turn LEFT onto Rawhide Rd. (Look for the Lure Coursing signs.) Go to the top of the second hill on the right hand side and 7655 on the mailbox. Brick house, red barns, white fence. You're there!

Any hound that is ASFA pointed or is pointed in its country of residence or is AKC pointed, is eligible to enter a Regional Invitational in an appropriate stake, including Single Stake. Proof of non-ASFA points for hounds should be in the form of a photocopy of the certificate, or a page of formal printing, included with the entry. For a Limited breed to be eligible, the entry must have one first placement, or two second placements, with competition in the Limited Stake. All points or placements must be earned by the closing date of the event. Hounds entered in the Single Stake are not eligible to be entered in Breeder, Kennel, or Bench stakes.

### ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, and Whippets.

**Provisional breeds** may be entered in the Provisional Stake or the Singles Stake. Provisional breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NG

## REGULAR STAKES OFFERED

**OPEN STAKE:** Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

**FIELD CHAMPION STAKE:** Any ASFA Field Champion

**VETERAN STAKE:** Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

**PROVISIONAL STAKE:** Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

**SINGLE STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPS titles from the Singles stake. Provisional breeds are not eligible for these titles

## NON-REGULAR STAKES OFFERED FOR REGIONAL ON SATURDAY ONLY

**BENCH STAKE:** For any eligible sighthound with proof on file with the ASFA of Conformation champion title from the AKC, CKC or both, or a conformation grand champion title from the UKC. Please submit a copy of non-ASFA title certificates with the entry

## LURE COURSING INSTINCT (LCI) STAKE:

Open to NON sighthounds and sighthound mixes. All entries shall be individually registered with the AKC (including ILP & PAL,) the UKC, the FCI, an ASFA recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry.

**Small Open:** for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

**Small Senior:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

**Small Veteran:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

**Large Open:** for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.

**Large Senior:** is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC.

**Large Veteran:** for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

**Sighthound Mix Open:** for dogs with a sighthound breed in its background who have not achieved the title of LCC.

**Sighthound Mix Senior:** for dogs with sighthound breed in its background who have achieved the title of LCC. **Sighthound Mix Veteran:** for dogs with sighthound breed in its background over the age of 7 years.

When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length

**Conditions of Entry:** All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

**Equipment:** Type of lure machine: battery-powered continuous-loop system. • Type of lures: highly-visible white plastic strips • Back-up equipment will be available.


## Friday 700 yds

## COVID19 Lure Coursing Procedures

We will follow State and local guidelines.

1. All Field Committee and Lure Operators are encouraged to wear facial coverings when closer than 6 feet to another person.
2. All participants are encouraged to wear facial coverings when closer than 6 feet to another person.
3. No food will be served, bring your own breakfast and lunches. Sorry!!! Please bring your own food, water and shade for yourself and your dogs. None will be available at this time.
4. We ask that you park at a safe distance away from each other.
5. The roll call committee are encouraged to wear facial coverings. We will ask the owners of females to wipe their dogs and show the inspection committee the tissue.
6. Wickets will be wiped down after each dog.
7. We will have hand washing stations or instant hand sanitizer and wet wipes.
8. We will prop open the portapots when not in use for more air flow to cut down on bacteria.
9. Huntmasters will stand 6 feet from the dogs after inspecting blankets and slip leads.
10. At the starting line, all dogs will stand 6 feet apart.

12. Please be aware of the running order will be posted as usual.
13. We will also post running order and scores on our **Gazehounds in Texas** Facebook page.
14. No self-serve ribbons anymore due to cross contamination.
