### ELIGIBLE BREEDS & REGISTRY

Only purebred Scottish Deerhounds may be entered in the trial. All entries shall be individually registered with the AKC (ILP/PAL included), the UKC, or an ASFA-recognized foreign or ASFA Board approved registry. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry;

### REGULAR STAKES OFFERED (*this is the running order as well*)

**OPEN STAKE:** Any eligible Scottish deerhound, excluding ASFA Field Champions of record.

**FIELD CHAMPION STAKE:** Any ASFA Field Champion Scottish Deerhound  
**VETERAN STAKE:** Any eligible Scottish deerhound whose age is at least six years. Points go toward V-FCh or V-LCM titles.

**SINGLE STAKE:** Any eligible Scottish deerhound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

### **BOB WILL BE RUN IMMEDIATELY AFTER ALL FLIGHTS ARE COMPLETED**

**Conditions of Entry:** All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

**Equipment:** Type of lure machine: battery-powered continuous-loop system. • Type of lures: highly-visible white plastic strips • Back-up equipment will be available.
