ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Baseniis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds and Whippets may be entered in the regular stakes.

Limited breeds may be entered in the Limited Stake or the Singles Stake. 


