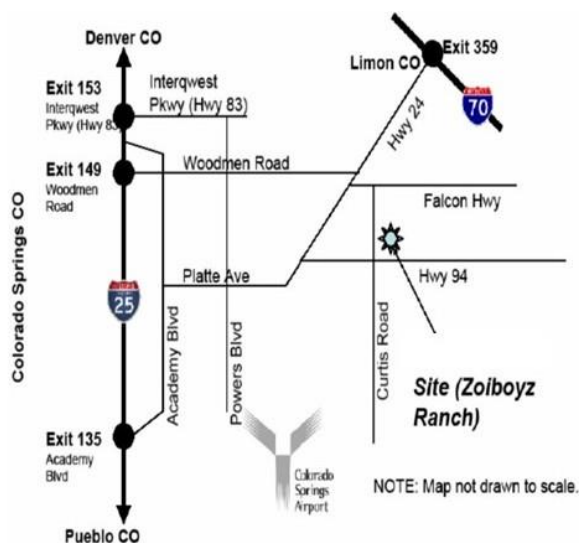

1. From 1-25 South, take exit 153 Interquest Parkway/Hwy 83
2. Go on Hwy 83 to South Powers Blvd
3. Turn right on South Powers Blvd
4. Stay on Powers to Woodmen Road Exit
5. Go left (east) ~12 miles on Woodmen to its end at Hwy 24
6. Go right on Hwy 24 0.5 miles to Meridian
7. Go left on Meridian to STOP sign at Falcon Hwy
8. Turn left onto Falcon Hwy ~3 miles to flashing yellow (Curtis Rd)
9. Turn right (south) onto Curtis Road for 4.4 miles to mailbox 2115.
10. Turn left to Zoiboyz Ranch (NOTE: This will be the 2nd driveway on left after Davis Road. Ignore small house near Curtis Road; go on up the hill to the house surrounded by white fence. You've gone too far down Curtis if you come to Hwy 94 and a traffic signal).

REGISTRY

All dogs entered must have a registration number via one of the following:

- AKC Registration as one of the recognized breeds.
- AKC Canine Partners, which is for mixed-breed dogs and dogs ineligible for AKC registration.
- Purebred Alternative Listing (PAL) program, which is for purebred dogs that cannot be fully registered with the AKC to participate in AKC events.
- Foundation Stock Service® (FSS), which is for recorded breeds on the road to full AKC recognition.
- United Kennel Club (UKC) registration as one of the recognized breeds.
- If the dog has none of the above registrations, ASFA will provide a unique and permanent entry number for a one-time \$10 charge (this is separate from entry fee).
 - The owner has to complete an ASFA Request for unique entry number (last page).
 - The Trial Secretary will submit a copy of the form with the records.
 - The owner will retain a copy as proof of request and payment until ASFA provides a permanent number.
- This is an event for Non-Sighthounds only.

STAKE CLASSES OFFERED

LURE CHASING INSTINCT STAKE CLASSES:

Small Class - under 18" at the withers and all brachycephalic dogs, regardless of height

Large Class - 18" or over at the withers

CONDITIONS OF ENTRY:

- ⇒ All entries must be one year or older on the day of the trial.
- ⇒ Stakes will be split into flights by public random draw if the entry in any stake is 20 or more.
- ⇒ Bitches in season and lame hounds will be excused at roll call. Entry fees will be refunded.
- ⇒ Spayed, neutered, monorchid or cryptorchid hounds may be entered.
- ⇒ Hounds not present at the time of roll call will be scratched. Entry fees will not be refunded.
- ⇒ All hounds will run twice
- ⇒ **\$25 fine for returned checks.**

EQUIPMENT: Type of lure machine: battery-powered continuous-loop system. Continuous loop equipment will be used. Type of lures: lure will consist of highly visible white and/or black plastic. Back-up equipment will be available.

Course plans (reversed for finals) are shown on the following page. LLCC reserves the right to alter the course plans, as required, by weather and/or field conditions on the day of the trial. The elevation is ~ 6,800'. Bring your own food & shade. **NO CAMPFIRES - NO SMOKING OUTSIDE VEHICLE. FIRE DANGER ISHIGH**
