ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawaks, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

PLEASE CLEAN UP AFTER YOUR DOGS AND YOUR PARKING SITES

STAKES OFFERED

OPEN STAKE: Any eligible sighthound that has met hound certification requirements excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE: Any ASFA Field Champion.

VETERAN STAKE: Any eligible sighthound that has met certification requirements and whose age exceeds six years, except Irish Wolfhounds, whose age shall exceed five years, and Afgans, Rhodesian Ridgebacks, Salukis and Whippets, whose age shall exceed seven years. Points go to V-FCh or V-LCM titles

LIMITED STAKE: Any eligible sighthound of a Limited stake breed that has met certification requirements.

SINGLES STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

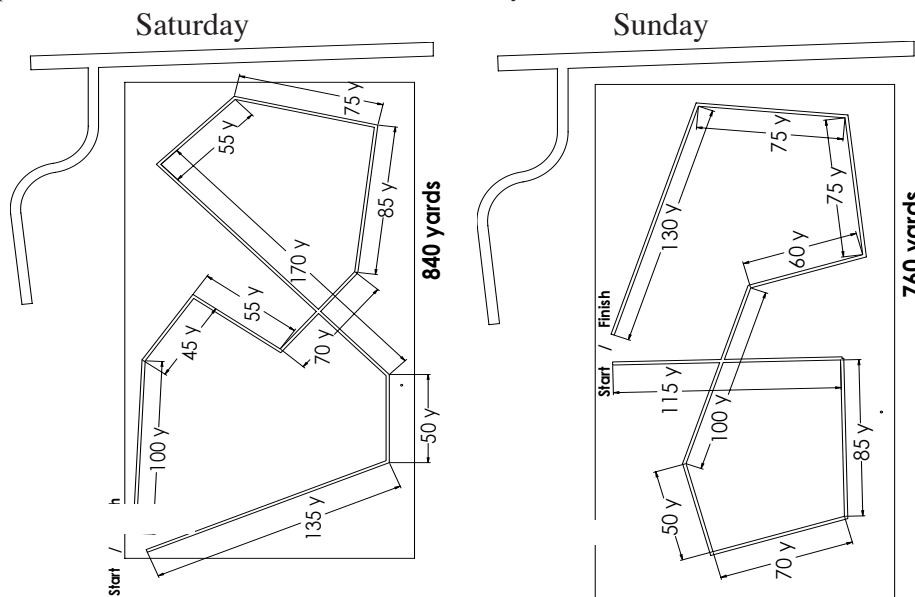

CONDITIONS OF ENTRY

B Hounds must be one year of age on the day of trial and will be examined for breed disqualifications - spayed, neutered, monorchid & cryptorchid hounds may be entered. B Hounds not present at time of roll call will be scratched. B Bitches in season, hounds with breed disqualifications and lame hounds will be excused. B Hounds with breed disqualifications are not eligible to enter except in the Single Stake B Stakes will be split if the entry in any one stake is 20 or more at the time of the draw. B All hounds will run twice, in trios if possible or braces, unless excused, dismissed or disqualified (except in the Single Stake). B Battery powered continuous loop system will be used. B Lure will consist of white plastic strips and/or fur. B Muzzles are not required but are allowed. B A penalty of \$5.00 will be assessed for any loose hound not competing in a course in progress & for any one not cleaning up after their hound. B Any person may, upon reasonable request, be asked to leave the grounds of the field trial by the Field Trial Committee. B Hound Certification and Practice after the trial, time and equipment permitting.

COURSE PLAN

B Course will be reversed for finals, run-offs, and BOB. B JRRWA reserves the right to alter course plans due to weather and/or field conditions on the day of the trial. B The field is not fenced.
