Eligible Breeds and Registries

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, and Whippets, may be entered in the regular stakes. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries in the regular stakes shall be individually registered with AKC (ILP/PAL included), UKC, NGA, FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a Critique Registration Number (CRN) from the SPDBS. Dogs with an indefinite Listing Privilege (LP) or a purebred Alternate Listing (PAL) from the AKC shall be considered registered with that body. Limited and/or Provisional stake entries shall be individually registered with the appropriate registry. A photocopy of acceptable registry must be submitted with a hound's first ASFA field trial entry; this requirement is waived for Greyhounds registered with the NGA registry.

RIBBONS: 1st = Blue, 2nd = Red, 3rd = Yellow, 4th = White, NBQ = Green
 BOB = Purple/Gold, High Scoring Single = Navy/Gold, BIF = Red, White & Blue

All hounds entering Open, Veteran, or Limited stakes for the first time must include a completed certification form or waiver (all breeds) and a copy of the hound's registration certification with their entry (waived for NGA Greyhounds only).

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record that have met the certification requirements.

FIELD CHAMPION STAKE: Any ASFA Field Champion.

VETERAN STAKE: Any eligible hound, that has met the certification requirements, and whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

LIMITED STAKE: Any eligible sighthound of a Limited Stake breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLES STAKE: Any eligible sighthound including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

Best in Field offered on Saturday and Sunday

Conditions of Entry: All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

Brahma II Cup (awarded Saturday)

Eligibility requirements to receive award:

To be eligible to win the Brahma II Cup (or compete in any ASA lure cup run-off), the owner of the qualifying Saluki must be a member in good standing of the ASA before the roll call is called before the draw on the day of the trail. Under no circumstances can a Saluki who is owned by a non-ASA member compete in a cup run-off. Salukis entered in the Singles stake are not eligible, only Salukis entered in the Open, Field Champion, or Veteran stakes qualify to compete for this award.

Run-off Rules:

In the event there is only one stake, the first place Saluki in that stake wins.

If the first place Saluki is owned by a non-ASA member prior to roll call, the award is presented to the highest scoring ASA member owned Saluki.

ASA member owned Salukis tied for first place will compete in a run-off.

No run-off is permitted if the only one Saluki tied for first place is ASA member owned.

If there is no time for a run-off, the award will be shared by the ASA member owned Salukis.

In the event there are two or more stakes – The first place ASA member owned Salukis from each stake will meet for a run-off.

No run-off is permitted if the only one of the first place Salukis from each stake is ASA member owned.

If there are ties for first place in any stakes, all the first place ASA member owned Salukis compete for a run-off.

If there is no time for a run-off, the award will be shared by Salukis who are ASA member owned.

ASA Regional Trophy (awarded Sunday-two day event)

Eligibility requirements to receive award:

To be eligible to win the ASA Regional Lure Coursing trophy (or compete in any ASA lure cup run-off), the owner of the qualifying Saluki must be a member in good standing of the ASA before the roll call is called before the draw on the day of the trail. Under no circumstances can a Saluki who is owned by a non-ASA member compete in a cup run-off. Eligible Salukis must be entered and run two qualifying courses each day of the 2 day trial. Salukis entered in the Singles stake are not eligible, only Salukis entered in the Open, Field Champion, or Veteran stakes qualify to compete for this award.

Run-off Rules:

This Perpetual trophy is awarded to the winner of a special run-off between the BOB Salukis over a two day lure coursing trial.

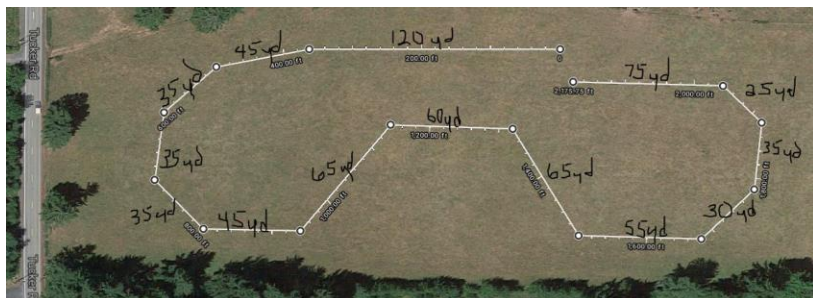
The BOB Saluki on the first day that is registered to at least one ASA member as of roll call on the first day will run off against the BOB Saluki on the second day that is registered to at least one ASA member as of roll call on the FIRST day. If the same Saluki so registered is the BOB Saluki on both days, that Saluki will be declared the winner and no run-off will be necessary.

If the BOB Saluki on one day is not owned by an ASA member but the BOB Saluki on the other day is owned by an ASA member there will be no run-off and the ASA owned Saluki will be declared the winner.

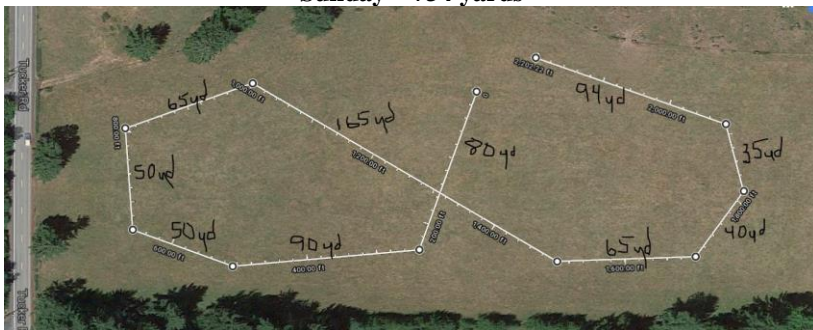
If no BOB winner is owned by an ASA member, the highest placing ASA owned Saluki from each stake (or flight if stakes are divided) each day is eligible to run for the ASA Regional Lure Coursing Trophy.
