### ELIGIBILITY REQUIREMENTS:

Only purebred Silken Windhounds individually registered with the United Kennel Club (UKC) and/or International Silken Windhound Society (ISWS) may be entered.

**Incomplete, unsigned, conditional or unpaid entries will not be accepted.**

Changes of stake and substitutions for lame or in season hounds may be made by notifying the Field Trial Secretary. Substitutions must be made no later than roll call on the day of trial.

Substitutions must be from the same owner & household only.

Entries will **NOT** be acknowledged by mail.

**\*\*Please DO NOT send entries to P.O. Box with 'signature required'.\*\***

### STAKES OFFERED:

**Open Stake:** Any eligible Silken Windhound, excluding ASFA Field Champions of record.

**Field Champion Stake:** Any ASFA Silken Windhound Field Champion of record.

**Veteran Stake:** Any eligible Silken Windhound whose age is at least six years. Points go toward V-FCh or V-LCM titles.

**Singles:** Any eligible Silken Windhound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

**Kennel Stake:** An entry shall consist of two Silken Windhounds, designated at time of entry, in one of the regular stakes being owned and kenneled by the same person.

**ISWS Conformation (Bench) Stake:** An entry shall consist of a single hound, in one of the regular stakes, with proof on file with the ISWS of a conformation championship.

**Best in Field** will not be offered.

### CONDITIONS OF ENTRY:

- All entries must be one year or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Hounds not present at time of roll call will be scratched.
- All hounds will run twice, in trios if possible, or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- There will be certification runs on the day of trial as time permits.
- A \$5.00 penalty will be collected for any loose hound not in competition.
- **Persons exhibiting unsportsmanlike conduct detrimental to ASFA, this club, any hound or person will be asked to leave the trial site.**

### GENERAL INFORMATION:

- Please bring your own food, shade and water.
- A restroom will be available.
- No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Committee.
- Anyone failing to clean up their dog's waste will be excused from the field for the day.
- ISWS assumes no liability for injury to any person or dog before, during or after the Tests and/or Trials.

All first time entries MUST include a copy of the hound's registration certificate. The entry for each hound entering the Limited Stake for the first time MUST include a completed & signed ASFA Certification Form or Waiver Form (with proof of title) and a copy of the hound's registration certificate (ASFA certification waived for Single Stake entries only).

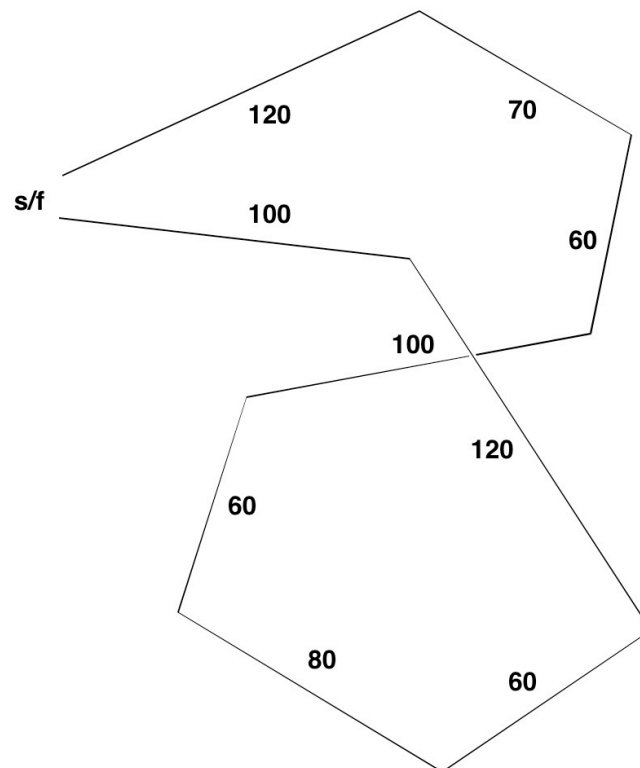
A battery powered, continuous loop system will be used with white or colored plastic streamers and/or fur for the lure. Back-up equipment will be available.

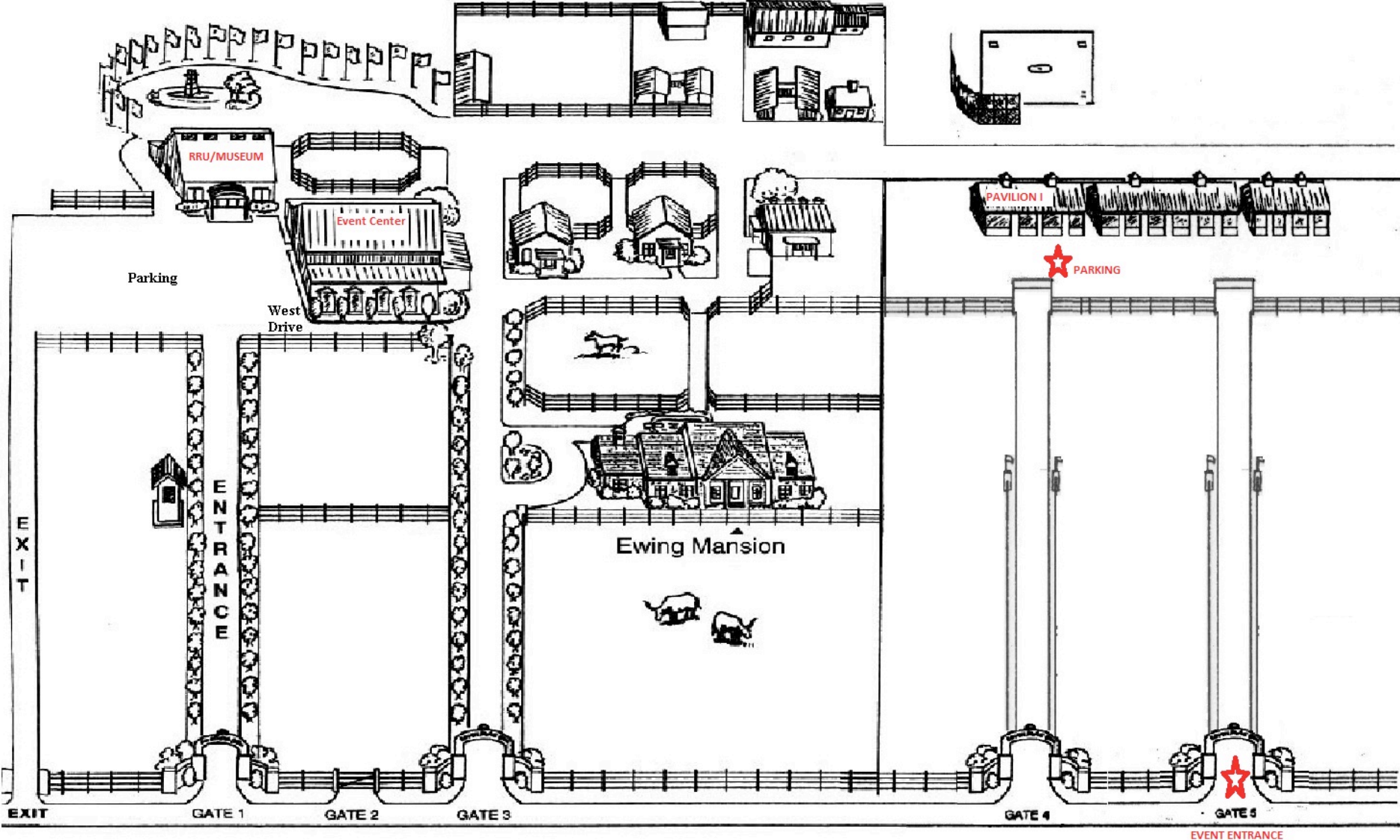
