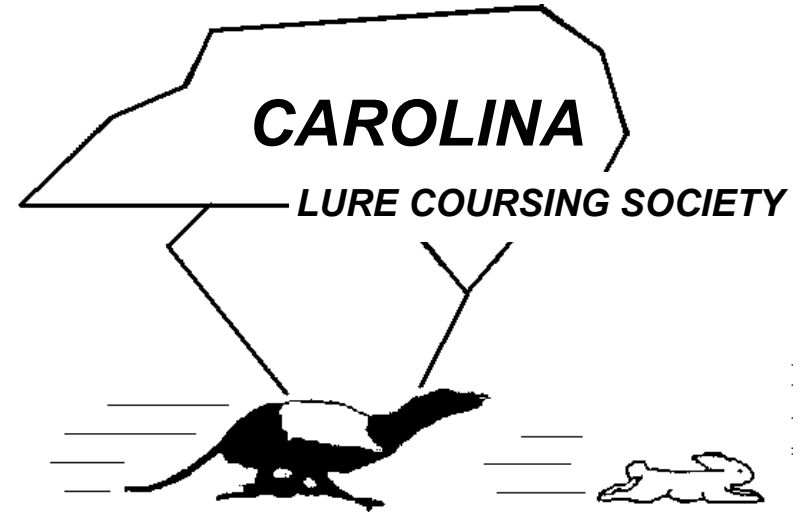
Directions to the Polo Field, Camden SC:

ELIGIBILITY REQUIREMENTS

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzois, Cirneci dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Whippets and Provisional breeds, if any, may be entered in the regular stakes. Limited stake breeds, if any, are entered in the Limited Stake and currently include purebred Chart Polskis, Galgo Espanols, Magyar Agars, Peruvian Inca Orchids, Portuguese Podengos and Silken Windhounds.

All entries in the regular stakes shall be individually registered with the American Kennel Club, the United Kennel Club, the National Greyhound Association, the Federation Cynologique Internationale, an ASFA recognized foreign or ASFA Board approved registry, or possess a Critique Registration Number (CRN) from the Society for the Perpetuation of Desert-Bred Salukis (SPDBS). Dogs with an Indefinite Listing Privilege (ILP) or a Purebred Alternate Listing (PAL) from the AKC shall be considered registered with that body. Limited and/or Provisional stake entries shall be individually registered with the appropriate registry. A photocopy of acceptable registry must be submitted with a hound's first ASFA field trial entry; this requirement is waived for Greyhounds registered with the National Greyhound Association registry.

Entries will not be acknowledged by mail.

STAKES OFFERED

Open Stake: Any eligible sighthound, excluding ASFA Field Champions of record.

Field Champion Stake: Any ASFA Field Champion.

Veteran Stake: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks and Whippets, whose age shall be at least seven years. Points and placements go toward V-FCH and V-LCM titles.

Limited Stake: Any eligible sighthound of a Limited or Provisional stake breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

Single Stake: Any eligible sighthound including those disqualified to run in other stakes. Not eligible to compete in Best of Breed or Best in Field.

CONDITIONS OF ENTRY

*All entries must be one year of age or older on the day of the trial.

*Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.

*Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.

*Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.

*Hounds with breed disqualifications are not eligible to enter except in the Single Stake.

*Hounds not present at the time of roll call will be scratched.

*All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

*Hound certification runs will be offered on Saturday only, following the trial, before practice weather and equipment permitting.

*There will be a five dollar (\$5.00) fine assessed for any loose hound on the field not taking part in the course in progress.

*There will be a \$25.00 charge added for any returned checks.

***Owners must keep their hounds under control and clean up after them.**

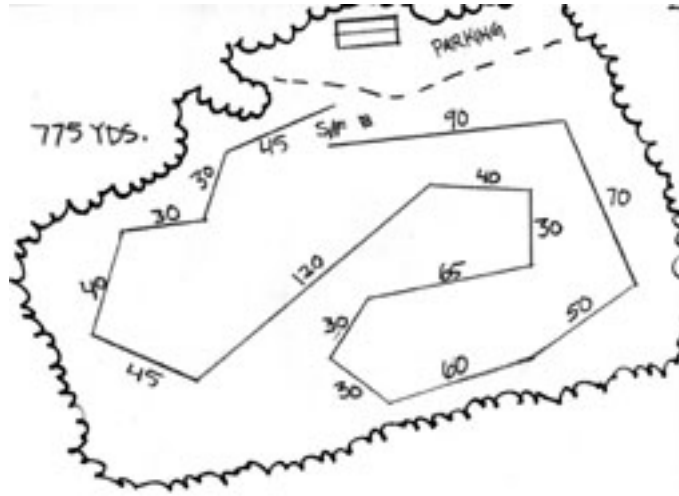
*Back up equipment will be available.

*Lure consists of highly visible plastic strips of white, black, or both depending on weather conditions.

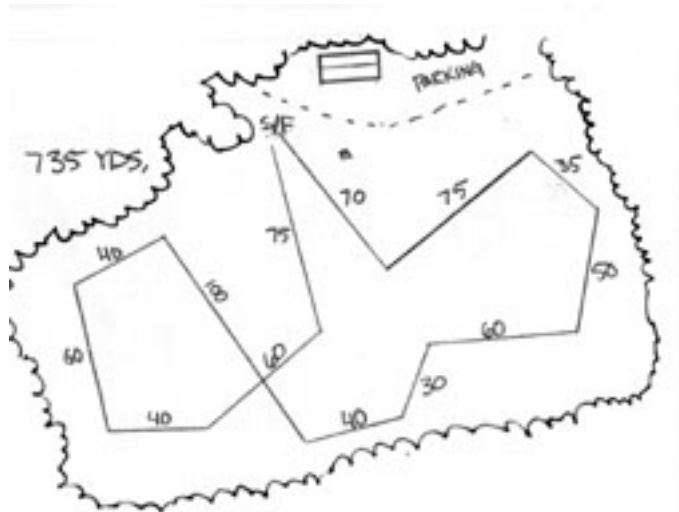
*The club reserves the right to alter the course as required by weather and/or field conditions on the day of the trial.
