


All Hounds entering Open, Veteran or Limited Stakes for the first time MUST include a completed ASFA Certification Form or Waiver Form (with proof of title) and a copy of the hound's registration certificate (registration requirement waived for NGA Greyhounds only; certification waived for Single Stake entries only).

------DIRECTIONS -----

From I-65, exit at Crown Point route 231, & go east on route 231 (away from Crown Point) about 3 miles. Just past the small town of Leroy, turn left (north) on 145th Ave. There is a Stoney Run Park sign at this intersection. Follow 145th Ave about 2 miles to park (on left). There may be a charge per vehicle, charged by the park. Gate may be locked at night. The park gate will be unlocked at 8 am.

If coming from the east, take Route 2 from Valparaiso south to Hebron. In Hebron, turn right (west) on route 231. Go about 4 miles to Stoney Run park sign & turn right (north) onto Montgomery Road. When Montgomery road makes a "T", go right again (145th avenue) and follow to the park.

No entries accepted by email or fax per ASFA rules. Make check payable to "WCLCC". Late, incomplete, conditional, unsigned, unpaid entries and entries without a registration number, will NOT be accepted. Entries will NOT be acknowledged by mail. Substitutes for lame or in-season hounds will be allowed if substitute has the same owner and the trial secretary is notified before the close of day-of-trial entries. Please do not bring bitches in-season to these trials; just report the bitch in-season to the trial secretary. Day-of-Trial entries closes 7:30 am day of trial.

SEPARATE, DATED ENTRY FORMS ARE REQUIRED FOR EACH DAY.

Trial Hours: 7:00 am until completion. All Times are Central Daylight Savings Time

Roll Call & Inspection for all breeds: 8 AM Central Daylight Savings

Awards: Ribbons-1st blue; 2nd-red; 3rd-yellow; 4th-white; NBQ - Green, Singles Winner-Blue/Gold, Best of Breed - purple & gold rosette. BIF – Red, White & Blue Rosette

Best In Field will be offered both days.

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Whippets and Provisional breeds may be entered in the regular stakes. Current provisional breed: Silken Windhound. Limited stake breeds may be entered in the Limited Stake or the Singles stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo Pequeno, Portuguese Podengo Medio & Grande, and must be individually registered with the appropriate registry. All entries shall be individually registered with the American Kennel Club, the National Greyhound Association, the United Kennel Club, the Federation Cynologique Internationale, an ASFA approved registry, or possess a Critique Registration Number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). Dogs with an Indefinite Listing Privilege (ILP) or a Purebred Alternate Listing (PAL) from the American Kennel Club are eliigible. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the National Greyhound Registry.

Regular Stakes:

OPEN STAKE: Any eligible sighthound who has met certification requirements, excluding ASFA Field Champions of record. A photocopy of the hound's registration must be submitted at the hound's first trial. This is waived for NGA greyhounds

FIELD CHAMPION STAKE: Any ASFA Field Champion.

VETERAN STAKE: Any eligible hound whose age exceeds 6 years, except Irish Wolfhounds whose age shall exceed 5 years, and Afghans, Rhodesian Ridgebacks & Whippets whose age shall exceed 7 years, who has met certification requirements. Points earned in this stake are towards the V-FCH & V-LCM.

LIMITED STAKE for Chart Polskis, Galgo Espanols, Magyar Agars, Peruvian Inca Orchids, Portuguese Podengo who have met certification requirements.

Single Stake: Any eligible sighthound including those disqualified to run in other stakes. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

Conditions of Entry: All entries must be one year or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified. Hound certification runs will not be offered this weekend.
