Check-in for dogs belonging to the field committee will begin 30 minutes before published trial hours.

Saturday, September 3rd – “Day of” entries close at 8am.

Roll Call at 9am – Draw at 9:15 am with trial to start immediately after the draw.

Certification runs will be offered before the trial for dogs planning to enter this trial. Dogs not entering this trial may certify after the trial completes.

The handler presenting the certifying hound shall be responsible for providing the Testing Hound for the qualifying course.

Eligible Breeds:

This is a Greyhound specialty trial.

General Information:

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

Stakes Offered:

OPEN STAKE – Open to Greyhounds excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE – Any Greyhound ASFA Field Champion of record.

VETERAN STAKE – Any Greyhound whose age is at least six years.. Points go toward V-FCh or V-LCM titles.

SINGLE STAKE – Any Greyhound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

KENNEL STAKE – Highest combined score for two Greyhounds with at least one common owner. Please complete attached entry form.

BREEDER STAKE – Highest combined score for two Greyhounds with at least one common breeder. Please complete attached entry form.

Conditions of Entry:

Hounds must be one year or older on the day of the trial. All hounds will run twice, in trios if possible or braces unless excused, dismissed or disqualified. Bitches in season and lame hounds will be excused. Hounds not present at the time of roll call will be scratched after a five-minute grace period. Each entry will be examined at inspection for breed disqualifications. Hounds determined to have a breed disqualification at the time of roll call shall be barred from competition and their entry fees shall be refunded. Spayed, monorchid, cryptorchid, and neutered hounds without breed disqualifications may be entered. Regular stakes will be split if 20 or more entries are present in any one stake at the time of the draw. Any hound that displays aggressive behavior during trial hours will be excused for the day. A penalty of \$5 will be assessed for any loose hound not competing in the course in progress.

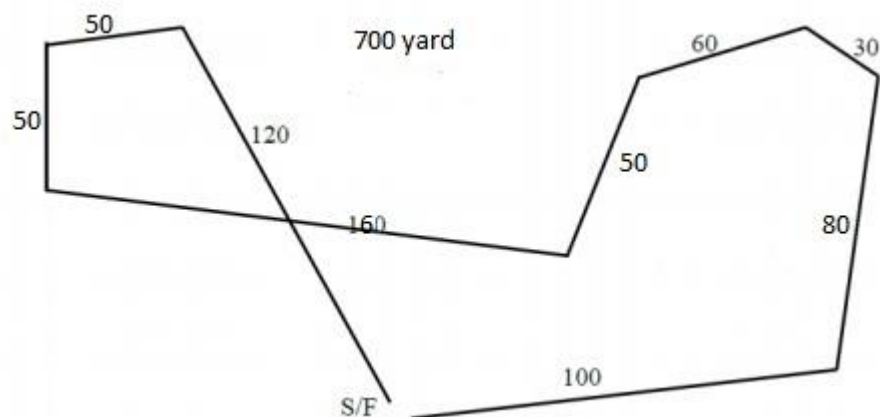

Equipment & Field Information:

Terrain is natural field with uneven ground. Hounds need to be in top physical condition due to the high elevation. Battery powered continuous loop machine will be used. Backup equipment will be available. Lure will consist of white plastic strips. USRCC reserves the right to alter the course diagram as required by weather and/or field conditions on the day of the trial.

Course Plan:

The course is 700 yards, reversed for finals, BOB direction at the discretion of the judges.



Trial Information:

The inaugural running of the Jackalope Challenge ASFA Greyhound Specialty was envisioned by local Greyhound enthusiasts Faith Burnham and Kimberly Fritzler, and made possible through the support of USRCC and its members. We are thrilled to be hosting the second running of the Jackalope Challenge this year, and we hope you will enjoy your stay in picturesque northern Utah. May your hounds run fast and safe!!

There will be a Port-a-John on site. Bring your own food, water and shade. No littering. Pick up after your dogs, and haul out your own garbage. There will be a fine for NOT cleaning up after your hounds. Camping is available for *self-contained* motorhomes with NO HOOKUPS and NO DUMPING. Due to the proximity of crops to the RV parking area, dogs may not be off leash except when competing.

USRCC relies on the generosity of all club members and visiting exhibitors to fund future trials. Please join us for a home-cooked fundraiser lunch on the field and a raffle after the trial to help support our club. We will also have a photographer available to catch shots of your hounds in action, as well as commemorate their wins with our Jackalope mascot!

USRCC welcomes spectators, but asks that all spectators and exhibitors adhere to ASFA and USRCC standards of conduct. Any spectator or exhibitor that behaves in an inappropriate manner will be asked to leave the trial site.

Directions to 14400 N 10800 W, Bothwell, UT :

From I-84 northbound, take Exit 39 for Garland/Bothwell. Turn left off the exit on to Rocky Point Rd, then right on the Frontage Road. Follow the frontage road for 3.7 miles until it bears left and becomes 13600 North, then turn right on to 10800 West. The field will be approximately one mile in on 10800 West. Club representatives will be available starting Friday afternoon to help guide RVs and Trailers.
