

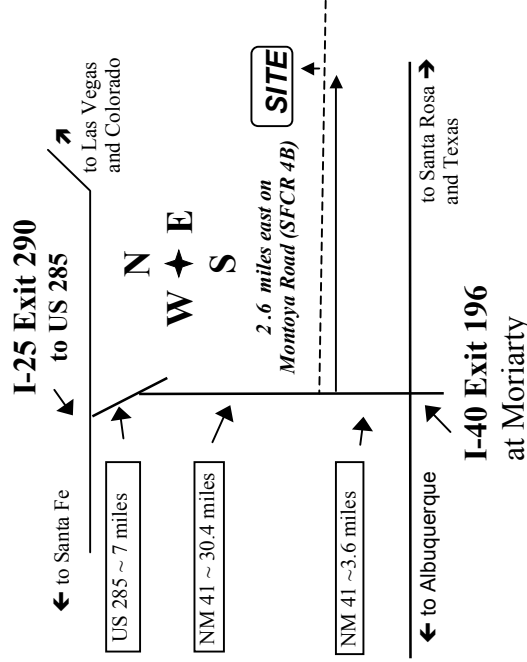

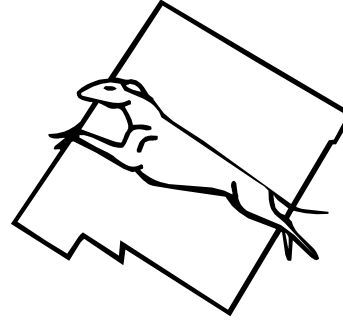


The coursing field is located *North and East of Moriarty, New Mexico*

STAKES OFFERED:

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record. Hounds are eligible to earn FCh title.

FIELD CHAMPION STAKE: Any ASFA Field Champion. Hounds are eligible to earn LCM titles.

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Ridgebacks and Whippets whose age shall be at least seven years. Points & placements go toward V-FCh & V-LCM titles.

LIMITED STAKE: Any eligible sighthound of a Limited or Provisional stake breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

CONDITIONS OF ENTRY:

- ⇒ All entries must be one year or older on the day of the trial.
- ⇒ Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- ⇒ Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- ⇒ Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- ⇒ Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- ⇒ Hounds not present at the time of roll call will be scratched.
- ⇒ All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

OTHER:

- ⇒ There will be a \$5 fine assessed for any hound loose on the field, other than those running the course in progress. \$5 fine for delay of trial at judge's discretion.
- ⇒ There will be a \$25 fee for returned checks.
- ⇒ Everyone must clean up after themselves and their dogs.

Continuous loop equipment will be used. Back-up equipment will be available. Lure will consist of highly visible white and/or black plastic strips. Course plans (reversed for finals) are shown below. AWFA reserves the right to alter the course plans, as required, by weather and/or field conditions on the day of the trial. The altitude is 6,350'. Please bring your own food, shade and water. No fires of any kind permitted on the field. Absolutely no smoking anywhere on the trial grounds.

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Whippets, and Provisional breeds may be entered in the regular stakes. Current Provisional breed: Silken Windhound. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

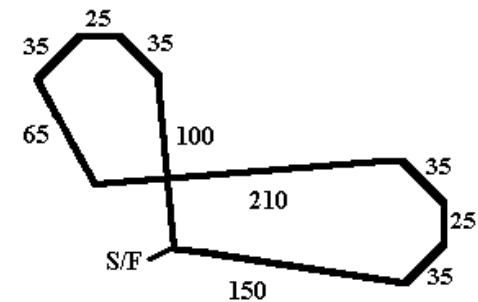
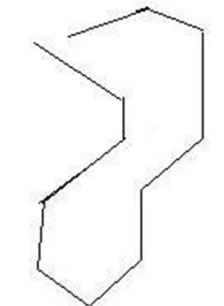
