

# **ELIGIBILITY REQUIREMENTS:**

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis and Whippets may be entered in the regular stakes. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry. All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS.

Incomplete, unsigned, conditional or unpaid entries will not be accepted.

# **STAKES OFFERED:**

**Open Stake:** Any eligible sighthound, excluding ASFA Field Champions of record, that has met the certification requirements.

Field Champion Stake: Any ASFA Field Champion of record.

**Veteran Stake**: Any eligible hound whose age is at least six years that has met the certification requirements, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

**Limited Stake:** Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

**Single Stake:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

Best in Field will not be offered.

# **RIBBONS & ROSETTES:**

Best of Breed: Purple & Gold Rosette, High Scoring Singles: Navy & Gold Rosette, First Place: Blue Ribbon, Second: Red Ribbon, Third: Yellow Ribbon, Fourth: White Ribbon, NBQ: Dark Green Ribbon

#### **EARLY ENTRY FEES AND PAYMENTS:**

- ENTRIES can be sent to the Field Secretary's address above with checks made payable to "CCASH". FAX ENTRIES will not be accepted.
- E-MAIL ENTRIES will be accepted, provided the Field Secretary receives payment before 9:00 pm on Wednesday, July 18<sup>th</sup>, 2018 and the entry form is signed. Unsigned entries will not be accepted.
- If paying by PayPal, send payment to lori@elessarhounds.com and pay for your own PayPal transaction fees. Do not defer the transaction fee to the host club or your entry will be declined.

#### **CONDITIONS OF ENTRY:**

- All entries must be one year or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Hounds not present at time of roll call will be scratched.
- All hounds will run twice, in trios if possible, or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- Hound certification runs will be offered as time permits.
- A \$5.00 penalty will be collected for any loose hound not in competition.
- Persons exhibiting unsportsmanlike conduct detrimental to ASFA, this club, any hound or person will be asked to leave the trial site.

Changes of stake and substitutions for lame or in season hounds may be made by notifying the Field Trial Secretary. Substitutions must be made no later than roll call on the day of trial.

Substitutions must be from the same owner & household only. Entries will **NOT** be acknowledged by mail.

Stay straight to go onto Lopez Drive and proceed 2.7 miles. Turn right to stay on Lopez Drive and proceed 1 mile. Biddle Park is on the right (0.4 miles past Camino Las Ventanas).

#### From South:

Take the CA-227/Grand Avenue exit (Exit 187A) in Arroyo Grande. Turn slight right onto W Branch St./CA-227 and proceed 0.8 miles through downtown Arroyo Grande. Turn right onto Huasna Rd and proceed 1.6 miles. Stay straight to go onto Lopez Drive and proceed 2.7 miles. Turn right to stay on Lopez Drive and proceed 1 mile. Biddle Park is on the right (0.4 miles past Camino Las Ventanas).


