Eligible Breeds and Registry

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirnechi dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis and Whippets may be entered in the regular stakes. Limited stake breeds, if any, are entered in the Limited Stake and currently include purebred Chart Polskis, Galgo Espanols, Magyar Agars, Peruvian Inca Orchids and Portugese Podengos. All entries in the regular stakes shall be individually registered with the AKC, the NGA, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a critique registration number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). Limited and/or Provisional stake entries shall be individually registered with the appropriate registry.

CAMPING

Camping is permitted on the field, but no hookups are available. Bring your own water, shade, power and clean-up materials. Contact Wishing Well Farms (252-442-9474) if you plan to arrive earlier than 1pm on Friday.

Lets all work together to keep the site clean.
Clean up after your dog and take your trash with you please.

PARKING

No parking is allowed on any farm road. Please park in the field in designated areas only. In case of wet conditions, paved parking is available nearby.

FOOD

Beverages and donuts will be offered each morning. On Saturday, there will be a **potluck lunch** on the field. Bring something to pass, and join us! There are also fast food restaurants approximately 10 minutes from the field in Rocky Mount.

DIRECTIONS TO THE TRIAL

From I-95 North or South, take exit 138 onto US 64 East. Continue on US 64 east approximately 7 miles and exit onto Alternate US 64 East toward Tarboro. From US 64A, turn left at first intersection onto Springfield Rd. At first stop sign, turn right onto Leggett Rd. Continue 1 mile on Leggett Rd. Look for signs on right for Wishing Well Farm Kennel. Turn right into driveway. Follow the gravel drive around the field to the parking area.

STAKES OFFERED:

REGULAR STAKES:

OPEN: Any eligible sighthound, excluding ASFA Field Champions of record.

FIELD CHAMPION: Any ASFA Field Champion.

VETERAN: Any eligible hound whose age is at least 6 years (except Irish Wolfhounds, whose age shall be at least 5 years, and Rhodesian Ridgebacks and Whippets, whose age shall be at least 7 years).

LIMITED stake: Any eligible sighthound of a Limited or Provisional stake breed that has met certification requirements.

BEST IN FIELD WILL BE OFFERED BOTH DAYS

CONDITIONS OF ENTRY:

- Hounds must be one year of age or older on the day of the trial
- Stakes will be split into flights by random draw if the entry in any regular stake is 20 or more.
- Bitches in season, hounds with breed disqualifications, and lame hounds will be excused at roll call.
- All hounds will be examined for breed disqualifications spayed, neutered, monorchid and cryptorchid hounds without breed disqualifications may be entered
- Hounds with breed disqualifications are not eligible to enter expect in the Singles Stake (not offered here).
- Hounds not present at the time of roll call will be scratched.
- All hounds will run twice, in trios if possible or braces, unless excused, dismissed or disqualified.
- Substitute entries will be allowed for lame or in-season hounds.
- If hounds owned or co-owned by the the same person are not to run together, the owner must state this on the entry form
- Hound Certification runs will be offered Saturday at the end of the trial, weather/time permitting. No pre-entry is required.

HOUND CERTIFICATION TEST:

All hounds entered for the first time in the open stake, veteran stake, or limited stake, must have included with their entry, a Hound Certification statement signed within the year preceding the closing date for the entry by a licensed judge. If the hound has competed previously in the open stake, veteran stake, or limited stake or holds another ASFA-approved lure coursing or racing title requiring competition, this certification is not required, However, a Waiver of Requirement for these titles must be included with the entry of a hound competing for the first time. CERTIFICATION AND WAIVER forms are available in this premium list and/or from the field trial secretary. To become certified, a hound must complete a lure course of at least 500 yards running with one other hound of the same breed (or of another breed with a similar running style) and show no inclination to interfere with the other hound. If you wish to certify your hound, please arrange for another hound of the same breed or with a similar running style to be present.


EQUIPMENT:
